Introduction

THE world is complex, dynamic, multidimensional; the paper is static, flat. How are we to represent the rich visual world of experience and measurement on mere flatland?

This book celebrates escapes from flatland, rendering several hundred superb displays of complex data. Revealed here are design strategies for enhancing the dimensionality and density of portrayals of information - techniques exemplified in maps, the manuscripts of Galileo, timetables, notation describing dance movements, aerial photographs, the Vietnam Veterans Memorial, electrocardiograms, drawings of Calder and Klee, computer visualizations, and a textbook of Euclid's geometry.

Our investigation yields general principles that have specific visual consequences, governing the design, editing, analysis, and critique of data representations. These principles help to identify and to explain design excellence - why some displays are better than others.

Charts, diagrams, graphs, tables, guides, instructions, directories, and maps comprise an enormous accumulation of material. Once described by Philip Morrison as "cognitive art," it embodies tens of trillions of images created and multiplied the world over every year. Despite the beauty and utility of the best work, design of information has engaged little critical or aesthetic notice: there is no Museum of Cognitive Art. This book could serve as a partial catalog for such a collection. Like my previous study, *The Visual Display of Quantitative Information*, which derives theoretical counsel from the classics of statistical graphics, this book arrays exemplary designs - this time over a broader spectrum, for all types of information.

To envision information - and what bright and splendid visions can result - is to work at the intersection of image, word, number, art. The instruments are those of writing and typography, of managing large data sets and statistical analysis, of line and layout and color. And the standards of quality are those derived from visual principles that tell us how to put the right mark in the right place.

Finally, in reading the words and drawings, note that:

Many of the illustrations have been edited and redrawn (as indicated in the citations) in order to repair battered originals, to make new color separations, and to improve the design. Primary sources - the themes for my variations - are always noted.

The illustrations repay *careful* study. They are treasures, complex and witty, rich with meaning. The text, I do hope, is of similar character, with every word meant to count; all in all, the reader should proceed most slowly through these bountiful and condensed pages.

The principles of information design are universal - like mathematics - and are not tied to unique features of a particular language or culture. Consequently, our examples are widely distributed in space and time: illustrations come from 17 countries and 7 centuries, and, for that matter, 3 planets and 1 star.

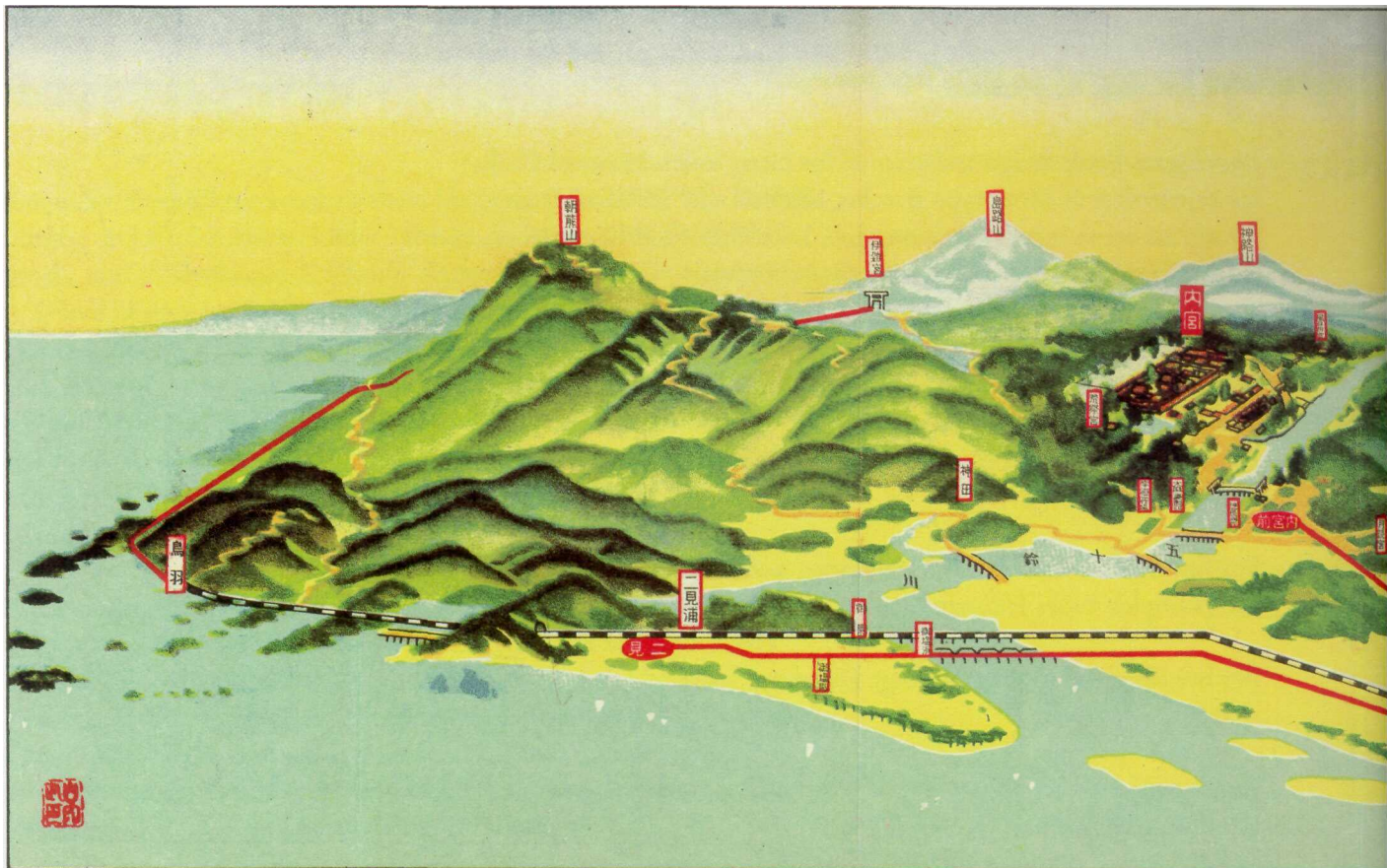

1 Escaping Flatland

EVEN though we navigate daily through a perceptual world of three spatial dimensions and reason occasionally about higher dimensional arenas with mathematical ease, the world portrayed on our information displays is caught up in the two-dimensionality of the endless flatlands of paper and video screen.¹ All communication between the readers of an image and the makers of an image must now take place on a two-dimensional surface. *Escaping this flatland is the essential task of envisioning information—for all the interesting worlds (physical, biological, imaginary, human) that we seek to understand are inevitably and happily multivariate in nature. Not flatlands.*

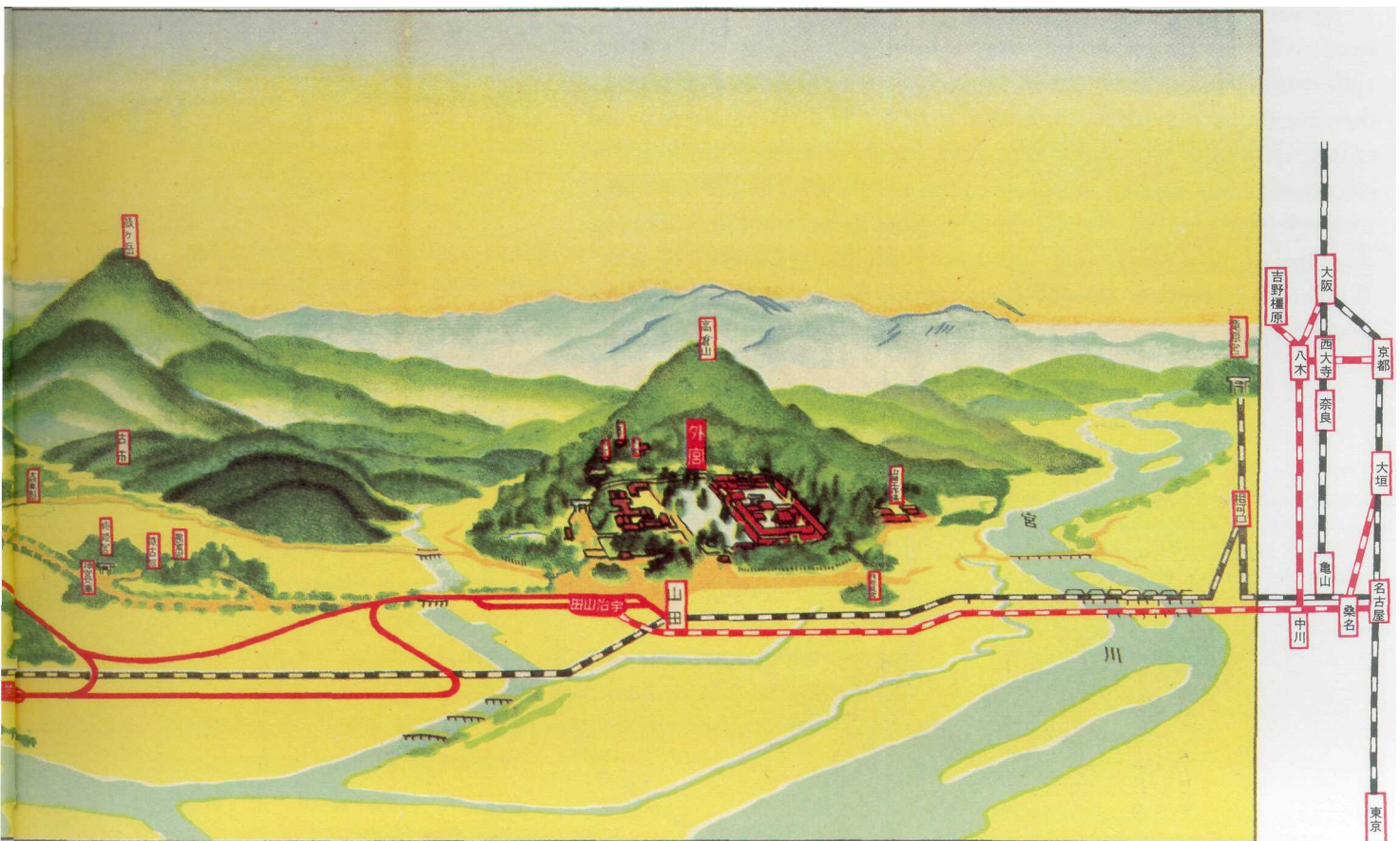

THIS chapter outlines a variety of design strategies that sharpen the information resolution, the resolving power, of paper and video screen. In particular, these methods work to increase (1) the number of dimensions that can be represented on plane surfaces and (2) the data density (amount of information per unit area).

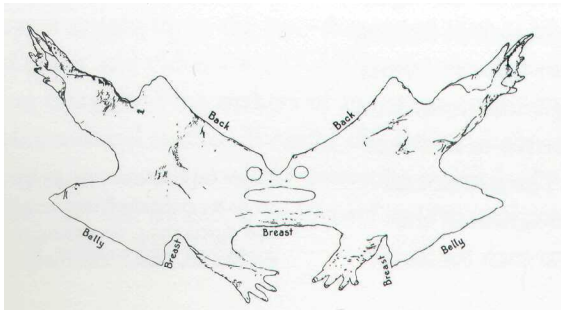
IN this Japanese travel guide, an engaging hybrid of design technique, the abrupt shift from friendly perspective to hard flatland shows the loss suffered by giving in to the arbitrary data-compression of paper surfaces. A bird's-eye view with detailed perspective describes local areas near the architecturally renowned Ise Shrine; then, on the right margin, a very flat map delineates the national railroad system linking the shrine to major cities, somewhat compensating for loss of a visual dimension with a broad overview. A change in design accommodates a change in the scale of the map, and local detail is shown in national context, a mixed landscape of refuge and overview. The horizontal layout combines harmoniously with the vertical orientation of the language, so that the stand-up labels point precisely to each location.

When the toad (*Bufo americanus* Le Conte) sheds its skin upon the occasion of a quarterly moulting, the suit leaves life's spaceland and collapses into flatland, not unlike our information displays.

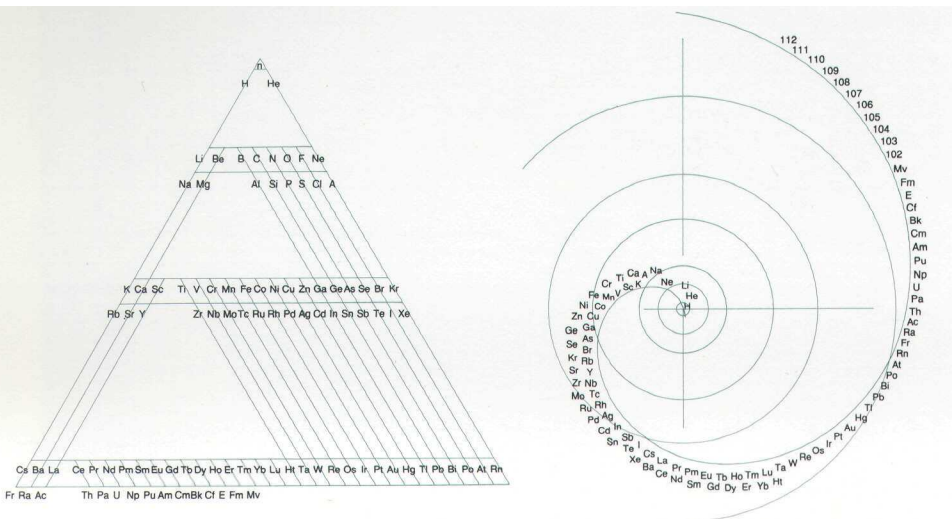
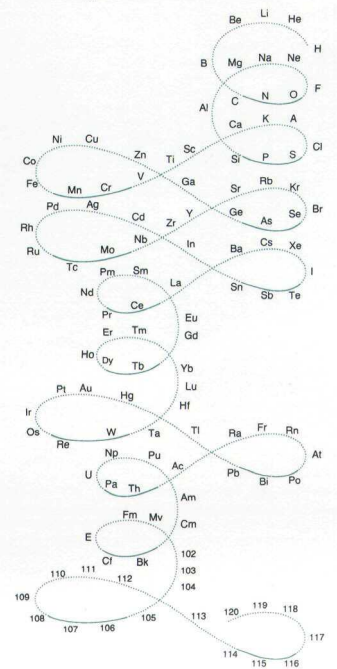
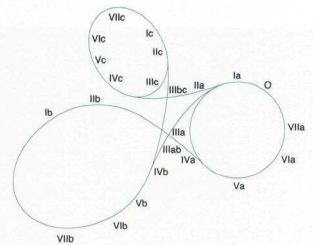


All sorts of techniques for doing better than flattened-out toad suits have evolved during some 500 years of information design.² Since the 15th-century Italian Renaissance, when Florentine architects perfected the necessary geometry, conventional perspective drawing has enriched representations of physical objects. And, for more abstract multivariate information not residing in our three-space reality, several enterprising methods have evolved—nearly silently, often to be found in workaday diagrams of those confronted with an overwhelming quantity of data. A few such techniques are well documented; for example, the elaborate structuring of the periodic table of chemical elements³ (with several

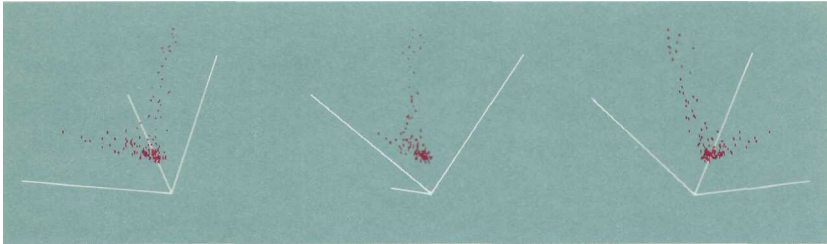

hundred arrangements proposed to capture the assorted complexities). Some recently perfected statistical graphics, self-consciously multivariate, enrich flatland with the dynamics of rotating point clouds on



computer screens — a marvel, although navigation in three-dimensional scatterplots is not a trivial matter.⁴ Another approach, here on the right, slices and projects data from many angles onto six of the twelve surfaces of a pentagonal dodecahedron (only six faces are needed, since opposite parallel faces show identical views).

Nearly every escape from flatland demands extensive compromise, trading off one virtue against another; the literature consists of partial, arbitrary, and particularistic solutions; and neither clever idiosyncratic nor conventionally adopted designs solve the inherent general difficulties of dimensional compression. Even our language, like our paper, often lacks immediate capacity to communicate a sense of dimensional complexity. Paul Klee wrote to this point:

It is not easy to arrive at a conception of a whole which is constructed from parts belonging to different dimensions. And not only nature, but also art, her transformed image, is such a whole.

It is difficult enough, oneself, to survey this whole, whether nature or art, but still more difficult to help another to such a comprehensive view.

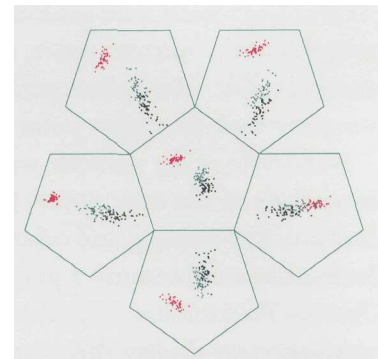
This is due to the consecutive nature of the only methods available to us for conveying a clear three-dimensional concept of an image in space, and results from deficiencies of a temporal nature in the spoken word.

For, with such a medium of expression, we lack the means of discussing in its constituent parts, an image which possesses simultaneously a number of dimensions.⁵

And perspective projection is a simple extension of a two-surface, made unmistakable by everyday experience in three-space itself. Yet much of our data—and nature's pattern—have far greater complexity. What, then, are general strategies for extending the dimensional and informational reach of display flatlands? And what specific techniques effectively document and envision multivariate worlds? Why are some performances better than others?

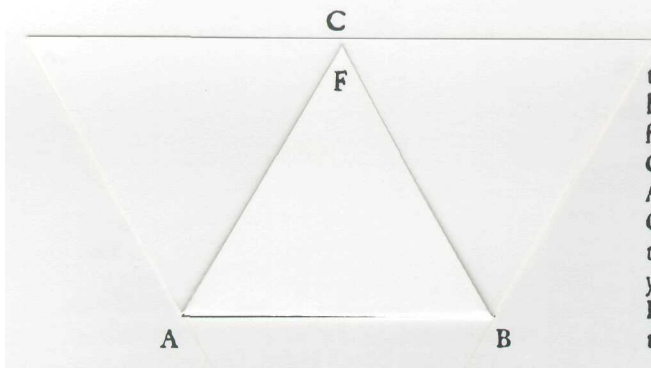
To begin, a series of splendid examples.

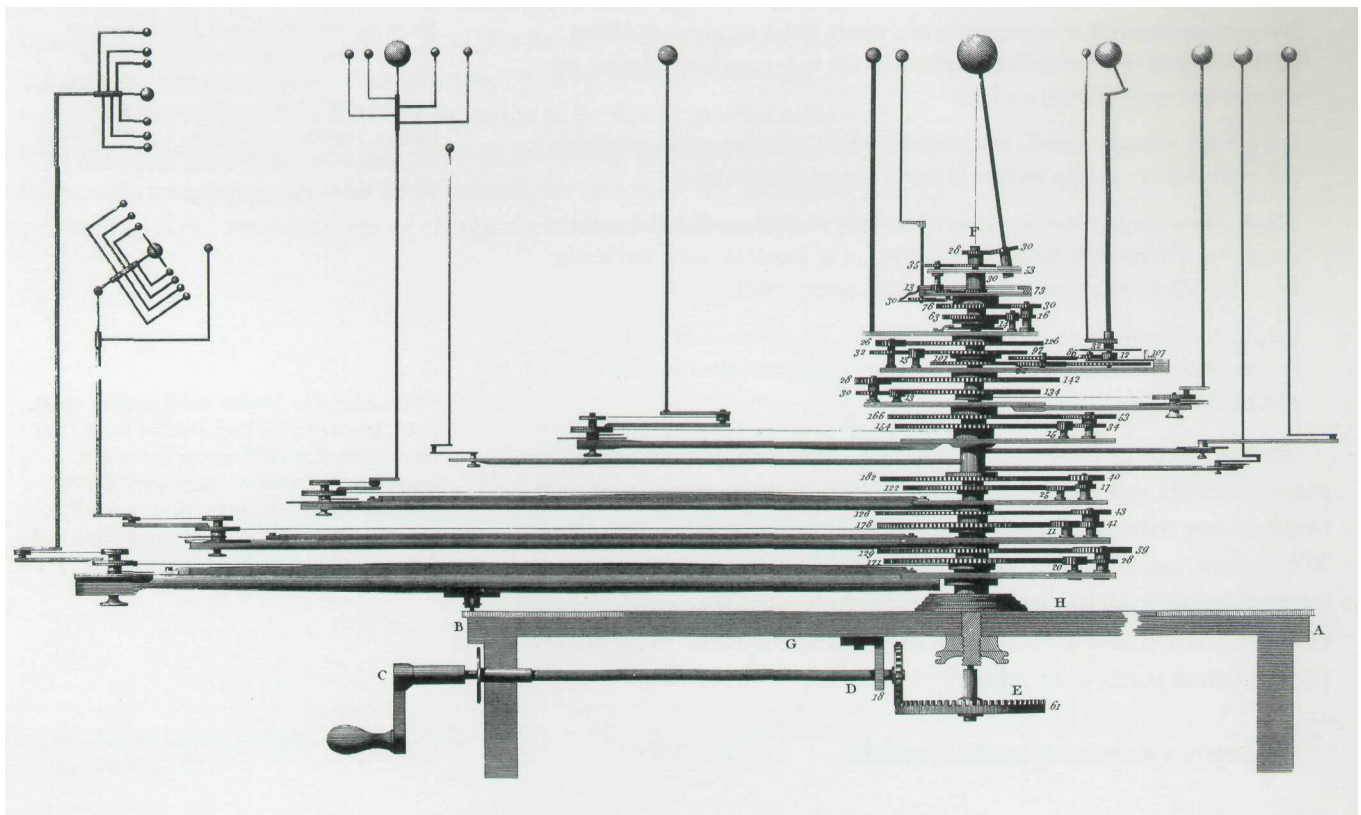
So all their angles there ioyned together, make a solide angle. And for the better fight thereof, I haue fet here a figure wherby ye shall more easly conceiue it, the base of the figure is a triangle, namely, $A B C$, if on every side of the triangle $A B C$, ye raise vp a triangle, as vpon the side $A B$, ye raise vp the triangle $A F B$, and vpon the side $A C$ the triangle $A F C$, and vpon the side $B C$, the triangle $B F C$, and so bowing the triangles raised vp, that their toppes, namely, the pointes F meete and ioyne together in one point, ye shall easly and plainly see how these three superficial angles $A F B$, $B F C$, $C F A$, ioyne and clofe together, touching the one the other in the point F , and so make a solide angle.

DIRECT methods for the display of three dimensions include making models, as in this 1570 edition of Euclid's *Elements*, where little paper constructions teach solid geometry. Models pleasingly represent the smooth surfaces of three-space, as in architectural miniatures and mathematical solids; more obstreperous statistical data however, call for computer analysis of data point clouds.

Narratives of the universe were impressively cranked up in orreries, simulations of our solar system (as known in 1800), with planets and their satellites rotating and orbiting. Although a triumph of gear ratios, the machines did commit a grave sin of information design — Proudly Obvious Presentation — by directing attention more toward miraculous contraptionary display than to planetary motion.

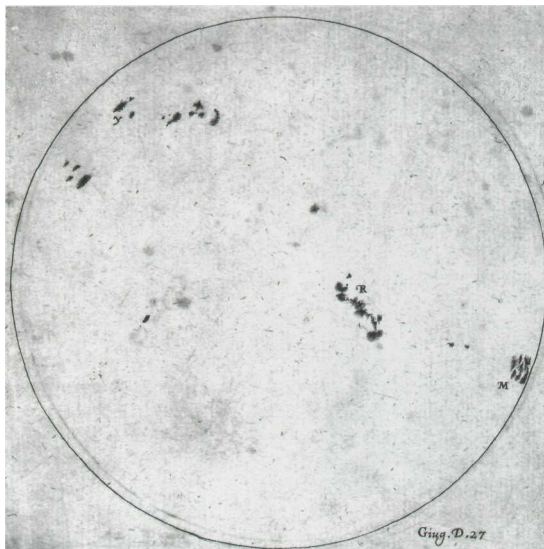
Particularly intriguing are stereo illustrations, which deliver vivid three-dimensional scenes by means of paired images (one for each eye), which are then fused mentally by viewers. Aerial landscapes, molecular structures, and other worldly objects are commonly portrayed; representations of more abstract and ragged quantitative data are rarely seen. Many viewers must struggle (and some fail) to fuse the images; even experienced eyes may require several minutes of vacant staring before obtaining the splendid stereo view.⁶ Recent work on computer visualizations, stereo images, holograms, and so on hint at an increasing depth and pace to analytic displays, perhaps eventually without all the paraphernalia accompanying current methods.⁷

SUNSPOTS were examined in detail by telescope in the early 1600s, after some 200 years of repeated viewing by unaided eyes in Athens, China, Japan, and Russia. It was difficult for Europeans to see sunspots at all because Aristotle had said that celestial bodies were perfect and without blemish, a fancy which became official church doctrine in the middle ages.⁸ Then, in 1610-1612, Galileo and others made detailed telescopic observations of sunspots.

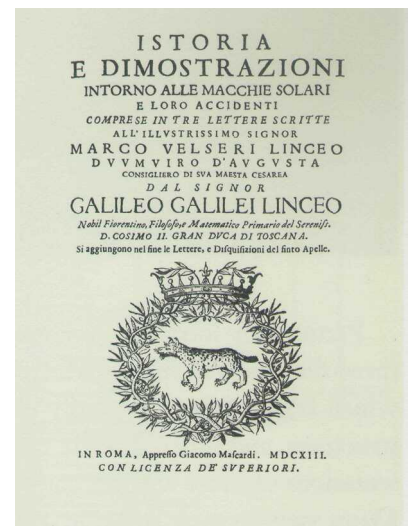
Galileo marked spots directly onto paper flatland, maintaining the proper image plane while drawing a large diagram of a spotted sun:

The method is this: Direct the telescope upon the sun as if you were going to observe that body. Having focused and steadied it, expose a flat white sheet of paper about a foot from the concave lens; upon this will fall a circular image of the sun's disk, with all spots that are on it arranged with exactly the same symmetry as in the sun. The more the paper is moved away from the tube, the larger this image will become, and the better the spots will be depicted. Thus they will all be seen without damage to the eye, even the smallest of them—which, when observed through the telescope, can scarcely be perceived, and only with fatigue and injury to the eyes.

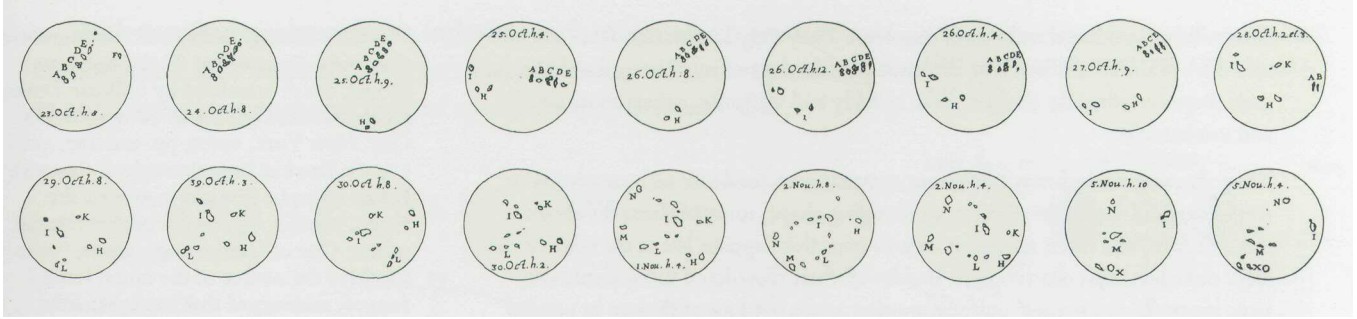


In order to picture them accurately, I first describe on the paper a circle of the size that best suits me, and then by moving the paper towards or away from the tube I find the exact place where the image of the sun is enlarged to the measure of the circle I have drawn. This also serves me as a norm and rule for getting the plane of the paper right, so that it will not be tilted to the luminous cone of sunlight that emerges from the telescope. For if the paper is oblique, the section will be oval and not circular, and therefore will not perfectly fit the circumference drawn on the paper. By tilting the paper the proper position is easily found, and then with a pen one may mark out spots in their right sizes, shapes, and positions. But one must work dextrously, following the movement of the sun and frequently moving the telescope, which must be kept directly on the sun.⁹

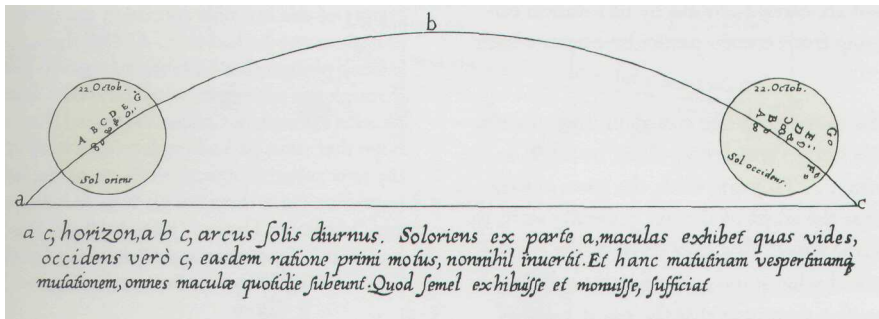

As more observations were collected daily, small multiple diagrams recorded the data indexed on time (a design simultaneously enhancing dimensionality and information density), with the labeled sunspots parading along alphabetically. This profoundly multivariate analysis — showing sunspot location in two-space, time, labels, and shifting relative orientation of the sun in our sky — reflects data complexities that arise because a rotating sun is observed from a rotating and orbiting earth:

For some astronomers, particularly those seeking to reconcile data with doctrine, it was unclear just where sunspots were located. Surely not on the surface of that perfect sphere; perhaps satellites orbited the sun, or even planets were in transit across the sun's face — speculations soon demolished by Galileo. Through an elegant chain of visual reasoning and with characteristic sardonic bluntness, Galileo, writing from Florence in August 1612, converts empirical observation into focused evidence supporting conclusions. His argument unfolds the raw data ("what the eye of the forehead" registers) into a luminous explanation of mechanism ("what the eye of the mind" envisions),¹⁰ a deeply visual logic that produced precise insights far beyond those achieved by others who had also observed sunspots in the early 1600s. Indeed, "it was more than 150 years before any important addition was made"¹¹ to Galileo's results, as reported in 1613:

I therefore repeat and more positively confirm to Your Excellency that the dark spots seen in the solar disk by means of the telescope are not at all distant from its surface, but are either contiguous to it or separated by an interval so small as to be quite imperceptible. Nor are they stars or other permanent bodies, but some are

always being produced and others dissolved. They vary in duration from one or two days to thirty or forty. For the most part they are of most irregular shape, and their shapes continually change, some quickly and violently, others more slowly and moderately.

They also vary in darkness, appearing sometimes to condense and sometimes to spread out and rarefy. In addition to changing shape, some of them divide into three or four, and often several unite into one; this happens less at the edge of the sun's disk than in its central parts. Besides all these disordered movements they have in common a general uniform motion across the face of the sun in parallel lines. From special characteristics of this motion one may learn that the sun is absolutely spherical, that it rotates from west to east around its own center, carries the spots along with it in parallel circles, and completes an entire revolution in about one lunar month. Also worth noting is the fact that the spots always fall in one zone of the solar body, lying between the two circles which bound the declinations of the planets - that is, they fall within 28° or 29° of the sun's equator.

The different densities and degrees of darkness of the spots, their changes of shape, and their collecting and separating are evident directly to our sight, without any need of reasoning, as a glance at the diagrams which I am enclosing will show. But that the spots are contiguous to the sun and are carried around by its rotation can only be deduced and concluded by reasoning from certain particular events which our observations yield.

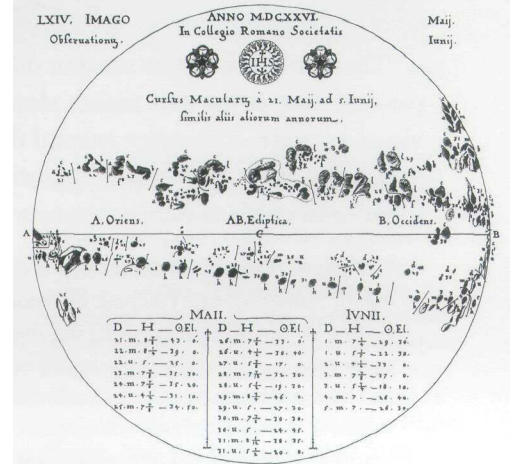
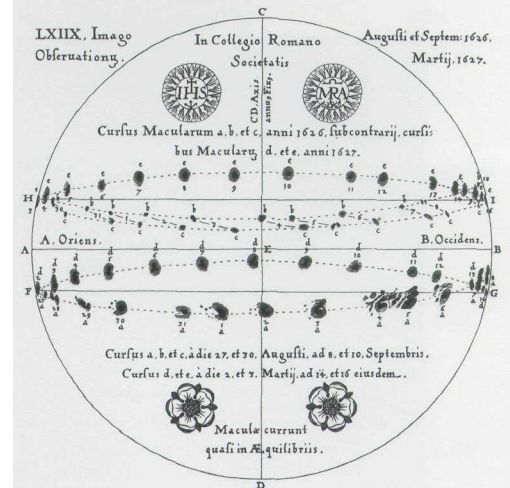
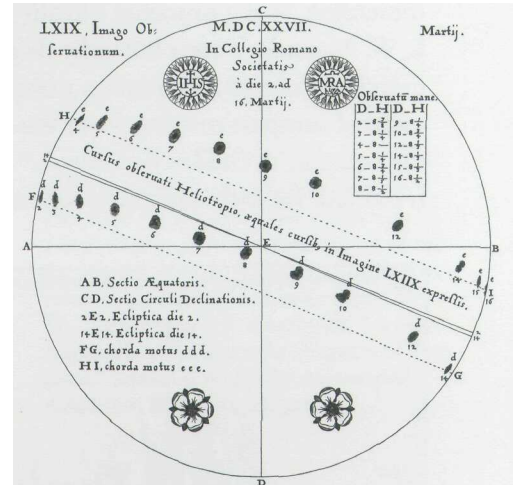
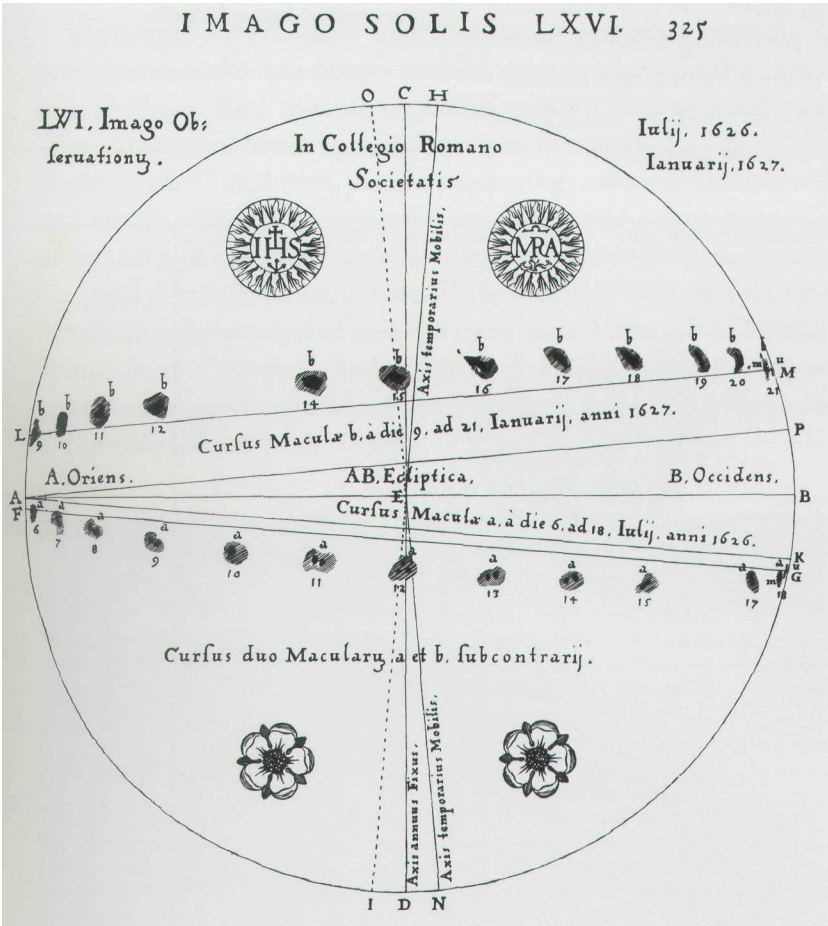
First, to see twenty or thirty spots at a time move with one common movement is a strong reason for believing that each does not go wandering about by itself, in the manner of the planets going around the sun. . . . To begin with, the spots at their first appearance and final disappearance near the edges of the sun generally seem to have very little breadth, but to have the same length that they show in the central parts of the sun's disk. Those who understand what is meant by foreshortening on a spherical surface will see this to be a manifest argument that the sun is a globe, that the spots are close to its surface, and that as they are carried on that surface toward the center they will always grow in breadth while preserving the same length. . . . this maximum thinning, it is clear, takes place at the point of greatest foreshortening....

I have since been much impressed by the courtesy of nature, which thousands of years ago arranged a means by which we might come to notice these spots, and through them to discover things of greater consequence. For without any instruments, from any little hole through which sunlight passes, there emerges an image of the sun with its spots, and at a distance this becomes stamped upon any surface opposite the hole. It is true that these spots are not nearly as sharp as those seen through the telescope, but the majority of them may nevertheless be seen. If in church some day Your Excellency sees the light of the sun falling upon the pavement at a distance from some broken window pane, you may catch this light upon a flat white sheet of paper, and there you will perceive the spots. I might add that nature has been so kind that for our instruction she has sometimes marked the sun with a spot so large and dark as to be seen merely by the naked eye, though the false and inveterate idea that the heavenly bodies are devoid of all mutation or alteration has made people believe that such a spot was the planet Mercury coming between us and the sun, to the disgrace of past astronomers.¹²

With continuing observation, indexing each image afresh grew cumbersome. Christopher Schemer's *Rosa Ursina sive Sol*, completed in 1630, arranges the apparent path of spots across a stationary disk,

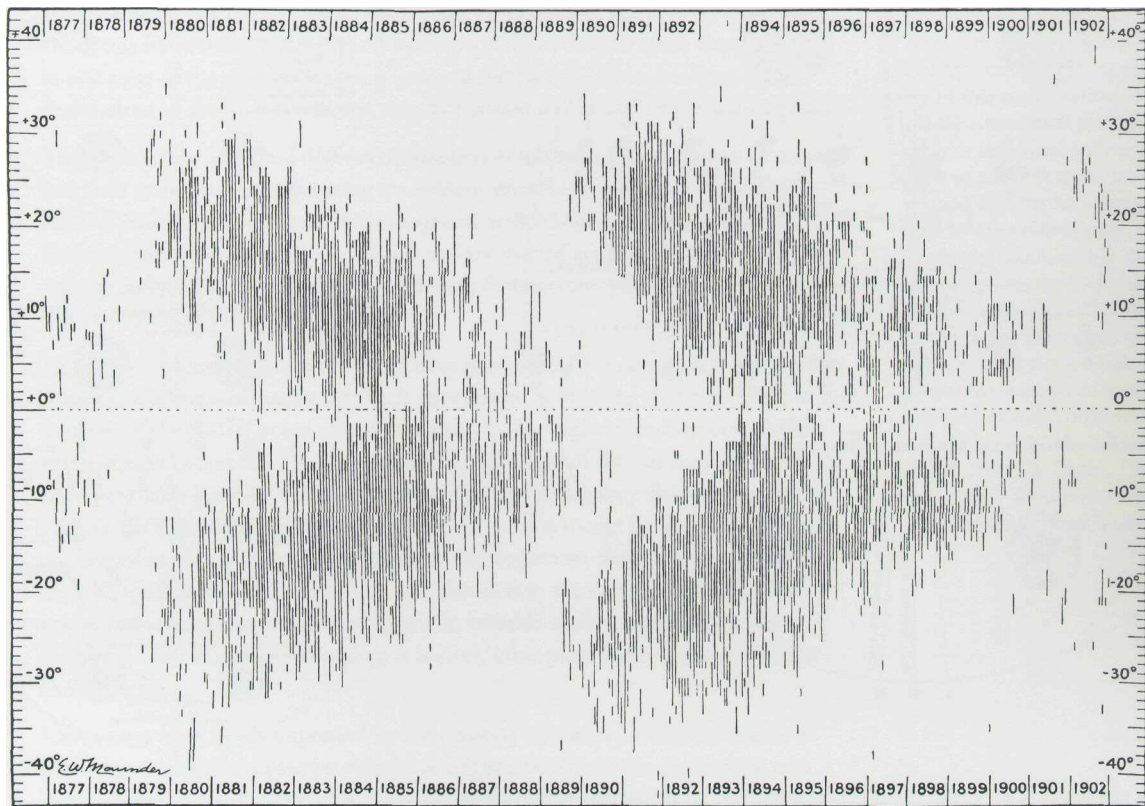
an ingenious method for tracking simple sunspot structures but tending to jumble up complex data. Symbols of Scheiner's patron and religious order decorate those areas without spots in a hundred such diagrams, a reminder of Jonathan Swift's indictment of 17th-century cartographers who substituted embellishment for data:

*With savage pictures fill their gaps,
And o'er unhabitable downs,
Place elephants for want of towns*

These symbols, similar to a modern trademark or logotype, may have served as a seal of validation for the readers of 1630. Today they appear somewhat strident, contradicting nature's rich pattern.

Years and years of daily mapping led to this superb visualization, sunspot distribution in latitude, recorded for long time periods. The sunspot's two areal dimensions are reduced to one content-relevant dimension, as the immense quantity of data provoked design mastery. E.W. Maunder's 1904 butterfly diagram aggregates the micro-detail of individual observations into a macro-view, portraying a *distributional* cycle of sunspots moving from the center of each hemisphere toward the equator, as Galileo had noted.¹³ Only an interval $+40^\circ$ sun latitude is plotted, for little activity is seen in more extreme latitudes:

The fine detail of this sunspot diagram merges into a repeated typical pattern; and, as the data march along over time, the foremost result is a visual measure of *variation* around that average. Measured assessments of variability are at the heart of quantitative reasoning. R. A. Fisher, the founder of modern statistics, wrote in 1925:

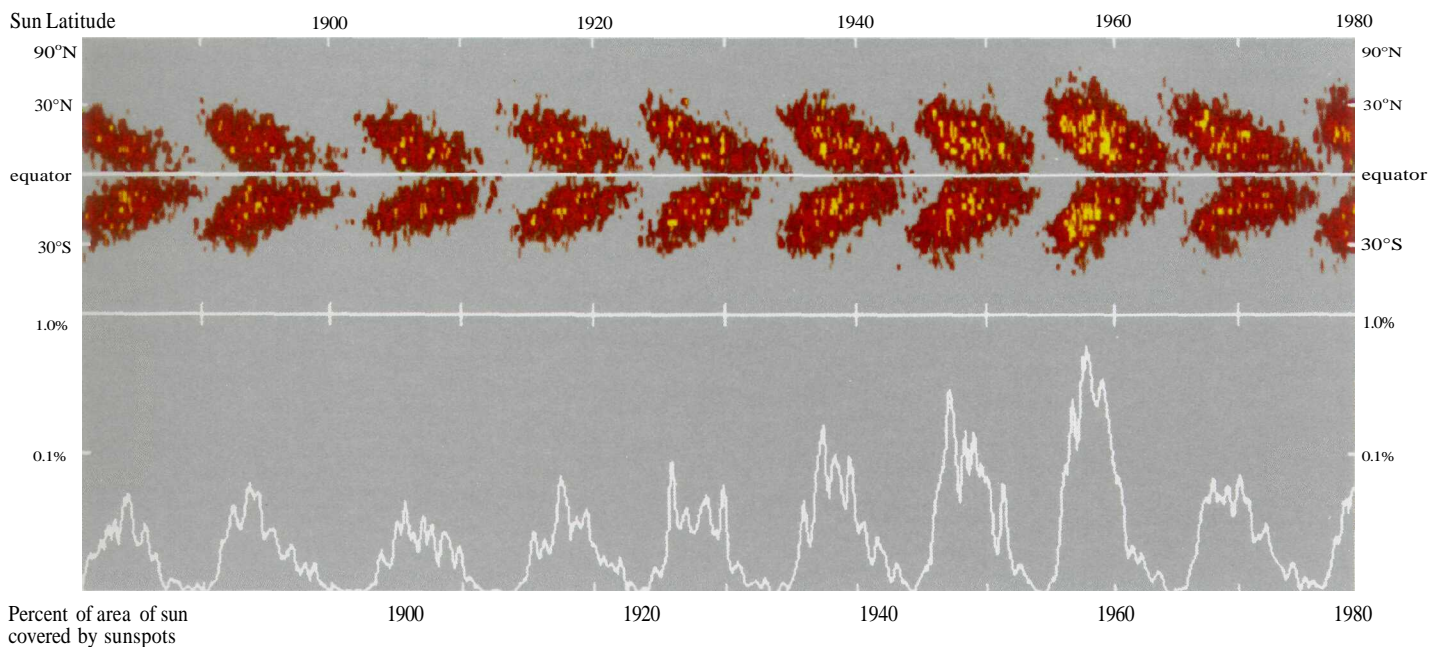
The populations which are the object of statistical study always display variation in one or more respects. To speak of statistics as the study of variation also serves to emphasize the contrast between the aims of modern statisticians and those of their predecessors. For until comparatively recent times, the vast majority of workers in this field appear to have had no other aim than to ascertain aggregate, or average, values. The variation itself was not an object of study, but was recognized rather as a troublesome circumstance which detracted from the value of the average. The

error curve of the *mean* of a normal sample has been familiar for a century, but that of the *standard deviation* was the object of researches up to 1915. Yet, from the modern point of view, the study of the causes of variation of any variable phenomenon, from the yield of wheat to the intellect of [people], should be begun by the examination and measurement of the variation which presents itself.¹⁴

Compared to Maunder's original picture, the modern butterfly diagram increases the data density tenfold, reporting now a full century of solar memoirs. And, moving in parallel with the flapping wings, the lower time-series restores an areal measure of sunspot activity.¹⁵ The display method used here, parallel sequencing, enhances dimensionality and density, although showing the variables one-at-a-time-in-parallel is unrevealing of complex *interrelated* structure. (As statisticians explain, marginal distributions are not wholly informative with regard to joint distributions.) Portrayal of nine full cycles here enforces comfortable comparisons of between- and within-cycle variation, and also exposes an apparent growth trend (perhaps it is merely improved observation) in the wingspan of recent cycles.

Note all the different techniques for displaying sunspots during 380 years of data analysis — from Galileo's first precious observation of the solar disk, to small multiple images, to dimensionality and data compression, and finally to micro/macro displays combining pattern and detail, average and variation. *Exactly the same design strategies are found, again and again, in the work of those faced with a flood of data and images, as they scramble to reveal, within the cramped limits of flatland, their detailed and complex information. These design strategies are surprisingly widespread, albeit little appreciated, and occur quite independently of the content of the data.*

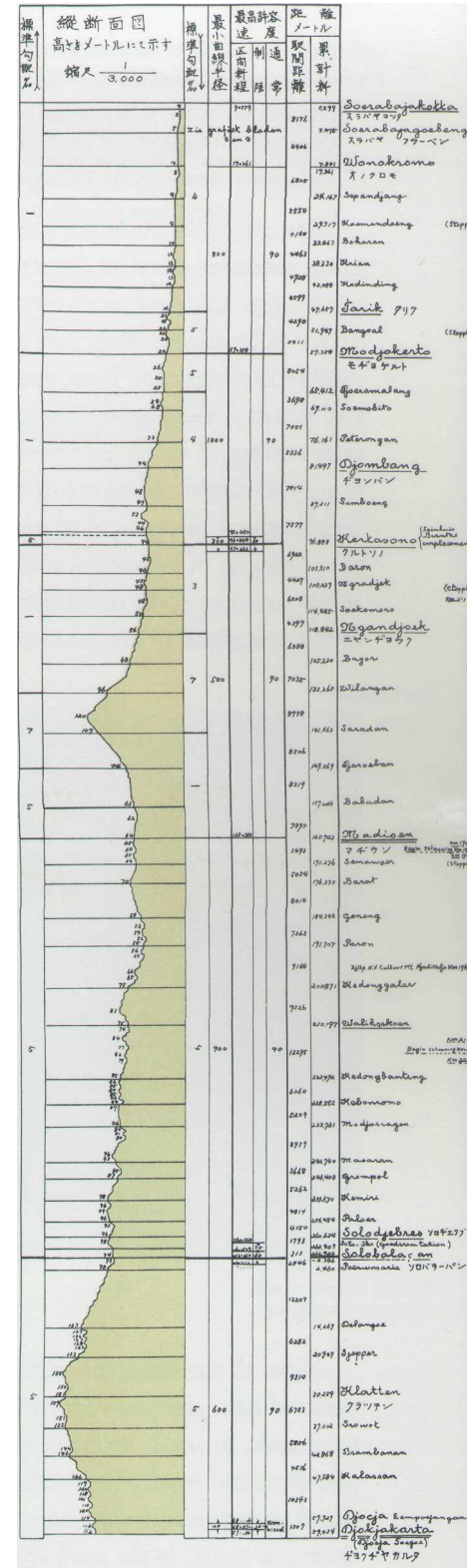
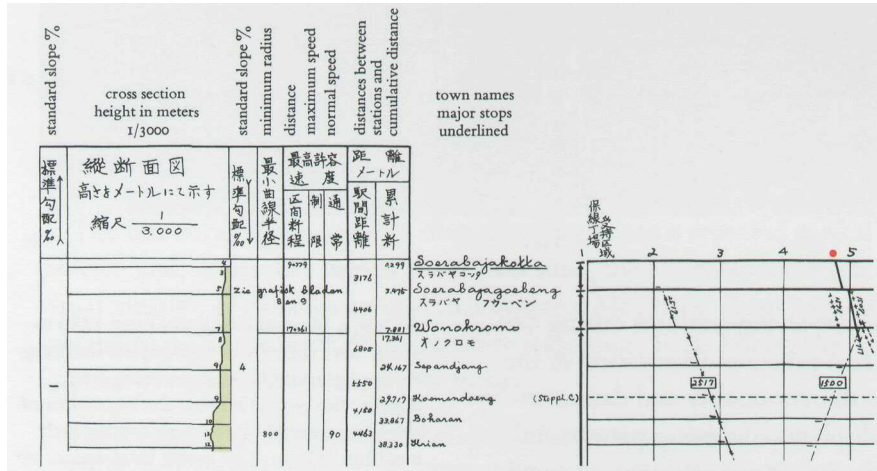

WONDROUSLY complex is this graphic timetable for a Java railroad line, Soerabaja-Djokjakarta, drawn in November 1937 (annotated in Dutch, then in Japanese). By smoothly suppressing a dimension first here and then several times there, finessing perspective treatments entirely, and changing the focus, this 24-hour railroad plan abstractly traces out multiple paths through three-space and time, in a four-dimensional tour with a dozen other variables carried along.

The time scale is read across the top; towns on the railroad route are indicated by names stacked down the column at left. Diagonal lines running from upper left to lower right show trains heading down $\backslash\backslash$, returntrains by diagonals going from lower left to upper right $//$

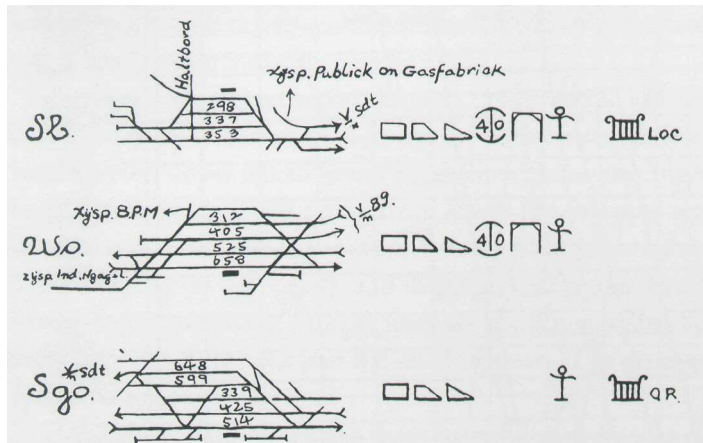
The first train from the top station, Soerabajakotta, leaves at about 4:50 in the morning (at the \bullet dot), and then reaches the first stop just a few minutes later, and so on. Steeper lines are the faster trains. When trains going opposite directions pass by, an \times appears. The arrangement repays meticulous study:

- Graphical timetables turn the three spatial dimensions of our daily world into one train-relevant dimension by measuring distance along the track itself. Horizontal grid lines, marking towns and station stops, are spaced approximately in proportion to their distance apart along the rails (yielding straight-line diagonals, assuming trains run more or less at constant speed over the entire route).
- The left margin of the timetable reflects another viewpoint, with a profile (at an enlarged vertical scale) of all the valleys and mountains crossed by rail. This visual depiction is accompanied by quantitative details, to the right of the profile, where columns of numbers describe the grade and path. Note how the vertical has been used repeatedly to



array parallel sequences of thoroughgoing data. In flatland, after all, every opportunity to spread additional information over an already-available dimension must be cherished.

- Within each station, still another view—for what is important here is activity on the flat ground. Aerial views of the intricate networks of station switching tracks are shown, encoded with symbols, icons, and dingbats describing the local facilities:

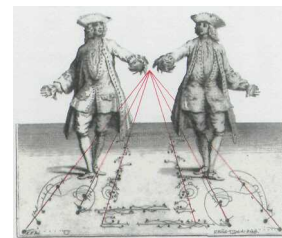
- The train diagonals cleverly multiple-function,¹⁶ as those marks record six variables all at once: the location of a train between towns, time of that position, direction, train type, relative speed (comparing slopes of diagonals), and yearly pattern of operation. A two-dimensional matrix organizes lines by type and seasonality, encoding the diagonal path of the train through the space-time field:

This 16-variable schedule served as an internal planning document for the Java Railroad; it was then obtained by agents working for Japan preparing for their military invasion of Java during 1942." In the upper right-hand corner, this railroad timetable is classified "secret" (秘密). The spy graphical timetable portrays detailed operations of an intricate and irregular system and, at a more distant view, the overall structure and pattern of the railroad—a dual micro and macro reading. It is very much like an excellent map, but with many dimensions breaking free of direct analogy to conventional cartographic flatland.

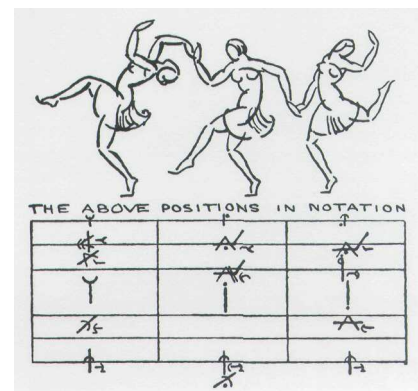

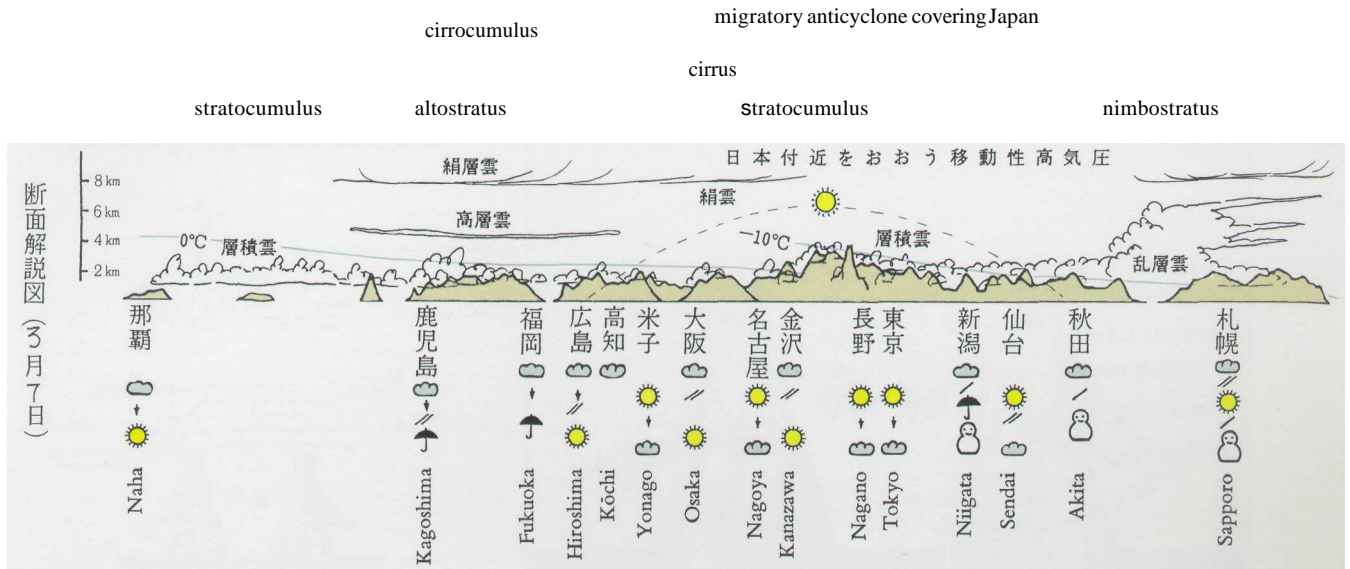

LIKE the tour-guides for the Ise Shrine and sunspots, movements are again depicted on a perspective map, but now in four dimensions - the flatland of floor, coded gestures in dance notation of body motion, and time sequence. (Symbolically encoded because "any serious system of movement notation avoids words because they are a strong deterrent to international communication."¹⁸). The floor plan is linked to the airy music (two dimensions there, time and tone) by numbers, with varying steps for varying sounds. The numbers double-function, simultaneously sequencing steps and relating movement to music. Note the enlarged dance-floor notation for the partner on our right, since he takes a front route in switching sides. Often the redundancy of bilateral symmetry consumes space better devoted to fresh information; but here the integrated complexity of dual movements, as the dancers' paths weave and intermingle, requires symmetric repetition. The two, pulled apart by their mirrored pairing, become visually integrated through their nearly touching hands, mutual postures, overlapping paths of movement, and convergence of perspective lines radiating from the flatland floor to a vanishing point exactly midway between their outstretched hands. A subtle, graceful, profoundly simple design, with a straightforward complexity, a forerunner of modern dance and movement notation.



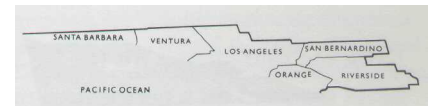

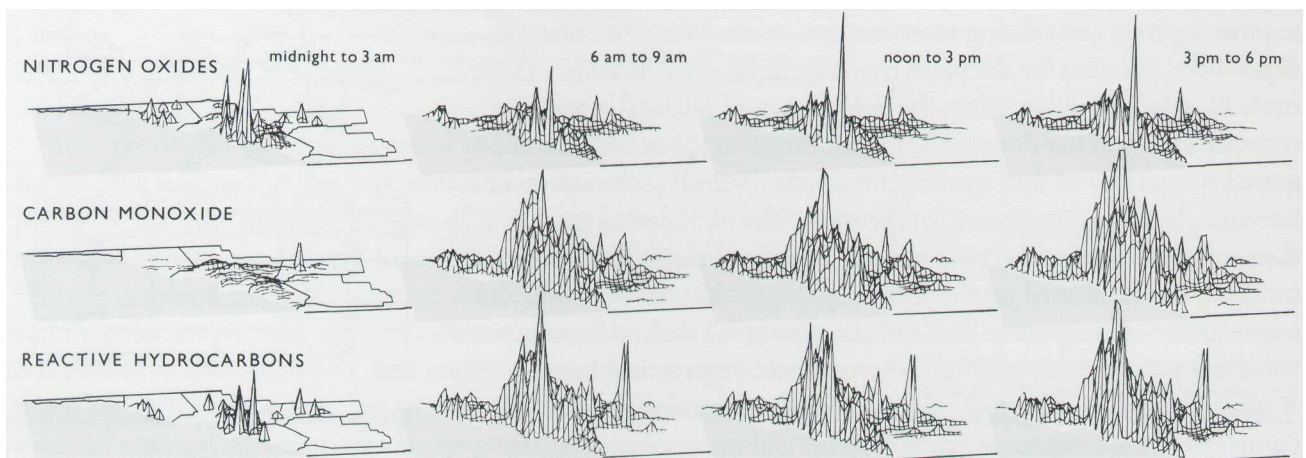
HERE gray contours tracing out constant temperatures at 0° and -10° c stretch through the clouds in a side profile of Japan, an ocean-eye view. Forecasts for 15 areas annotate the cross-section of this unusual weather map from a daily newspaper. How easily the design reads, compared to traditional weather maps that commit both their visual dimensions to a planview of latitude and longitude, suppressing the vertical. Of course the arrangement works best for long, thin countries.

The next graphic, plotted by a computer, reports four times daily the levels of three air pollutants fuming over southern California. Nitrogen oxides (top row) are emitted by power plants, refineries, and vehicles. Refineries along the coast produce post-midnight peaks shown in the first panel; cars and power plants send daytime levels up. The morning traffic generates carbon monoxide, with high concentrations where five freeways converge in downtown Los Angeles. Reactive hydrocarbons (bottom row) emanate from refineries after midnight and then increase

with daily traffic. The twelve time-space-pollutant maps add up smog observations on a spatial grid of 2,400 squares (each five kilometers on a side), for a total of 28,800 readings, except for those masked by peaks—a high density arrangement of data, abounding with variables and with observations on those variables.

This air pollution display is a *small multiple*, with the same design structure repeated for all the images. An economy of perception results; once viewers decode and comprehend the design for one slice of data, they have familiar access to data in all the other slices. As our eye moves from one image to the next, this constancy of design allows viewers to focus on changes in information rather than changes in graphical composition. A steady canvas makes for a clearer picture. Note how paper's two dimensions are put to work here, twice over. Each small map reports on the two-space location of a third quantity; those maps become entries themselves in another matrix arraying time of day by type of pollution, for a grand total of five variables.

Tabular arrays of numbers similarly confront flatland, with design solutions identical to graphical displays. These compound interest tables record a third variable located on the two-surface, and then repeat each array, small multiple style, at levels of a fourth variable. Entries show capital plus interest, entabulated for sequenced amounts of capital and time. That grid is then repeated, indexed on the annual rate of interest.

Data entries located on a plane surface can themselves multiply, as in the notorious applicant/admit tables for law school admissions. Knitting together all combinations of college grades and test scores, the bivariate grid registers both the number of applicants and, from those candidates, the number then actually admitted by this law school. The margins on the right and bottom sum up to univariate distributions, with grand totals shown at lower right. This table could in turn become an entry in another two-space, a multiple comparison over time of various schools. And when that array itself becomes another entry . . .

Small multiples work as efficient and convincing summaries of data or an argument, making the same point again and again by offering complementary variations on the major substantive theme. Here is the colorful story of one such chart:

GOTTI IS ACQUITTED BY A FEDERAL JURY IN CONSPIRACY CASE

NEW CHARGES ARE LIKELY

Verdict is the First Setback in Recent Government Drive Against Mafia Leaders

By LEONARD BUDER

John Gotti was acquitted of Federal racketeering and conspiracy charges yesterday in the Government's first major setback in its recent assault on organized crime.

Mr. Gotti, who the Government says is the leader of the nation's most powerful Mafia family, and six co-defendants were found not guilty of charges they took part in a criminal enterprise. They were accused of carrying out illegal gambling and loan-sharking operations, armed hijackings and at least two murders over an 18-year period.

Despite yesterday's verdict, Federal investigators said the 46-year-old Mr. Gotti might face indictment on new charges as head of the Gambino crime family. "I can't comment but I won't deny it," said Thomas L. Sheer, head of the Federal Bureau of Investigation in New York, when asked if the F.B.I. was building up another case against Mr. Gotti.

'We'll Be Starting Again'

"They'll be ready to frame us again in two weeks," Mr. Gotti told a reporter before leaving the Brooklyn courthouse in a gray Cadillac that was waiting for him. "In three weeks we'll be starting again, just watch."

Until yesterday, Federal prosecutors in the Southern and Eastern Districts of New York had recorded a string of successes in major organized-crime cases.

Within the last six months, the heads of the city's four other Mafia families have been convicted after trials in Manhattan and Brooklyn. They, like Mr. Gotti and his co-defendants, had been charged under the Federal Racketeer Influenced and Corrupt Organizations Act, or RICO.

Key Witnesses Were Criminals

"Obviously they perceived there was something wrong with the evidence," said Andrew J. Maloney, the United States Attorney in Brooklyn, referring to the jury.

Many of the Government's key witnesses were criminals who testified for the prosecution under grants of immunity or in return for payments and other benefits.

The last piece of evidence requested by the jury for re-examination was a chart introduced by the defense that showed the criminal backgrounds of seven prosecution witnesses. It listed 69 crimes, including murder, drug possession and sales and kidnapping.

Mr. Gotti's lawyer, Bruce Cutler, said the jury showed "courage" because "it's not easy to say no to a Federal prosecutor." He said the jury had not been impressed with the testimony of "paid Government informants who lie, who use drugs, who kill people."

The verdict, which came on the seventh day of jury deliberations after a trial that lasted almost seven months, surprised many in the packed courtroom. Friends of the defendants cheered and applauded; the Government prosecutors, Diane F. Giacalone and John Gleeson, looked glum.

Mr. Gotti, who has been dubbed "Dapper Don" because of his expensive attire and impeccable grooming, and his co-defendants hugged and kissed each other and their lawyers.

Then they stood and applauded as the 12 members of the jury — whose identities had been kept secret to prevent possible tampering — left the room escorted by Federal marshals....

A Weakness In Gotti Case

Major U.S. Witnesses Viewed as Unreliable

Many lawyers and prosecutors who followed events in the seven-month trial of John Gotti said the underlying weakness of the prosecution's case was its apparent reliance on turncoat career criminals as key witnesses against Mr. Gotti and six co-defendants.

News Analysis

A signal that the credibility of the prosecution's principal witnesses was in doubt came yesterday morning when the jury, in its final request before acquitting the defendants of all charges, reviewed an exhibit introduced by the defense.

It was a chart listing the lengthy criminal records of seven prosecution witnesses who had obtained promises of leniency and other favors from the Government in return for their testimony against Mr. Gotti....

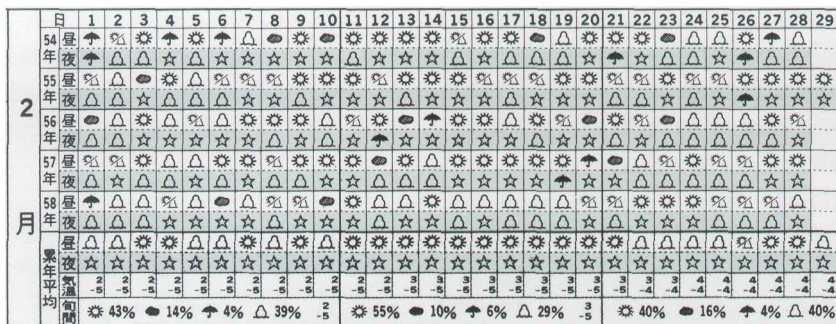
The chart invites reading both horizontally and vertically; neither direction enhances the reputations of those testifying against Mr. Gotti and his colleagues, as the eye detects curious patterns and unbroken runs of X's. Mr. Polisi, for example, has something of a streak going. Those marks indicating each crime by each witness are not modest or shy, and they dominate the spreadsheet grid (although only 37 percent of all the possible combinations are marked). Placement of particularly obnoxious activities at the top (murder) and bottom of the list (pistol whipping a priest) exploits the visual prominence of those positions.

Such displays are likely to be especially persuasive and memorable in situations where most information communicated consists of spoken words—as in a trial.¹⁹ Courtroom graphics can overcome the linear, nonreversible, one-dimensional sequencing of talk talk talk, allowing members of a jury to reason about an array of data at their own pace and in their own manner. Visual displays of information encourage a diversity of individual viewer styles and rates of editing, personalizing, reasoning, and understanding. Unlike speech, visual displays are simultaneously a wideband and a perceiver-controllable channel.

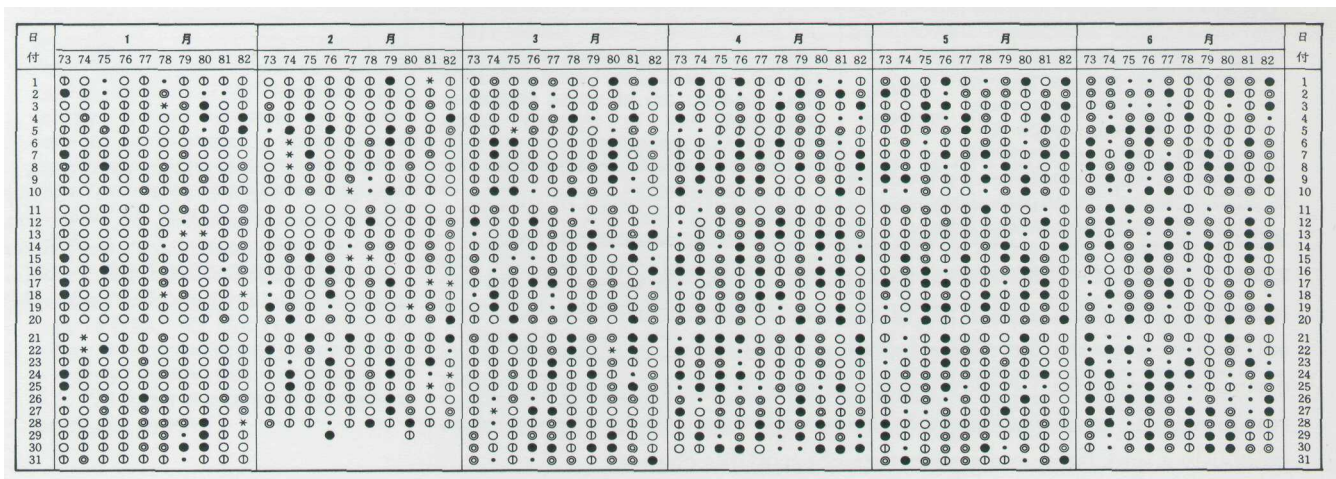
This weather history above extends the technique, partitioning data by town, year, month, day, and day/night. Here are five years of daily and nightly Tokyo weather every day in February. Bottom rows report summary data, averaged over ten-day periods, recounting the (1) most frequently observed weather, 1967-1982; (2) average high and low temperatures, last 30 years, 1951-1980; and (3) daytime frequency of sunshine, clouds, and rain during the last 16 years. A splendid total of 414 pieces of data are smoothly entabled, conveying both a sense of *average* and *variation* about that average—the two fundamental summary measures of statistical data.

An even more concentrated history, below, of Tokyo climate divides a full decade of observations by town, year, month, and day. Especially adroit is the gathering of both dimensions of the paper to apportion the one-dimensional variable, time, into increments from fine to coarse; each year-by-day-matrix is compounded by months, stretching the range of a compact display into an abundant span of 1,826 days of weather history. High-information graphics, such as this, convey a spirit of quantitative depth and a sense of statistical integrity. Emaciated data-thin designs, in contrast, provoke suspicions—and rightfully so—about the quality of measurement and analysis.

- Clear. Average amount of clouds less than 15% for all day (3:00, 9:00, 15:00, 21:00).
- Fair. Average amount of clouds more than 15% and less than 84% for all day.
- Cloudy. Average amount of clouds more than 85%.
- Light rain. Rain more than 1 mm but less than 5 mm.
- Rain. More than 5 mm in 24 hours.
- Snow. More than 1 cm during day.





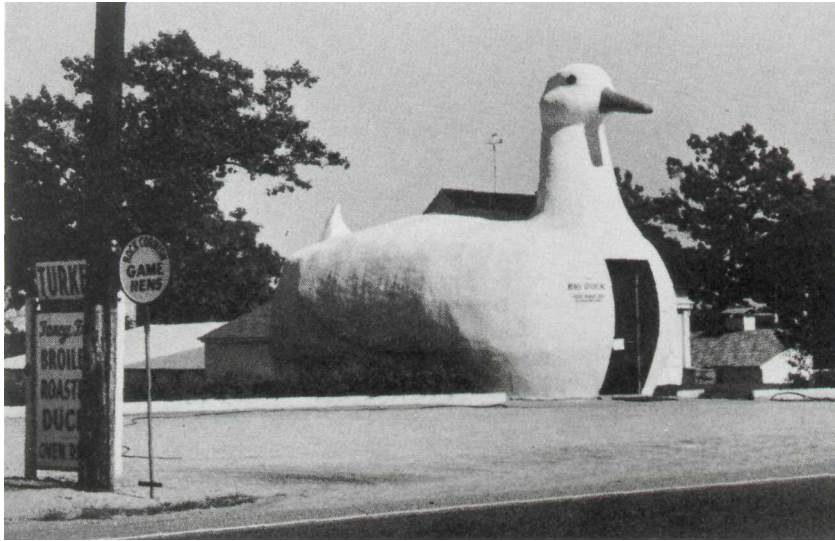
Small multiples, whether tabular or pictorial, move to the heart of visual reasoning - to see, distinguish, choose (even among children's shirts). Their multiplied smallness enforces local comparisons within our eyespan, relying on an active eye to select and make contrasts rather than on bygone memories of images scattered over pages and pages.

We envision information in order to reason about, communicate, document, and preserve that knowledge — activities nearly always carried out on two-dimensional paper and computer screen. Escaping this flatland and enriching the density of data displays are the essential tasks of information design. Such escapes grow more difficult as ties of data to our familiar three-space world weaken (with more abstract measures) and as the number of dimensions increases (with more complex data). Still, all the history of information displays and statistical graphics — indeed of any communication device — is entirely a progress of methods for enhancing density, complexity, dimensionality, and even sometimes beauty. Some of these methods, identified and described in the chapters that follow, include micro/macro readings of detail and panorama, layering and separation of data, multiplying of images, color, and narratives of space and time.

By giving the focus over to data rather than data-containers, these design strategies are transparent and self-effacing in character. Designs so good that they are invisible. Too many data presentations, alas, seek to attract and divert attention by means of display apparatus and ornament. Chartjunk has come to corrupt all sorts of information exhibits and computer interfaces, just like the "ducks" of modern architecture:

When Modern architects righteously abandoned ornament on buildings, they unconsciously designed buildings that *were* ornament. In promoting Space and Articulation over symbolism and ornament, they distorted the whole building into a duck. They substituted for the innocent and inexpensive practice of applied



decoration on a conventional shed the rather cynical and expensive distortion of program and structure to promote a duck.... It is now time to reevaluate the once-horrifying statement of John Ruskin that architecture is the decoration of construction, but we should append the warning of Pugin: It is all right to decorate construction but never construct decoration.²⁰

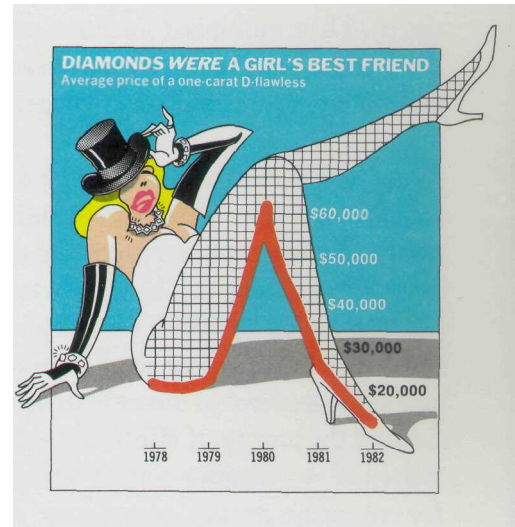
Consider this unsavory exhibit at right—chockablock with cliché and stereotype, coarse humor, and a content-empty third dimension. It is the product of a visual sensitivity in which a thigh-graph with a fishnet-stocking grid counts as a Creative Concept. Everything counts, but nothing matters. The data-thin (and thus uncontextual) chart mixes up changes in the value of money with changes in diamond prices, a crucial confusion because the graph chronicles a time of high inflation.

Lurking behind chartjunk is contempt both for information and for the audience. Chartjunk promoters imagine that numbers and details are boring, dull, and tedious, requiring ornament to enliven. Cosmetic decoration, which frequently distorts the data, will never salvage an underlying lack of content.²¹ If the numbers are boring, then you've got the wrong numbers. Credibility vanishes in clouds of chartjunk; who would trust a chart that looks like a video game?²²

Worse is contempt for our audience, designing as if readers were obtuse and uncaring. In fact, consumers of graphics are often more intelligent about the information at hand than those who fabricate the data decoration. And, no matter what, the operating *moral* premise of information design should be that our readers are alert and caring; they may be busy, eager to get on with it, but they are not stupid. Clarity and simplicity are completely opposite simple-mindedness. Disrespect for the audience will leak through, damaging communication. What E. B. White said of writing is equally true for information design: "No

one can write decently who is distrustful of the reader's intelligence, or whose attitude is patronizing."²³

Standards of excellence for information design are set by *high quality maps*, with diverse bountiful detail, several layers of close reading combined with an overview, and rigorous data from engineering surveys. In contrast, the usual chartjunk performances look more like posters than maps. Posters are meant for viewing from a distance, with their strong images, large type, and thin data densities. Thus poster design provides very little counsel for making diagrams that are read more intensely. Display of closely-read data surely requires the skilled craft of good graphic and poster design: typography, object representation, layout, color, production techniques, and visual principles that inform criticism and revision. Too often those skills are accompanied by the ideology of chartjunk and data posterization; excellence in presenting information requires mastering the craft and spurning the ideology.²⁴

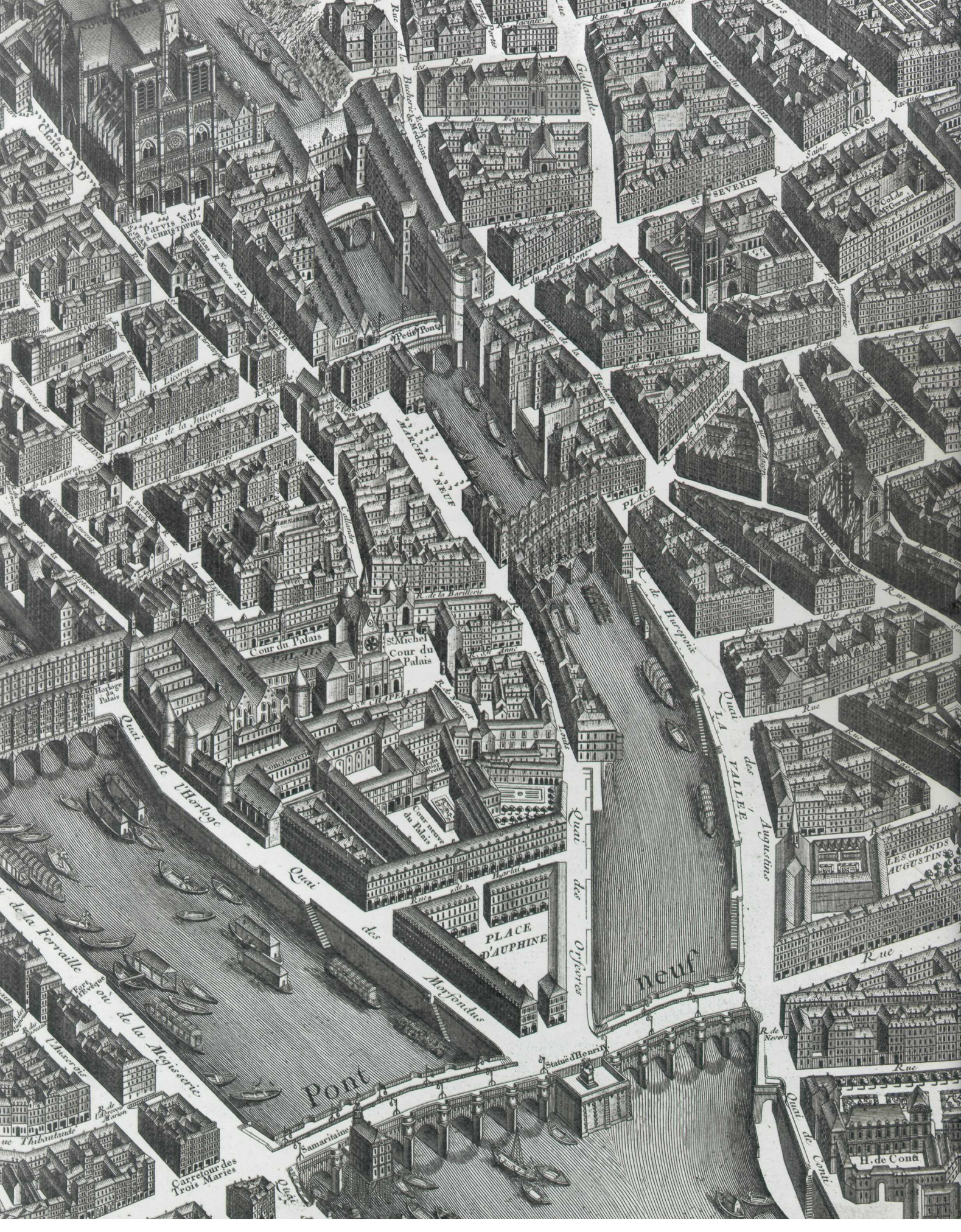
THE ducks of information design are *false escapes from flatland*, adding pretend dimensions to impoverished data sets, merely fooling around with information. They don't work, just as this royal dining table, caught up in flatland, fails to hold the pots and plates. The king and queen watch in exasperation and exclaim, as their meal slides off, "It's the way they draw these wretched tables!"

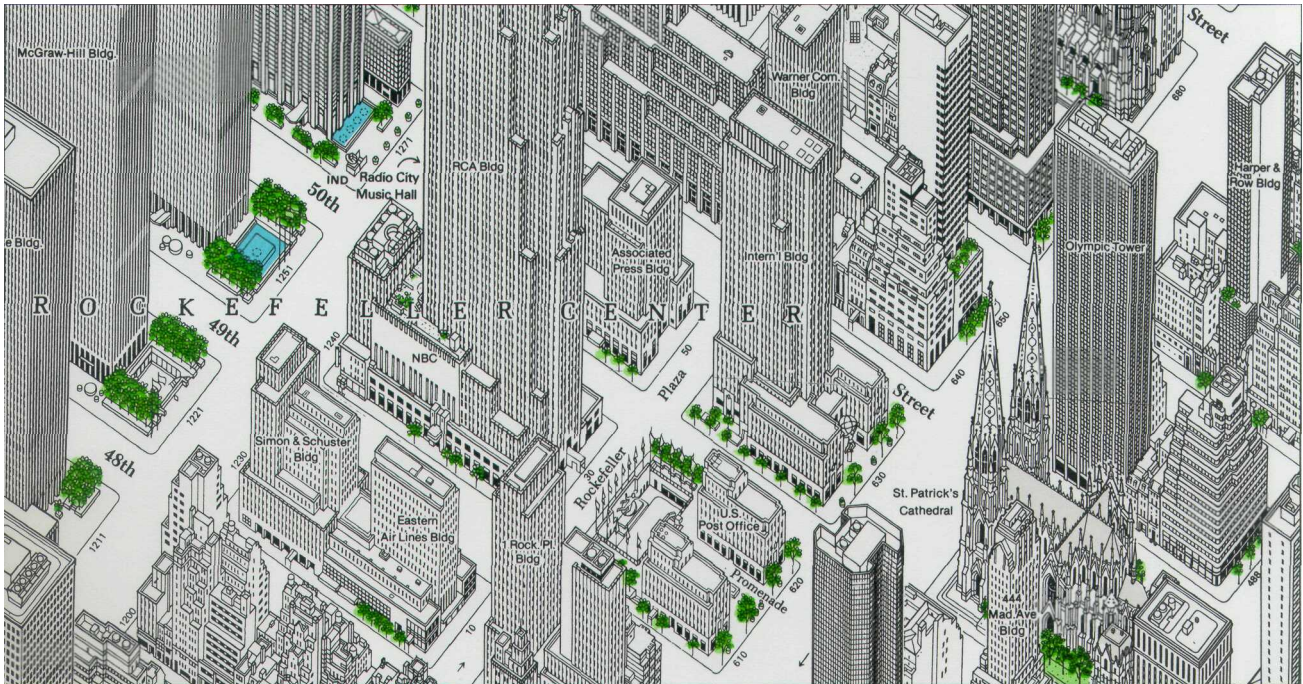

For 20 years Constantine Anderson refined this precise axonometric projection of midtown New York (shown here are Rockefeller Center environs), following the tradition of the classic 1739 Bretez-Turgot *Plan de Paris* (at left, the area around Pont Neuf and Notre Dame, from the 11th of 20 sheets). The Manhattan map embraces such fine points as individual windows, subway stations and bus shelters, telephone booths, building canopies, trees, and sidewalk planters. And the typography is persistently thorough; the entire map (60 by 92 centimeters, or 24 by 36 inches) reports 1,686 names of buildings, stores, and parks along with 657 specific street addresses—*for a map, an abundant typographic density of 3 characters per square centimeter (20 per square inch)*. The only major concession to paper flatland is widening of the map's streets to reduce masking of some buildings by others.

This fine texture of exquisite detail leads to personal micro-readings, individual stories about the data: shops visited, hotels stayed at, walks taken, office windows at a floor worked on—all in the extended context of an entire building, street, and neighborhood.¹ Detail cumulates into larger coherent structures; those thousands of tiny windows, when seen at a distance, gray into surfaces to form a whole building. Simplicity of reading derives from the context of detailed and complex information, properly arranged. A most unconventional design strategy is revealed: *to clarify, add detail*.

A high-resolution aerial photograph of Senlis, one of the oldest cities in France (construction started on this Notre Dame cathedral in 1153), arrays micro-details mixing into overall pattern. Encircling Senlis was once a broad strip of Gallo-Roman fortification, now replaced by houses, arranged by the memory of the old town's plan. Such intensity of detail is routinely reported in photographs, so much data that digitizing these images for computers requires 10^6 to 10^8 bits.

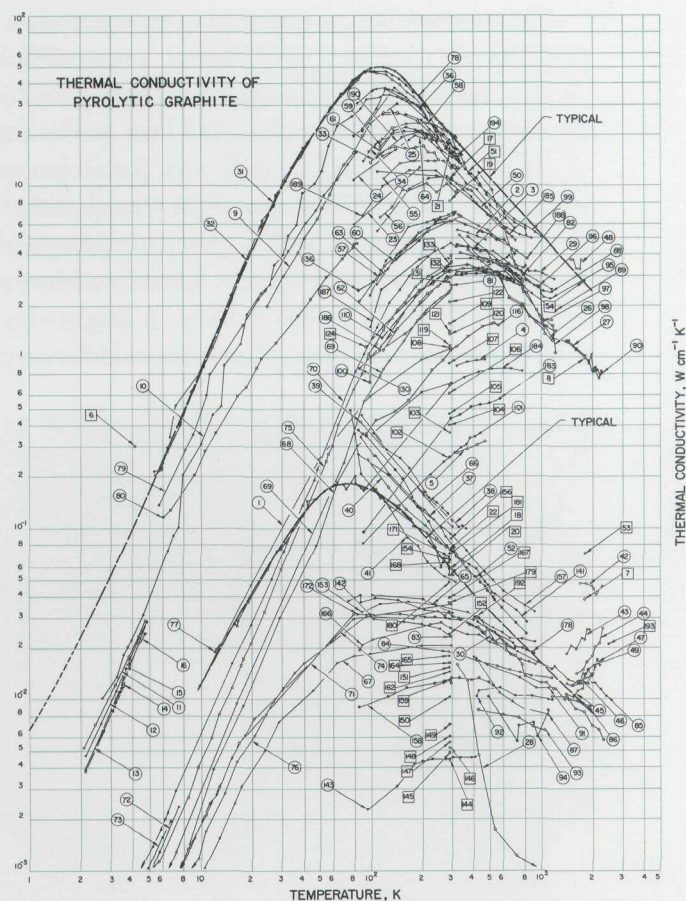
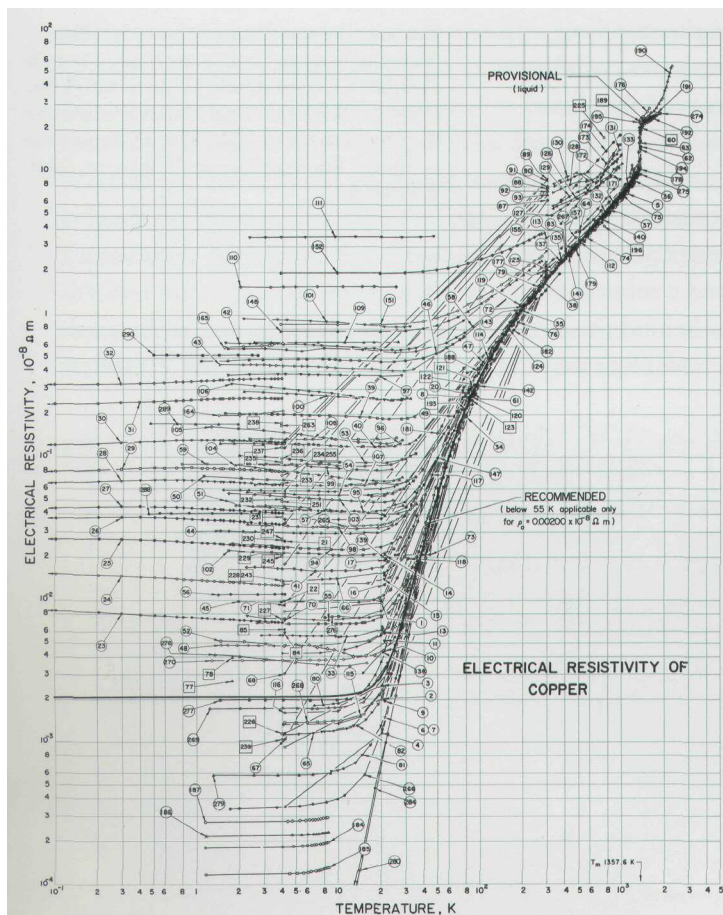
Micro/macro composition also oversees this celebrated 1930 poster composed by the Soviet graphic artist Gustav Klutsis. The design and political point correspond—as the poster shows and also writes out, from collaborative work of many hands, one great plan will be fulfilled.

At work here is a critical and effective principle of information design. Panorama, vista, and prospect deliver to viewers the freedom of choice that derives from an overview, a capacity to compare and sort through detail. And that micro-information, like smaller texture in landscape perception, provides a credible refuge where the pace of visualization is condensed, slowed, and personalized.² These visual experiences are universal, rooted in human information-processing capacities and in the abundance and intricacy of everyday perceptions. Thus the power of micro/macro designs holds for every type of data display as well as for topographic views and landscape panoramas. Such designs can report immense detail, organizing complexity through multiple and (often) hierarchical layers of contextual reading.

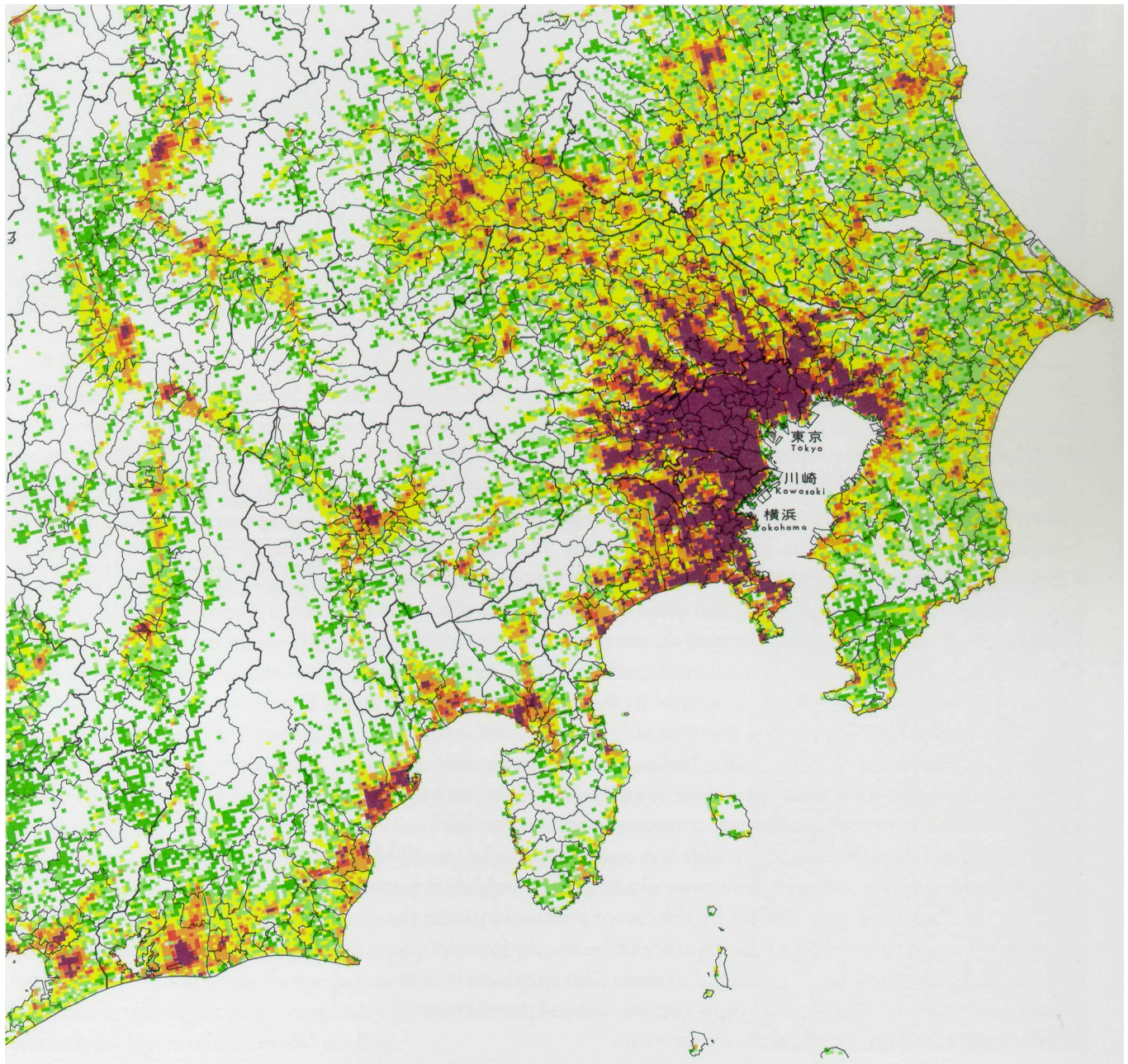
These multi-layered graphs report a clouded relationship between temperature and conductivity for various elements, as measured by many different laboratories. Each set of connected points comes from a single publication, cited by an identification number. Note how easily these displays organize the material, recording observations from several hundred studies and also enforcing comparisons among quite divergent results (this is science?) scattered around the correct curve, a solid line labeled **RECOMMENDED**. Since both scales are logarithmic, cycling through 3.5 to 6 orders of magnitude, deviations from the recommended curve are often quite substantial. In this micro/macro arrangement, 4 layers of data are placed in evidence—individual points measured within each study, connected curves formed by those results, and, finally, an overall conglomeration of curves (which are compared with the standard).

Still another slice of data can be added. A number, linked to an *alphabetical* list ordered by author's name, now identifies each published paper. A better method is to order the list by the *date* of publication; then the numerical codes correspond to the sequence of findings—foreexample, 61c indicates the third paper published in 1961. This graphical indexing depicts which study first had the right answer, and movement toward the correct curve can be tracked over the years.

These extraordinary statistical maps report data for thousands of tiny grid squares (1 km on a side). Below, a map of Tokyo shows population density; note smaller concentrations dotting the tracks radiating from the city, as people cluster along rail lines and station stops. At this level of detail, residents can find their own particular square and also see it in a broader context. The map at right records the proportion of children living at each location, with a systematic pattern of lower percentages in central Tokyo (where space is limited and costly) and a suburban ring teeming—relatively—with children. A bright idea lies behind these grid-square or mesh maps. Conventional blot maps (choropleth maps,

in the jargon) paint over areas formed by *given* geographic or political boundaries. The consequences are (1) sizes of areas are non-uniform, (2) colored-in areas are proportional to (often nearly empty) land areas instead of the activities depicted, with large unpopulated areas often receiving greatest visual emphasis, and (3) historical changes in political boundaries disrupt continuity of statistical comparisons.³ Mesh maps finesse these problems. For these maps, the whole country of Japan was divided up in 379,000 equal-sized units and then, in a heroic endeavor, census data and addresses were collated to match the new grid squares. Arbitrary but statistically wise boundaries now cradle the micro-data.

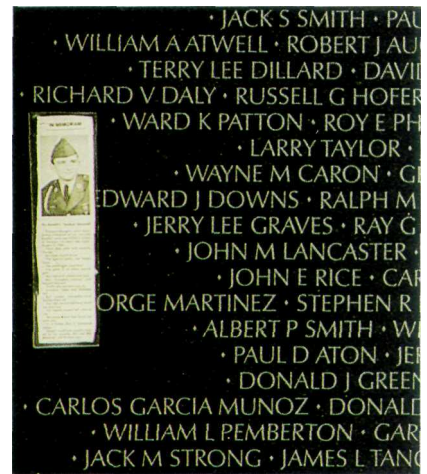




THE Vietnam Veterans Memorial in Washington, D.C. achieves its visual and emotional strength by means of micro/macro design. From a distance the entire collection of names of 58,000 dead soldiers arrayed on the black granite yields a visual measure of what 58,000 means, as the letters of each name blur into a gray shape, cumulating to the final toll. When a viewer approaches, these shapes resolve into individual names. Some of the living seek the name of one particular soldier in a personal micro-reading; more than a few visitors here touch the etched, textured names. We focus on the tragic information; absent are the big porticoes, steps and stairs, and other marble paraphernalia usually attached to grand official monuments. Walking on a slight grade downward (approaching from either side), our first close reading is of panels no higher than a few names. But looking forward, the visitor sees names of the dead rising higher and higher, a statistical blur of marks in the distance with micro-detail at hand. The context is enlarged by calm reflections off polished black granite, reflections of the living and of trees, and, at a distance, of the Lincoln and Washington memorials toward which the walls angle.

An additional data dimension comes from the ordering of names. The memorial's designer, Maya Ying Lin, proposed that names be listed by date of death rather than alphabetically:

. . . chronological listing was essential to her design. War veterans would find their story told, and their friends remembered, in the panel that corresponded with their tour of duty in Vietnam. Locating specific names with the aid of a directory would be like finding bodies on a battlefield. . . . Some initially disagreed. If 58,000 names were scattered along the wall, anyone looking for a specific name would wander around for hours and then leave in frustration. One solution seemed obvious: list everyone in alphabetical order. . . . But when a two-inch-thick Defense Department listing of Vietnam casualties was examined, thinking changed. There were over 600 Smiths; 16 people named James Jones had died in Vietnam. Alphabetical listing would make the Memorial look like a telephone book engraved in granite, destroying the sense of unique loss that each name carried. . . .⁴

Thus the names on stone triple-function: to memorialize each person who died, to make a mark adding up the total, and to indicate sequence and approximate date of death. A directory-book alphabetically lists all the names and serves as a finder, pointing viewers to the location of a single engraved name.

The spirit of the *individual* created by the wall—both of each death and of each viewer personally editing—decisively affects how we see other visitors. The busloads of tourists appear not so much as crowds but rather as many separate individual faces, not as interruptions at an architectural performance but rather as our colleagues.⁵

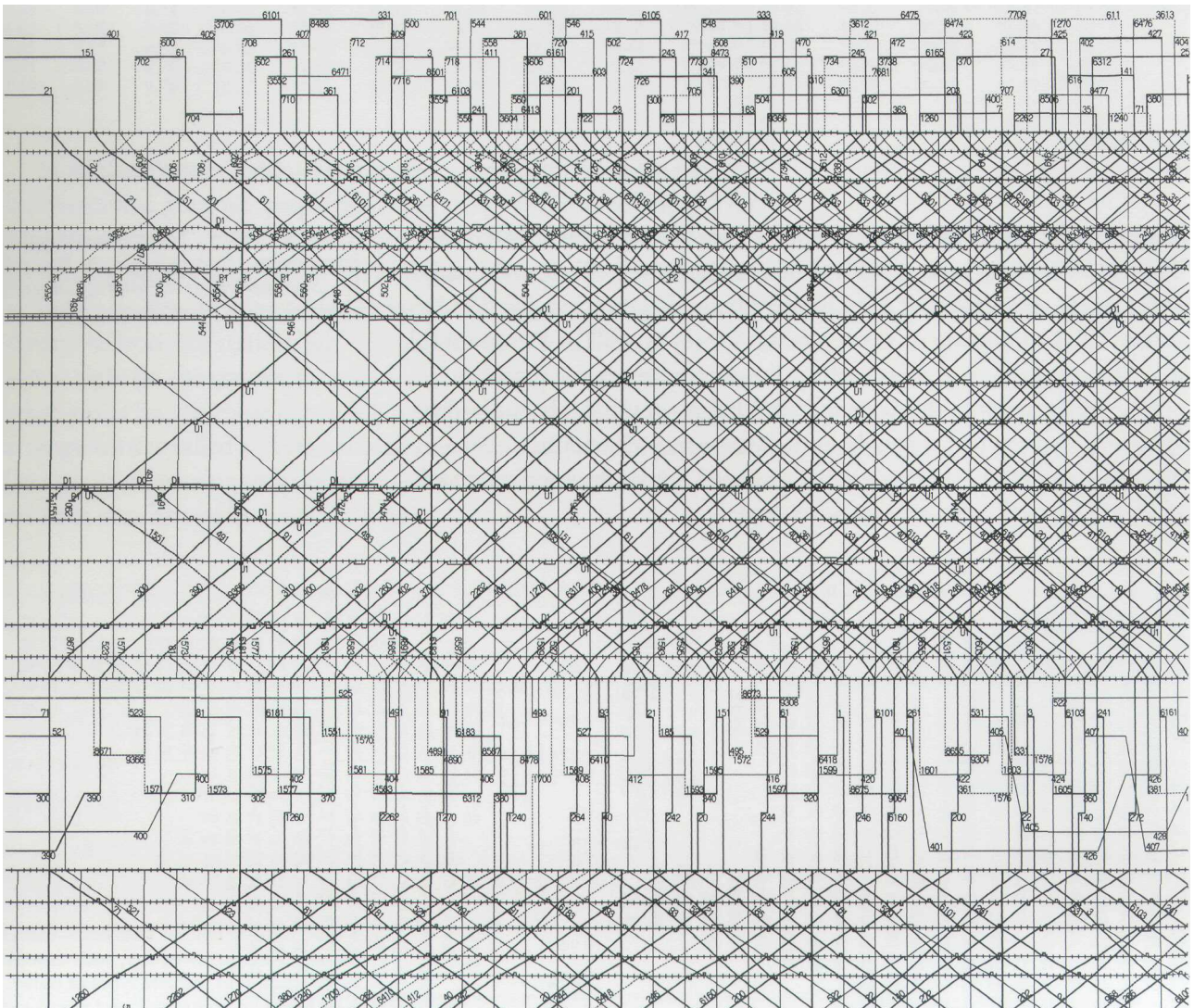

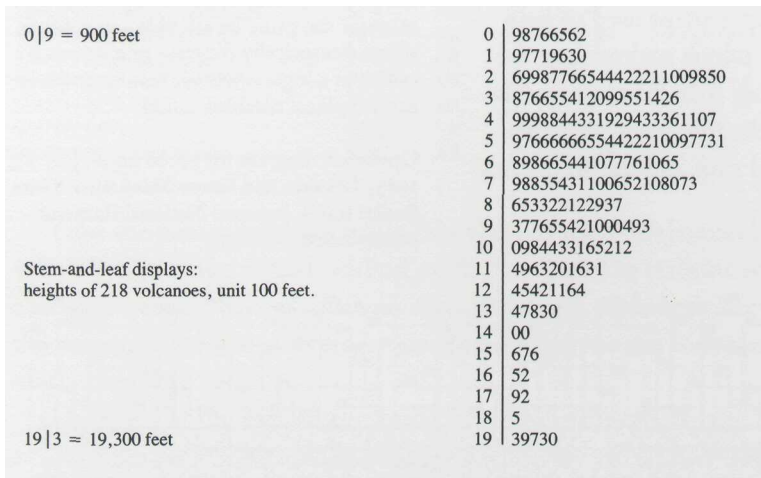
GRAPHICAL timetables also exemplify the multiplicity and wholeness of micro/macro design. Described here is the overall structure of a railroad system, as the individual lines aggregate into systematic patterns. This computer-graphical timetable shown here governs Japanese high-speed trains, or *Shinkansen*. Station stops are plotted down the side of the grid; time of day runs across the top; diagonal lines show the space-time path of each train. The Tokyo control-room directing these high-speed trains is filled with these graphical timetables, long paper strips used to help oversee thousands of journeys each day — a task which makes clear the enormous advantages of *seeing* information rather than tabulating data. Similar charts are also used for planning new schedules, with different interest groups negotiating where a train should stop and the frequency of service as they design a graphical timetable.⁶

Stem-and-leaf plots of statistical analysis also rely on micro/macro design. Each data point simultaneously states its value and fills a space representing one counted unit, like the names on the Vietnam Veterans Memorial, with those spaces in turn assembling to form a profile of the overall univariate distribution. Envisioned here are the heights of 218 volcanoes; each individual number helps to build the histogram. Micro-



data has replaced the information-empty bars of a traditional barchart. This idea of making each graphical element *repeatedly* effective animated design of the stem-and-leaf plot. In describing his invention, John Tukey wrote: "If we are going to make a mark, it may as well be a meaningful one. The simplest — and most useful — meaningful mark is a digit."⁷

Reported is the overall time distribution of 292 daily trains, with peaks during morning and evening rush hours. The shrewd design saves 777 characters, avoiding this typographical extravaganza below, which lacks the intensive annotation of the stem-and-leaf original and also fails to provide clear testimony about frequency of train service by hour.⁸

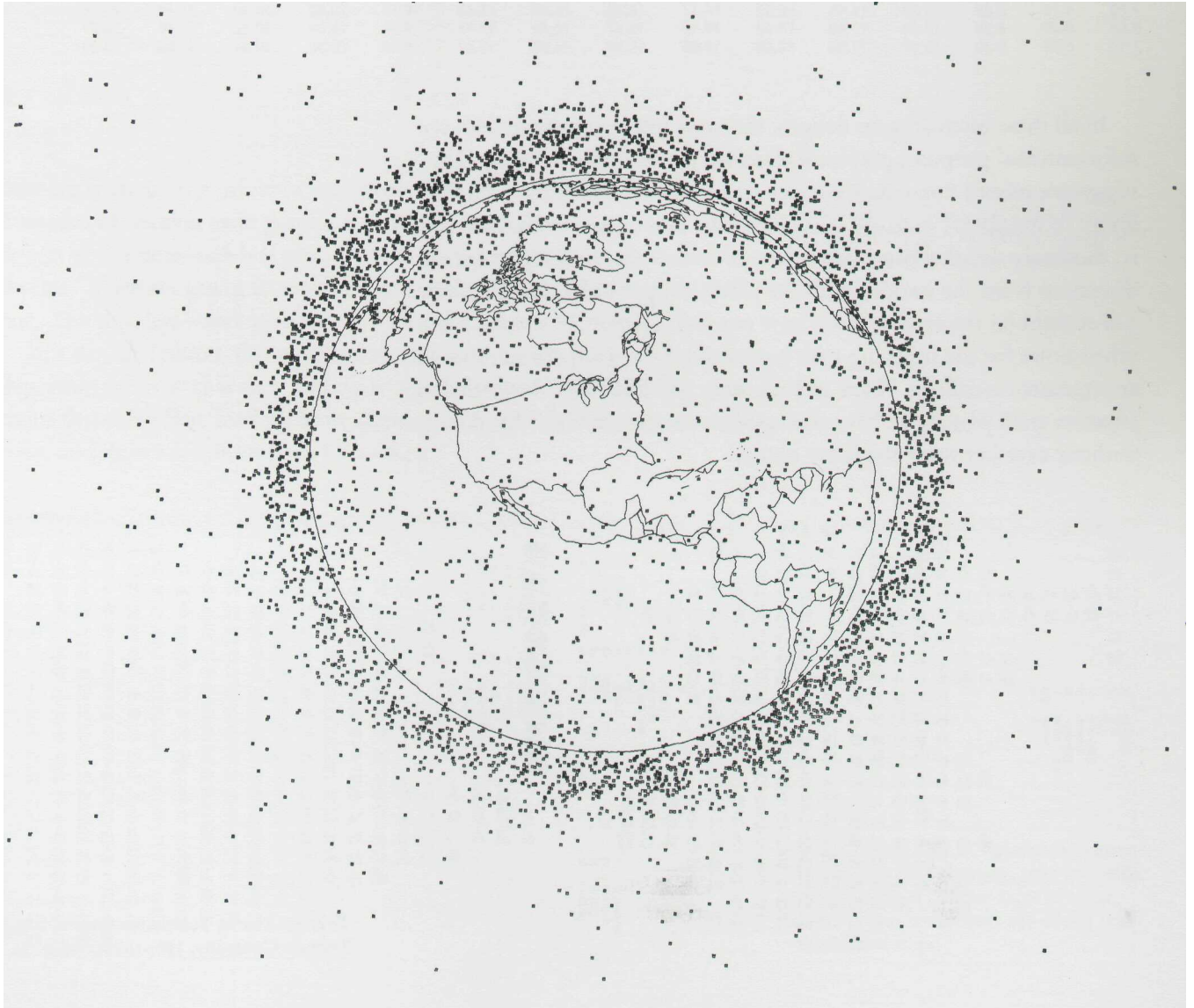

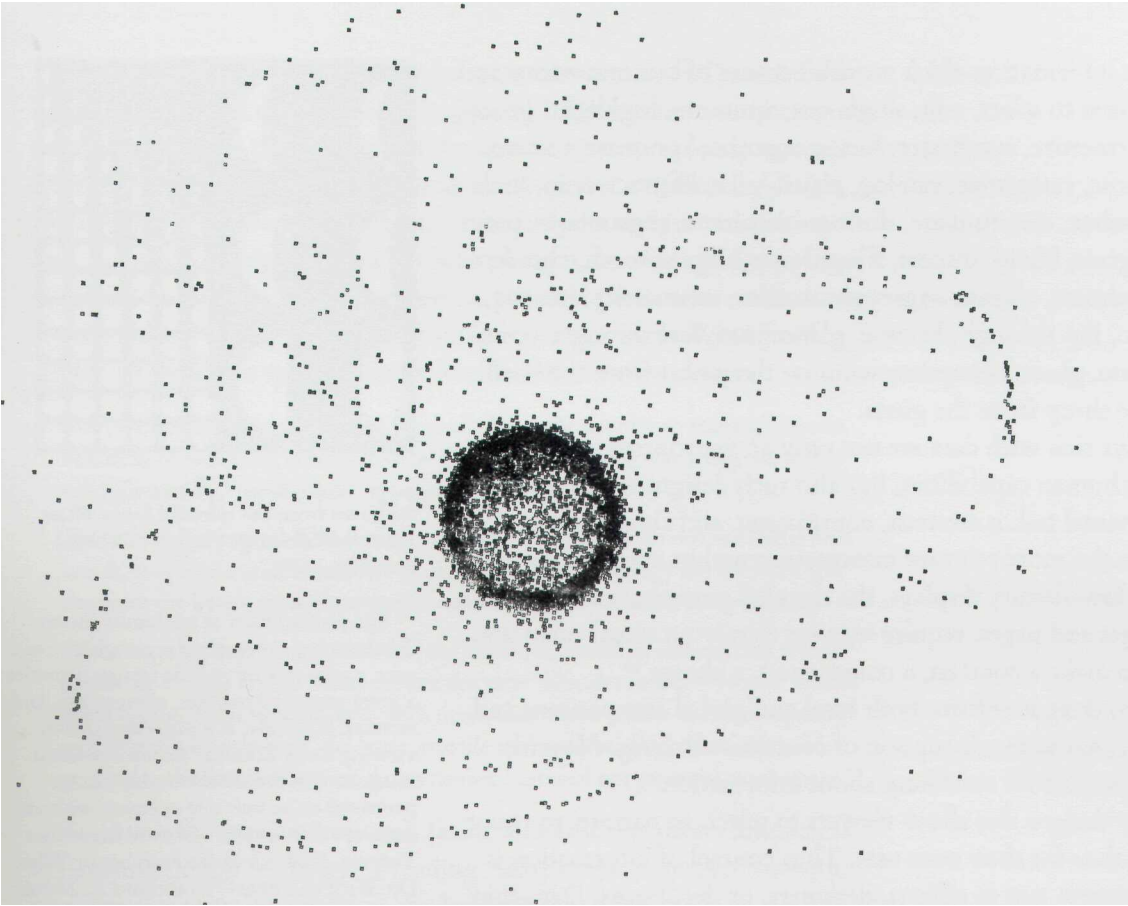
In all these micro/macro designs, the same ink serves more than one informational purpose; graphical elements are multifunctioning. This suggests a missed opportunity in the stem-and-leaf timetable—surely leaves of numbers can grow from *both* sides of a central stem. And so it is; the finely detailed timetable below records trains running in several directions from the station, with the platforms 7-8 at left and platforms 5-6 at right (at the arrows, note how numbers serpentine around a bend when times for the morning rush hour exceed the grid). Sometimes this arrangement is called a "back to back stem and leaf plot." Nonetheless, Japanese train passengers have managed to use the schedules for decades without ever knowing the fancy name.

EACH at least as big as this drawing of the earth, some 7,000 pieces of space debris — operating and dead satellites, explosion fragments from rocket engines, garbage bags and frozen sewage dumped by astronauts, shrapnel from antisatellite weapons tests, 34 nuclear reactors and their fuel cores, an escaped wrench and a toothbrush — now orbit our world. Only about 5 percent are working satellites. By means of extraordinary data recording and analysis, military computers identify and then track *each* of these 7,000 objects (>10 cm in diameter), in order to differentiate the debris from a missile attack, for which we may be thankful. Space is not totally self-cleaning; some of the stuff will be up there for centuries, endangering people and satellites working in space as well as inducing spurious astronomical observations. The risk of a damaging collision is perhaps 1 in 500 during several years in orbit. The volume of debris has doubled about every 5 years; future testing of space weapons will accelerate the trashing of space.⁹

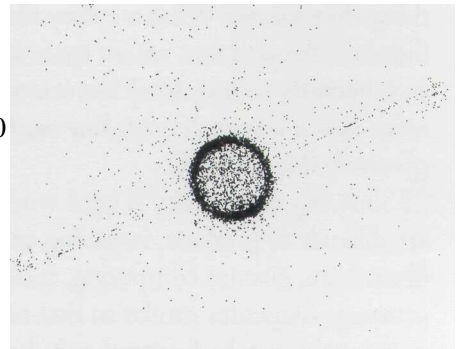

The consequences (as of 0:00 hours Universal time, July 1, 1987) are shown in these phenomenal and disheartening micro/macro images, as a multiplicity of 7,000 dots adds to the overall pattern of orbital pollution. Most of the debris is relatively close to earth; a more distant view shows a ring formed by geosynchronous satellites. Not shown are some 50,000 smaller objects (size between 1 cm and 10 cm), as well as 10 billion to 100 billion paint chips now in orbit.

NEARLY all micro/macro designs of this chapter have portrayed large quantities of data at high densities, up to thousands of bits per square centimeter and 20 million bits per page, pushing the limits of printing technology. Such quantities are thoroughly familiar, although hardly noticed: the human eye registers 150 million bits, the 35 mm slide some 25 million bits, conventional large-scale topographic maps up to 150 million bits, the color screen of a small personal computer 8 million bits. Typographic densities are also substantial; a few reference books report 28,000 characters per page, books on non-fiction best-seller lists from 5,000 to 15,000 characters per page, and the world's telephone books run between 10,000 and 18,000 characters per page. Statistical graphics and other information displays should do so well.

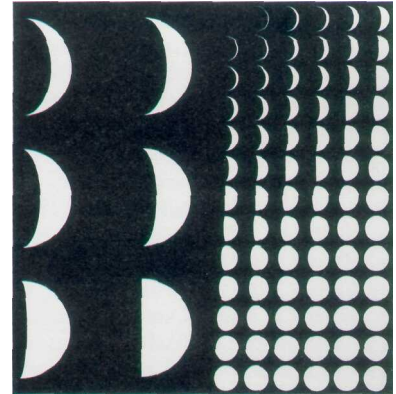
We thrive in information-thick worlds because of our marvelous and everyday capacities to select, edit, single out, structure, highlight, group, pair, merge, harmonize, synthesize, focus, organize, condense, reduce, boil down, choose, categorize, catalog, classify, list, abstract, scan, look into, idealize, isolate, discriminate, distinguish, screen, pigeonhole, pick over, sort, integrate, blend, inspect, filter, lump, skip, smooth, chunk, average, approximate, cluster, aggregate, outline, summarize, itemize, review, dip into, flip through, browse, glance into, leaf through, skim, refine, enumerate, glean, synopsise, winnow the wheat from the chaff, and separate the sheep from the goats.

Visual displays rich with data are not only an appropriate and proper complement to human capabilities, but also such designs are frequently optimal. If the visual task is contrast, comparison, and choice—often it is—then the more relevant information within eyespan, the better. Vacant, low-density displays, the dreaded posterization of data spread over pages and pages, require viewers to rely on visual memory—a weak skill—to make a contrast, a comparison, a choice.¹⁰

Micro/macro designs enforce both local and global comparisons and, at the same time, avoid the disruption of context switching. All told, exactly what is needed for reasoning about information.¹¹

High-density designs also allow viewers to select, to narrate, to recast and personalize data for their own uses. Thus control of information is given over to *viewers*, not to editors, designers, or decorators. Data-thin, forgetful displays move viewers toward ignorance and passivity, and at the same time diminish the credibility of the source. Thin data rightly prompts suspicions: "What are they leaving out? Is that really everything they know? What are they hiding? Is that all they did?" Now and then it is claimed that vacant space is "friendly" (anthropomorphizing an inherently murky idea) but *it is not how much empty space there is, but rather how it is used. It is not how much information there is, but rather how effectively it is arranged.*

Showing complexity is hard work. Detailed micro/macro designs are difficult to produce, imposing substantial costs for data collection, illustration, custom computing, image processing, production, and fine printing—expenses similar to that of first-class cartography (which, in the main, can be financed only by governments). The conventional economies of declining costs for each additional data bit will usually be offset by a proliferation of elaborate complexities provoked by the interacting graphical elements. Still, a single high-density page can replace twenty scattered posterizations, with a possible savings when total expenses are assessed (data collection and analysis, design, paper, production, printing, binding, warehousing, and shipping). And our readers might keep that one really informative piece of paper, although they will surely discard those twenty posterizations.

What about confusing clutter? Information overload? Doesn't data have to be "boiled down" and "simplified"? These common questions miss the point, for the quantity of detail is an issue completely separate from the difficulty of reading. *Clutter and confusion are failures of design, not attributes of information.* Often the less complex and less subtle the line, the more ambiguous and less interesting is the reading. Stripping the detail out of data is a style based on personal preference and fashion, considerations utterly indifferent to substantive content. What Josef Albers wrote about typography is true for information design:

The concept that "the simpler the form of a letter the simpler its reading" was an obsession of beginning constructivism. It became something like a dogma, and is still followed by "modernistic" typographers.

This notion has proved to be wrong, because in reading we do not read letters but words, words as a whole, as a "word picture." Ophthalmology has disclosed that the more the letters are differentiated from each other, the easier is the reading.

Without going into comparisons and the details, it should be realized that words consisting of only capital letters present the most difficult reading—because of their equal height, equal volume, and, with most, their equal width. When comparing serif letters with sans-serif, the latter provide an uneasy reading. The fashionable preference for sans-serif in text shows neither historical nor practical competence.¹²

So much for the conventional, facile, and false equation: simpleness of data and design = clarity of reading. Simpleness is another aesthetic preference, not an information display strategy, not a guide to clarity. What we seek instead is a rich texture of data, a comparative context, an understanding of complexity revealed with an economy of means.

Robert Venturi opens his *Complexity and Contradiction in Architecture* with a broad extension of Albers' point:

I like complexity and contradiction in architecture.... I speak of a complex and contradictory architecture based on the richness and ambiguity of modern experience, including that experience which is inherent in art. Everywhere, except in architecture, complexity and contradiction have been acknowledged, from Gödel's proof of inconsistency in mathematics to T. S. Eliot's analysis of "difficult" poetry and Joseph Albers' definition of the paradoxical quality of painting.... Architects can no longer afford to be intimidated by the puritanically moral language of orthodox Modern architecture an architecture of complexity and contradiction has a special obligation toward the whole: its truth must be in its totality or its implications of totality. It must embody the difficult unity of inclusion rather than the easy unity of exclusion. . . . Where simplicity cannot work, simpleness results. Blatant simplification means bland architecture. Less is a bore.¹³

But, finally, the deepest reason for displays that portray complexity and intricacy is that the worlds we seek to understand are complex and intricate. "God is in the details," said Mies van der Rohe, capturing the essential quality of micro/macro performances.

3 Layering and Separation

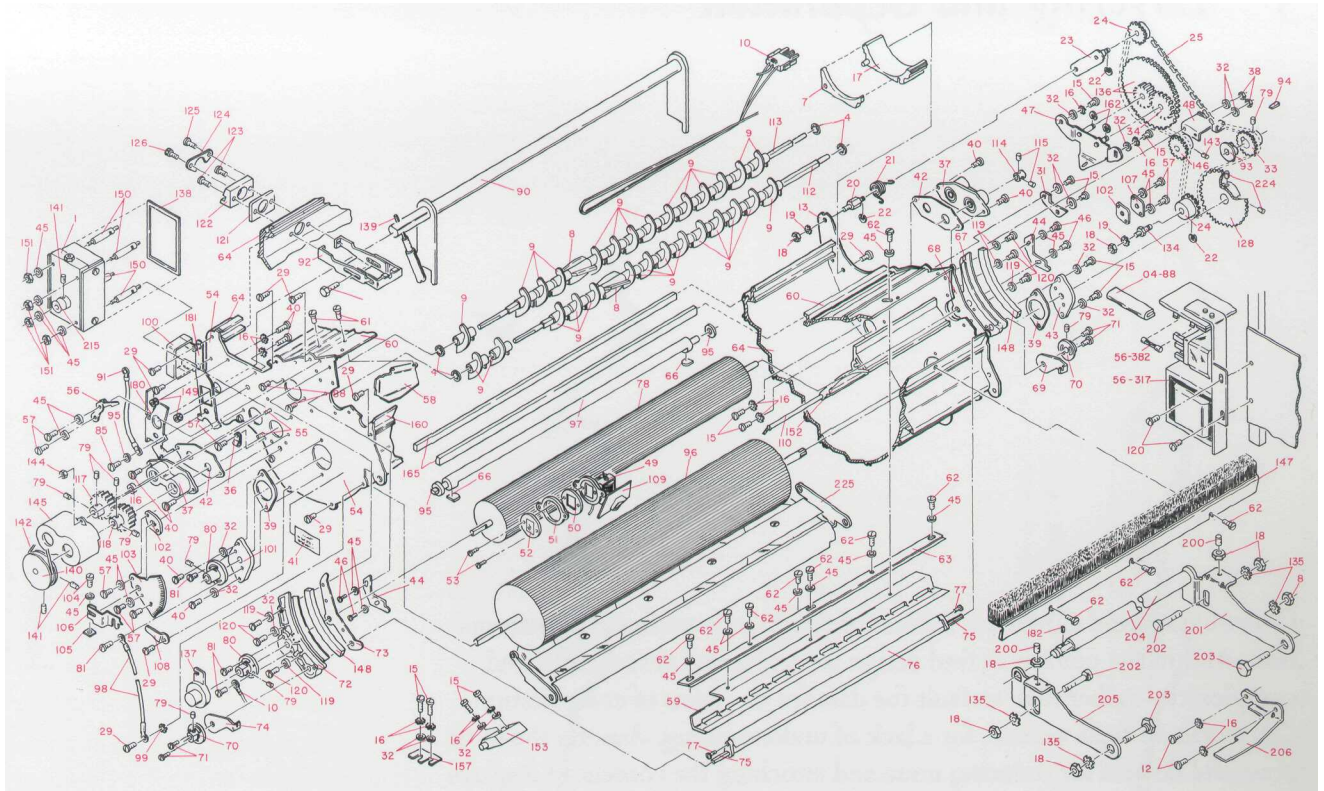
CONFUSION and clutter are failures of design, not attributes of information. And so the point is to find design strategies that reveal detail and complexity—rather than to fault the data for an excess of complication. Or, worse, to fault viewers for a lack of understanding. Among the most powerful devices for reducing noise and enriching the content of displays is the technique of layering and separation, visually stratifying various aspects of the data.

Effective layering of information is often difficult; for every excellent performance, a hundred clunky spectacles arise. An omnipresent, yet subtle, design issue is involved: the various elements collected together on flatland *interact*, creating non-information patterns and texture simply through their combined presence. Josef Albers described this visual effect as $1 + 1 = 3$ or more, when two elements show themselves along with assorted incidental by-products of their partnership—occasionally a basis for pleasing aesthetic effects but always a continuing danger to data exhibits.¹ Such patterns become dynamically obtrusive when our displays leave the relative constancy of paper and move to the changing video flatland of computer terminals. There, all sorts of unplanned and lushly cluttered interacting combinations turn up, with changing layers of information arrayed in miscellaneous windows surrounded by a frame of system commands and other computer administrative debris.

AT left a second color annotates the brush strokes of the calligrapher, Uboku Nishitani. By creating a distinct layer, the red commentary maintains detail, coherence, and serenity, in a crisp precision side-by-side with a gestural and expressive black line in this marriage of color and information. The saturated quality of the red partially offsets its lighter value and finer line (appropriate to meticulous annotation). Alone, each color makes a strong statement; together, a stronger one.

Similarly, color effortlessly differentiates between annotation and annotated, in this skillful industrial-strength diagram separating 300 small parts and their identifying numbers.

What matters—inevitably, unrelentingly—is the proper *relationship* among information layers. These visual relationships must be in relevant proportion and in harmony to the substance of the ideas, evidence, and data conveyed. "Proportion and harmony" need not be vague counsel; their meanings are revealed in the practice of detailed visual editing of data displays. For example, in this train timetable a heavy-handed grid interacts with the type, generating a stripy texture and fighting with the scheduled times. The prominent top position in the table shows the least important information, a four-digit train identifier used by railroad personnel and nobody else:

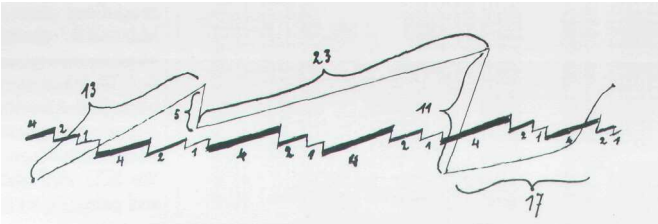
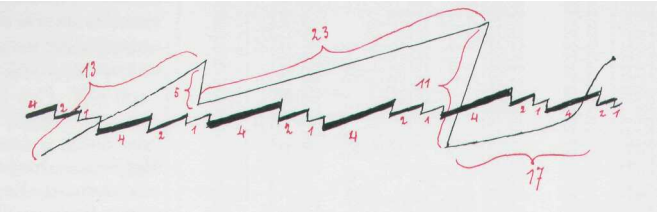

The focus is now given over to information, transparently organized by an *implicit* typographical grid, defined simply by the absence of type. Nevertheless, data-imprisonment spans centuries of information-design struggles. At right is a touchingly ramshackle grid from a 1535 edition of *Cosmographia*. But, from the virtuoso of typographic design: "Tables should not be set to look like nets with every number enclosed," wrote Jan Tschichold in *Asymmetric Typography*:

The setting of tables, often approached with gloom, may with careful thought be turned into work of great pleasure. First, try to do without rules altogether. They should be used only when they are absolutely necessary. Vertical rules are needed only when the space between columns is so narrow that mistakes will occur in reading without rules. Tables without vertical rules look better; thin rules are better than thick ones.²

Even quite small changes in line can have significant visual effects. For Paul Klee's sketch, the easy and graceful separation of black line and red commentary collapses into a mishmash when color and light/dark differences are minimized:

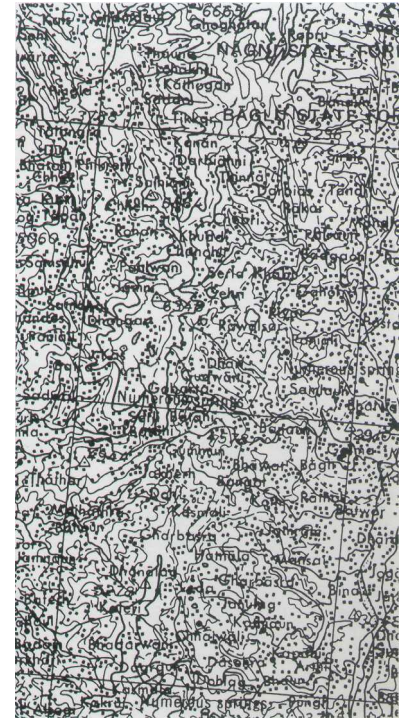
All elements in the map at right—contours, rivers, roads, names—are at the same visual level with equal values, equal texture, equal color, and even nearly equal shape. An undifferentiated, unlayered surface results, jumbled up, blurry, incoherent, chaotic with unintentional optical art. What we have here is a failure to communicate.

Far more detailed than the perfect jumble, this map below separates and layers information by means of distinctions in shape, value (light to dark), size, and especially color. The negative areas are also informative;



light strips formed by the grid of buildings identify roads and paths. The water symbol is a blue field, further differentiated from other color fields by a gentle fading away from each outlined edge. Shown against a dull background rather than bright white, these colors remain both calm and distinctive, avoiding clutter. The map exemplifies the "first rule of color composition" of the illustrious Swiss cartographer, Eduard Imhof:

Pure, bright or very strong colors have loud, unbearable effects when they stand unrelieved over large areas adjacent to each other, but extraordinary effects can be achieved when they are used sparingly on or between dull background tones. "Noise is not music . . . only on a quiet background can a colorful theme be constructed," claims Windisch.³



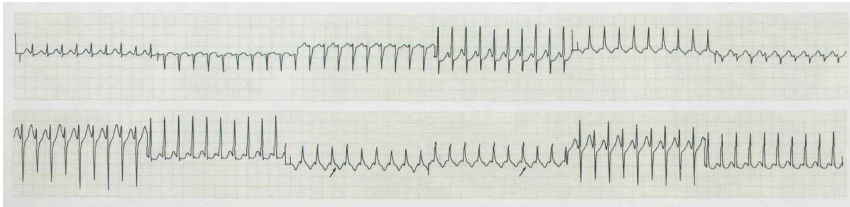

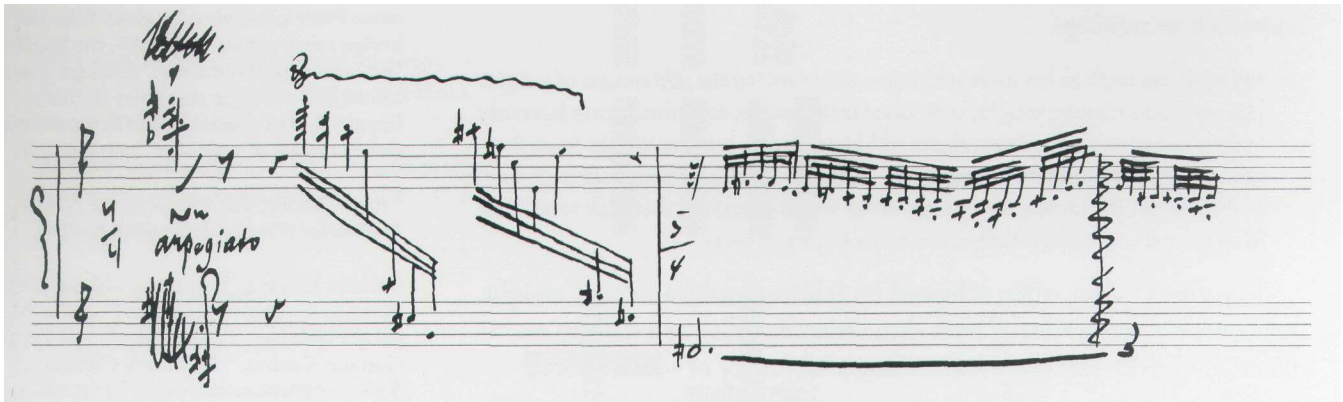
Signal and background compete above, as an electrocardiogram trace-line becomes caught up in a thick grid. Below, the screened-down grid stays behind traces from each of 12 monitoring leads:⁴



Similarly for music notation, some staff paper is better than others:



In Stravinsky's sketchbook for *Sacre du printemps*, a grid quietly but clearly and precisely locates the music. Gray grids almost always work well and, with a delicate line, may promote more accurate data reading



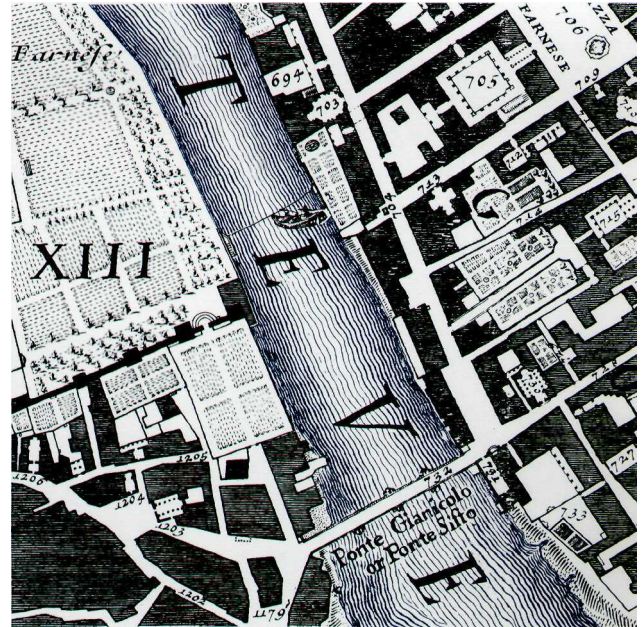
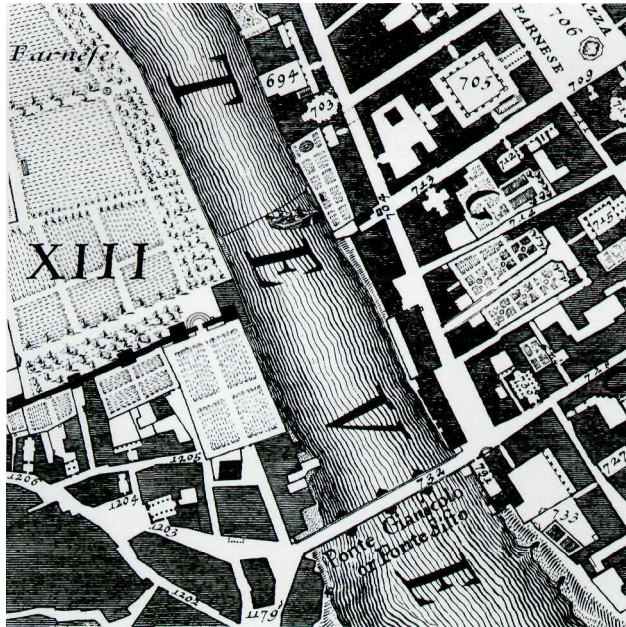
and reconstruction than a heavy grid. Dark grid lines are chartjunk. When a graphic serves as a look-up table (rare indeed), then a grid may help with reading and interpolation. But even then the grid should be muted relative to the data. Often ready-made graph paper comes with darkly printed lines. The reverse imprinted side should be used, for then lines show through faintly and do not clutter the data. If the paper is heavily gridded on both sides, throw it out.

In the masterly 1748 Nolli map of Rome, the river's heavy inking activates what should be a visually tranquil area, causing bridge names and a little boat to vibrate in a moire prison, albeit a quiet one. Muting the river encoding calms vibration and brings names and other details forward, while retaining a symbolism of rippling water.⁵ This redesign and others that we have seen are visual equivalents of Italo Calvino's approach to writing:

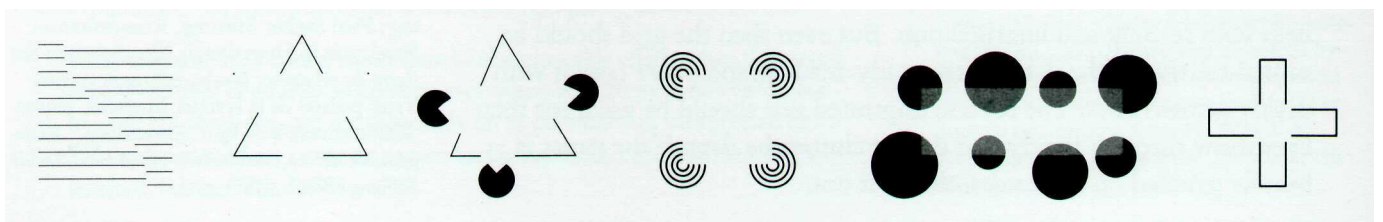
My working method has more often than not involved the subtraction of weight. I have tried to remove weight, sometimes from people, sometimes from heavenly bodies, sometimes from cities; above all I have tried to remove weight from the structure of stories and from language. . . . Maybe I was only then becoming aware of the weight, the inertia, the opacity of the world — qualities that stick to writing from the start, unless one finds some way of evading them.⁶

Layering of data, often achieved by felicitous subtraction of weight, enhances representation of both data dimensionality and density on flatland. Usually this involves creating a hierarchy of visual effects, possibly matching an ordering of information content. Small, modest design moves can yield decisive visual results, as in these intriguing demonstrations of the illusory borders of subjective contours:

Visual activation of negative areas of white space in these exhibits illustrates *the endlessly contextual and interactive nature of visual elements*. This idea is captured in a fundamental principle of information design: *1 + 1 = 3 or more*. In the simplest case, when we draw two black lines, a third visual activity results, a bright white path between hues (note that this path appears even to have an angled end). And a complexity



of marks generates an exponential complexity of negative shapes. *Most of the time, that surplus visual activity is non-information, noise, and clutter.*⁷ This two-step logic — recognition of $1 + 1 = 3$ effects and the consideration that they generate noise — provides a valuable guide for refining and editing designs, for graphical reasoning, for subtraction of weight.⁸

In a little-known essay on $1 + 1 = 3$ effects, Josef Albers conducts the demonstrations below, a visually sensitive and artistic approach to the cognitive contours of perceptual psychologists. Albers, seeing area and surface rather than border and edge, escapes the preoccupying magic of optical illusions to conceive a broad idea of negative space activation:

Here I have 2 equal strips of cardboard (1" x 6")

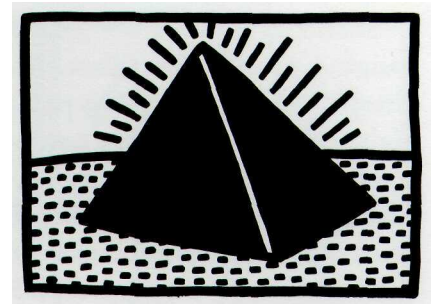
Here is one (vertical), here another (also vertical).
Seeing one strip plus one strip, we count 2 strips:
 $1 + 1 = 2$.

We recognize the equal width of the strips.
Now, 1 width + 1 width (strips touching)
equals 2 widths: $1 + 1 = 2$.

But now, separating them (both remain vertical)
by 1 width — we count 3 widths
(one of them negative) : $1 + 1 = 3$.

Of the 2 vertical strips,
one crosses the other horizontally
in their centers.
Result: 2 lines form a crossing
thus producing 4 arms, as 4 extensions,
to be read inward as well as outward.
We also see 4 rectangles, and with some imagination,
4 triangles, 4 squares.
By shifting centers and angles,
arms and the in-between figures become unequal.

All together: one line plus one line
results in many meanings — *Quod erat demonstrandum.*

Stumbling over $1 + 1 = 3$ has produced perhaps the worst index ever designed, a rare perfect failure. The preface to this guide for flying small aircraft says, "This manual is primarily intended for use during actual flight instruction." Imagine now noisy vibration in a plane as we search through this visually vibrating list, looking for, say, an entry on "forced landing" ... and the index turns out to have no page numbers. Only a small segment of the unbearable original is shown.

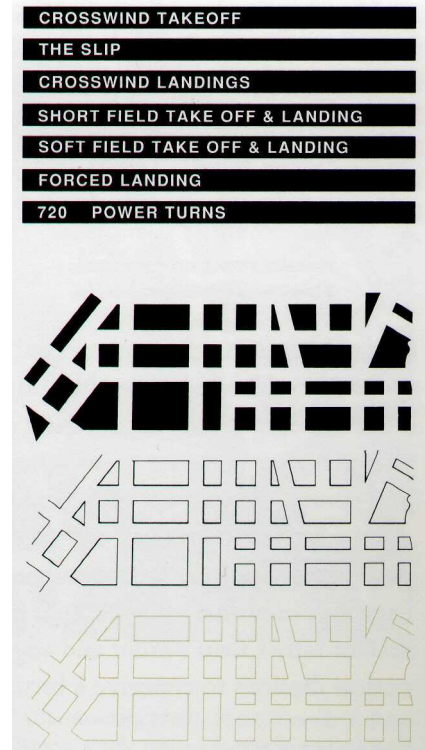
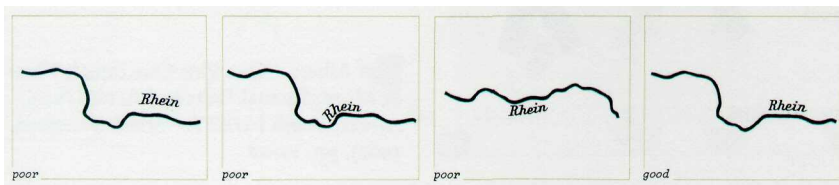
The noise of $1 + 1 = 3$ is directly proportional to the contrast in value (light/dark) between figure and ground. On white backgrounds, therefore, a varying range of lighter colors will minimize incidental clutter. Three maps at right show these tactics in action. In the first, the bold shapes promote vibration all over; and with only nameless streets down on paper, this map is already in visual trouble. At center, thinning two sides of each block results in every street bordered by one thick *and* one thin line, thus deflecting $1 + 1 = 3$ effects (the thin lines, like gray lines, are *visually* light in value). On the bottom map, gray establishes serene, motionless edges - an arrangement that will easily accommodate additional geographic detail.

Careful visual editing diminishes $1 + 1 = 3$ clutter. These are not trivial cosmetic matters, for signal enhancement through noise reduction can reduce viewer fatigue as well as improve accuracy of readings from a computer interface, a flight-control display, or a medical instrument. Clarity is not everything, but there is little without it. Editing this statistical graph (showing variability about local averages) remedies the visual clutter induced by parallel lines and equal-width white bands. The redesign, at far right, sweeps the noise away, with color spots now smartly tracking the path of averages.

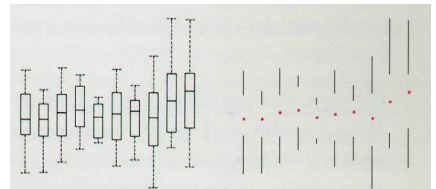
Harmonizing text and line-drawing requires sensitive appraisals of prolific interaction effects. Unless deliberate obscurity is sought, avoid surrounding words by little boxes, which activate negative white spaces

between word and box. And below, the first three maps place the type poorly, with an awkward white stripe materializing between name and river. Type from above adjusts to graphics better, in part because most words have fewer descenders than ascenders (in map 3, a diverting white shape is formed by the ascending letters).⁹ These small local details will promptly accumulate on the entire map surface, deciding quality.

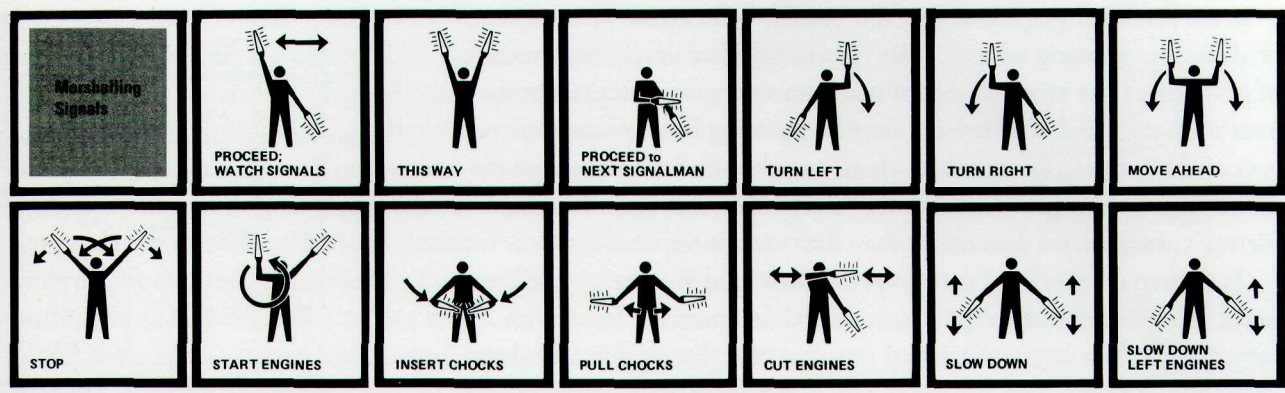


Middle map above, student project by Jon Wertheimer, Studies in Graphic Design, Yale University, 1985-1986.

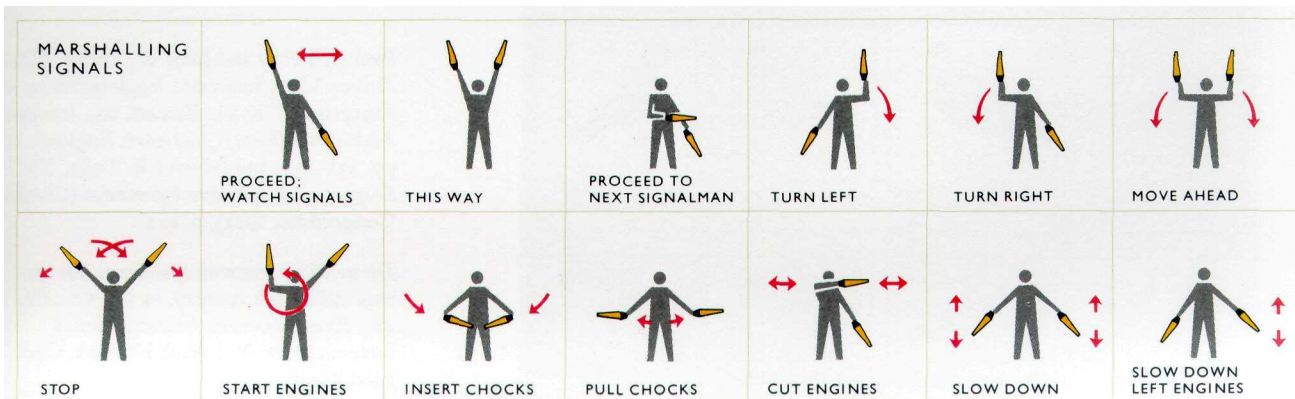

This array above, an information prison, employs a narrow range of strong shapes. Grid, silhouette, and type compete at the same nervous visual level. Too loud and too similar. Thick bars of grid boxes generate little paths around both type and silhouette by exciting the negative white space: 1 + 1 = 3, all over again. Why should the trivial task of dividing up the already free-standing elements become the dominant statement of the entire display?

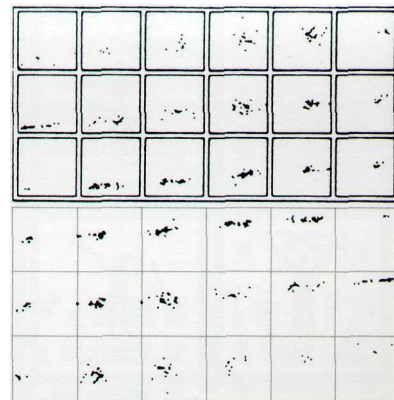
To direct attention toward the information at hand, the revision below extends the light to dark range of color, separating and layering the data in rough proportion to their relevance. Gray calms a contrasty silhouette, bringing about in turn more emphasis on the lamps and their position and motion. Coloring these lights helps to separate the signals from all the rest. Some 460 lamp-whiskers were erased, whiskers which originally read in confusion as glowing light and also trembling motion. Note the effectiveness and elegance of *small spots of intense, saturated color* for carrying information — a design secret of classical cartography¹⁰ and, for that matter, of traffic lights. Finally, in our revised version, the type for the title (upper left corner) has emerged from its foggy closet. Also the labels, now set in Gill Sans, are no longer equal in visual weight to the motion arrows, among several typographical refinements.

In the statistical graphic at top, the visually most active elements are, of all things, glowing optical white dots that appear at each intersection of grid hues. (The arrangement of many computer interfaces is similarly overwrought.) The doubled-up, tremor-inducing lines consume 18 percent of this technically ingenious chart, a multi-window plot. Here the redrawing, in ungrid style, eliminates the visual noise, concentrating our viewer's attention on data rather than data containers.

Too often epidemics of data-imprisonment and decorative gridding break out when contemporary commercial designers are faced with information. The aggressive visual presence of stylized grids, little boxes surrounding words here and there, and cadenced accents—all so empty of content, irrelevant—becomes the only way you can tell if something has been "designed". At any rate, the self-important grid is for the birds, providing only a nice place to perch:

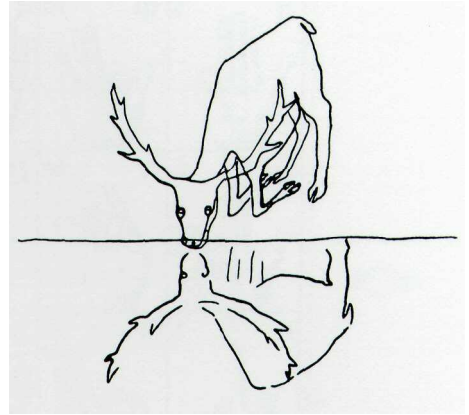

INFORMATION consists of *differences that make a difference*. A fruitful method for the enforcement of such differences is to layer and separate data, much as is done on a high-density map. In representing various layers of meaning and reading, the most economical of means can yield distinctions that make a difference: the small gestures of Calder's pen easily separate the stag and his watery reflection. Failure to differentiate among layers of reading leads to cluttered and incoherent displays filled with disinformation, generated by the unrelenting interactive visual arithmetic of flatland, $1 + 1 = 3$ or more.

All these ideas—figure and ground, interaction effects, $1 + 1 = 3$ or more, layering and separation - have compelling consequences for information displays. Such concepts (operating under an assortment of names) are thoroughly tested, long familiar the world over in the flatlands of typographers, calligraphers, graphic designers, illustrators, artists, and, in three dimensions, architects:



In every clear concept of the nature of vision and in every healthy approach to the spatial world, this dynamic unity of figure and background has been clearly understood. Lao Tse showed such grasp when he said: "A vessel is useful only through its emptiness. It is the space opened in a wall that serves as a window. Thus it is the nonexistent in things which makes them serviceable." Eastern visual culture has a deep understanding of the role of empty space in the image. Chinese and Japanese painters have the admirable courage to leave empty large paths of their picture — surface so that the surface is divided into unequal intervals which, through their spacing, force the eye of the spectator to movements of varying velocity in following up relationships, and thus create the unity by the greatest possible variation of surface. Chinese and Japanese calligraphy also have a sound respect for the white interval. Characters are written in imaginary squares, the blank areas of which are given as much consideration as the graphic units, the strokes. Written or printed communications are living or dead depending upon the organization of their blank spaces. A single character gains clarity and meaning by an orderly relationship of the space background which surrounds it. The greater the variety and distinction among respective background units, the clearer becomes the comprehension of a character as an individual expression or sign.¹¹

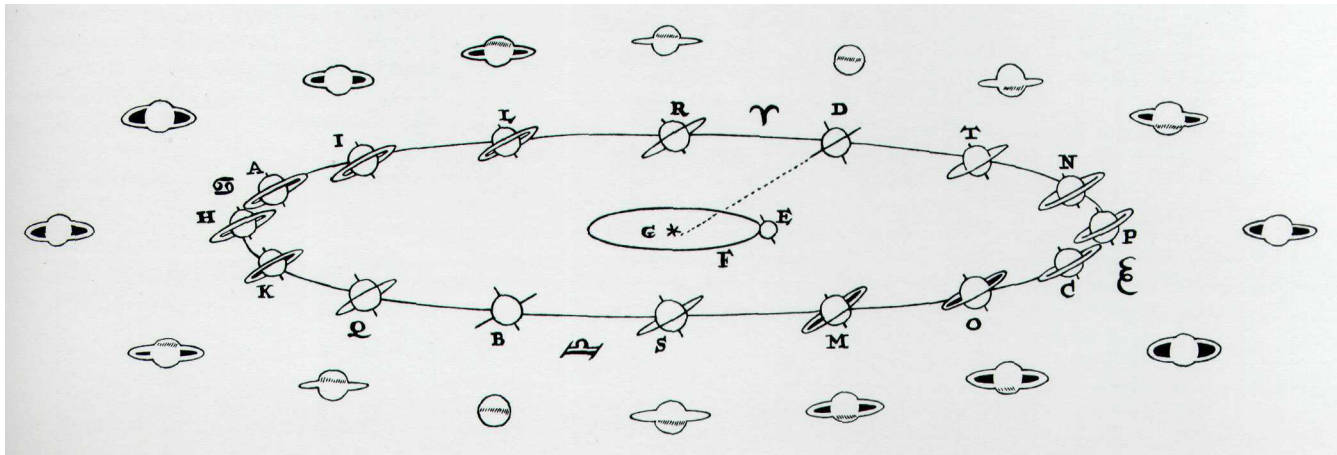

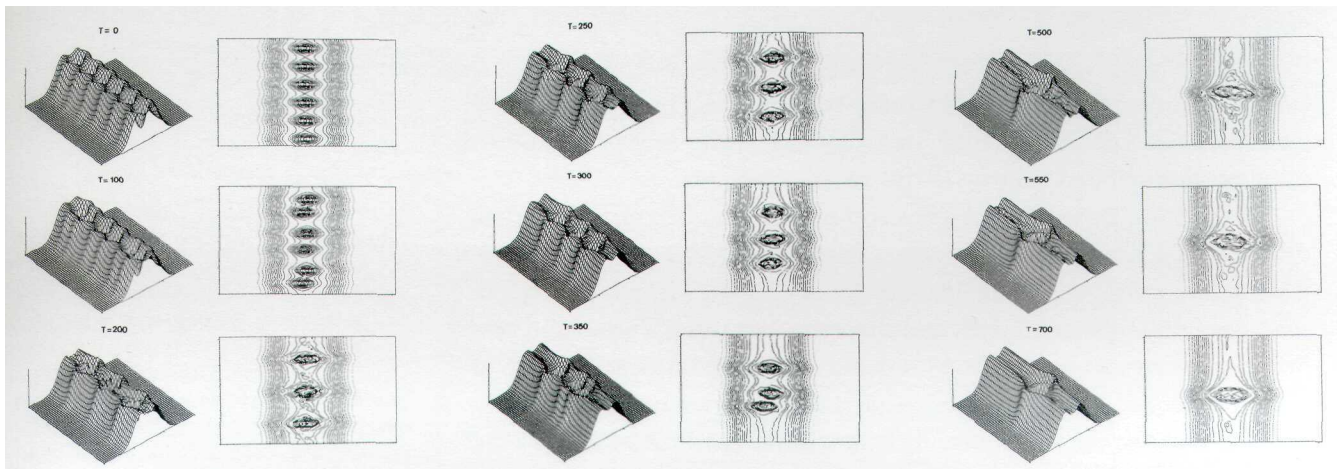
IN this splendid 1659 drawing by Christiaan Huygens, the inner ellipse traces Earth's yearly journey around the Sun; the larger ellipse shows Saturn's orbit, viewed from the heavens. The outermost images depict Saturn as seen through telescopes located on Earth. All told, we have 32 Saturns, at different locations in three-space and from the perspective of two different observers—a superior *small multiple* design.

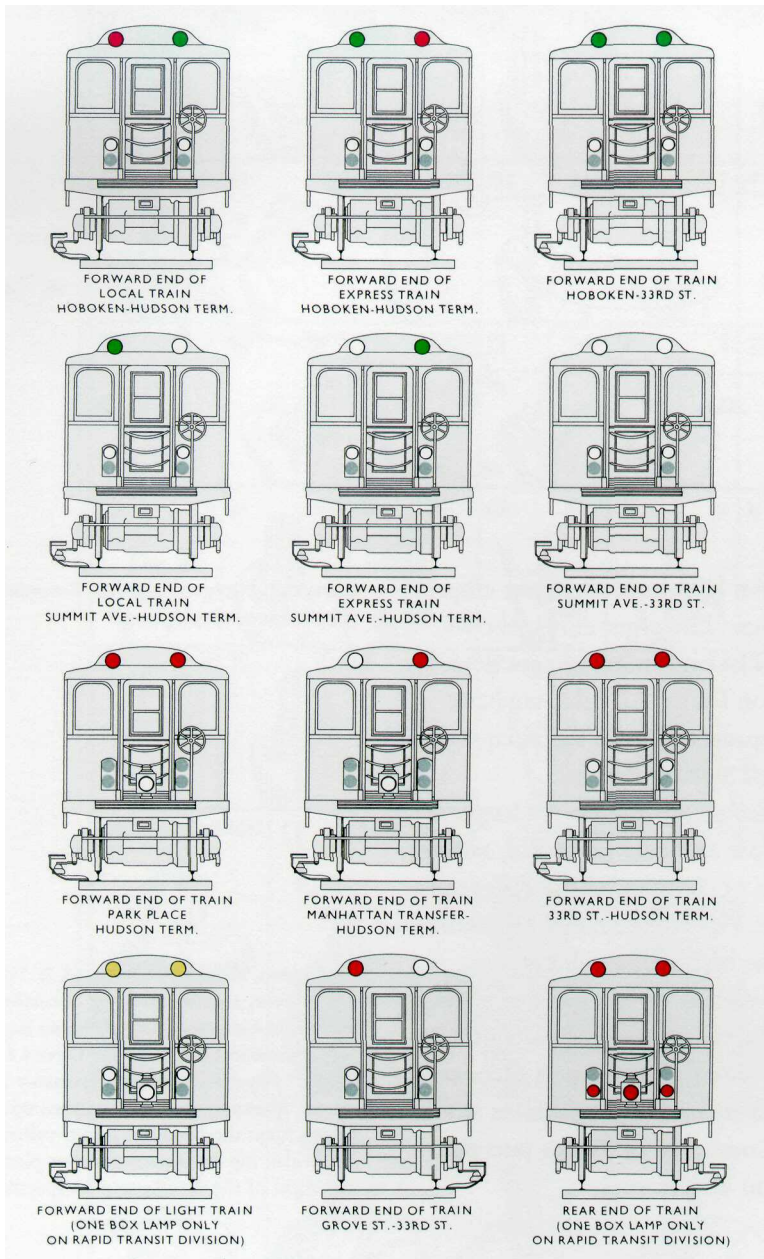

At the heart of quantitative reasoning is a single question: *Compared to what?* Small multiple designs, multivariate and data bountiful, answer directly by visually enforcing comparisons of changes, of the differences among objects, of the scope of alternatives. For a wide range of problems in data presentation, small multiples are the best design solution.

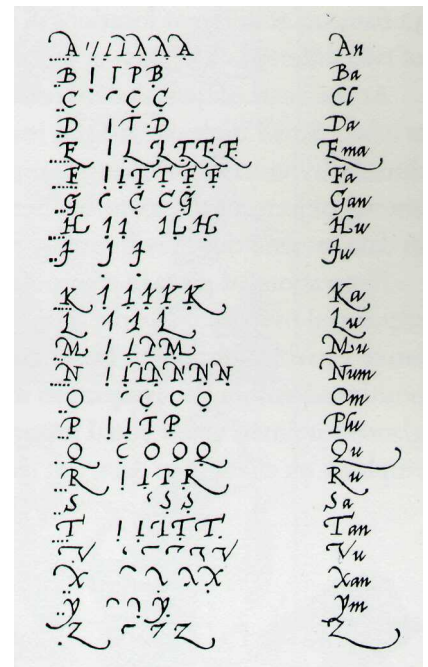
Illustrations of postage-stamp size are indexed by category or a label, sequenced over time like the frames of a movie, or ordered by a quantitative variable not used in the single image itself. Information slices are positioned within the eyespan, so that viewers make comparisons at a glance — uninterrupted visual reasoning. Constancy of design puts the emphasis on changes in data, not changes in data frames.

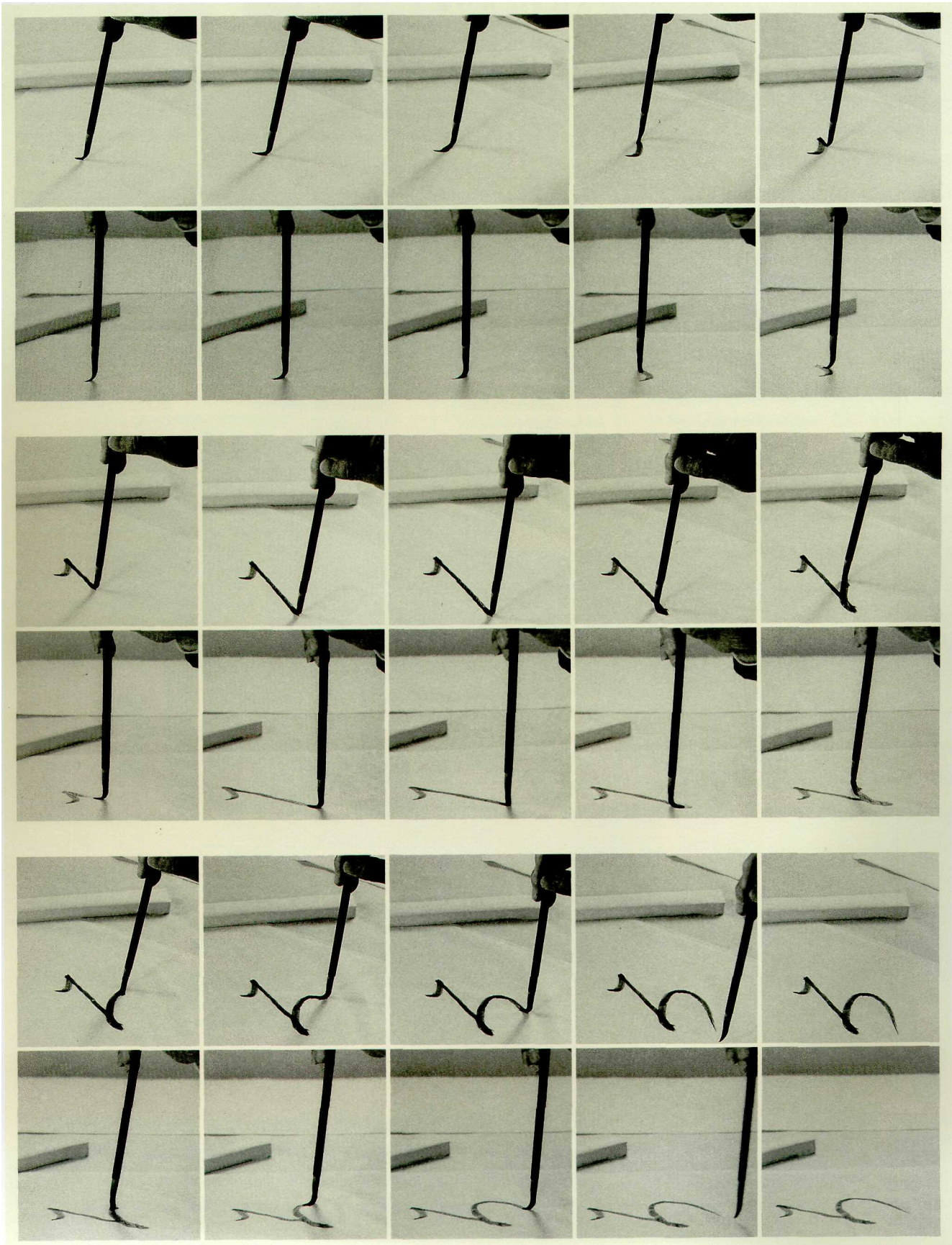

SMALL multiples reveal, all at once, a scope of alternatives, a range of options. Above, varying signal lights on the ends of a train are entailed in a rulebook for railroad employees. Our redrawing mutes the repeated train outline and brings forward differentiating colors.

At far right, these photographs capture pressure, direction, and speed of the calligraphic brush as it draws a single Kana character. Images are indexed by time (→) and by dual camera angle (↑). The paired series of photographs link hand, brush, and character (top row). The second row shows pressure and bend of the brush-tip - and the consequent width of line. The sequence has a magical quality, reflecting a remark of Garry Winogrand, the photographer: "There is nothing as mysterious as a fact clearly described."

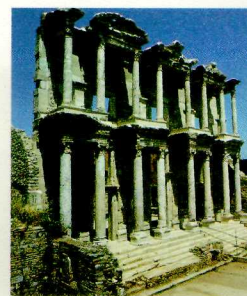


MURAL WITH BLUE BRUSHSTROKE

To make *Mural with Blue Brushstroke*, Lichtenstein drew on sources ranging from the most exalted to the most banal. Classical architecture (2, 14) provided inspiration, as did the site itself (8, where painted windows align with real ones). Homages to twentieth-century masters abound: Léger's people (1), Kelly's color fields (6), Matisse's split philodendron form (9), Arp's silhouettes (10, echoed in a piece of Swiss cheese), De Kooning's brushstrokes (12), Stella's triangles and French curves (15), Johns's flagstones (16), and Braque's balusters (20). Art styles—like Abstract Expressionism (11, 12, and 13, the latter with its “perfect painting”), Cubism (20), and Art Deco (21)—and artist's tools (4, 5, and 15) appear. And bustling around amid all this high culture are images of everyday modern life, those perennial sources of fascination to Lichtenstein: sunbursts (3), copy books (17), advertisements (7), food and drink (10, 18), and, of course, comic strips (19).

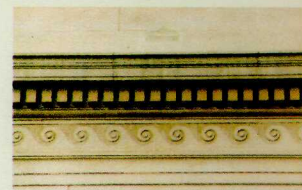

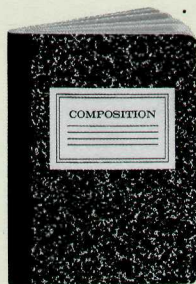

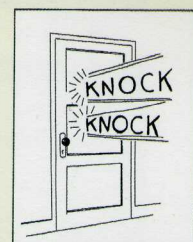

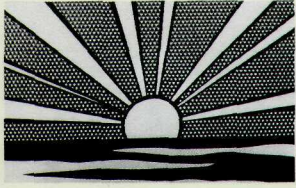

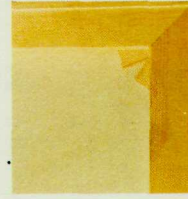

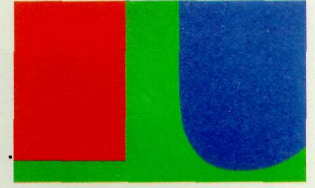

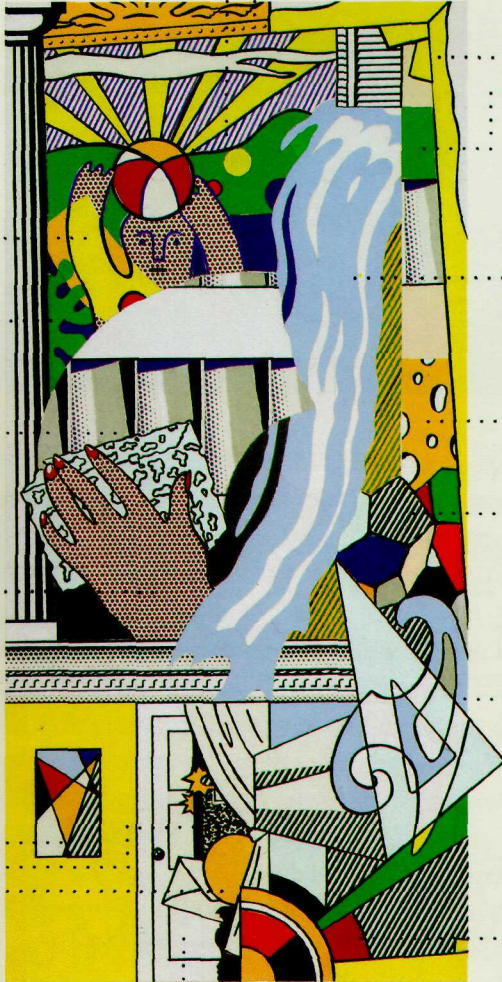

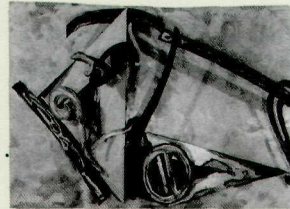

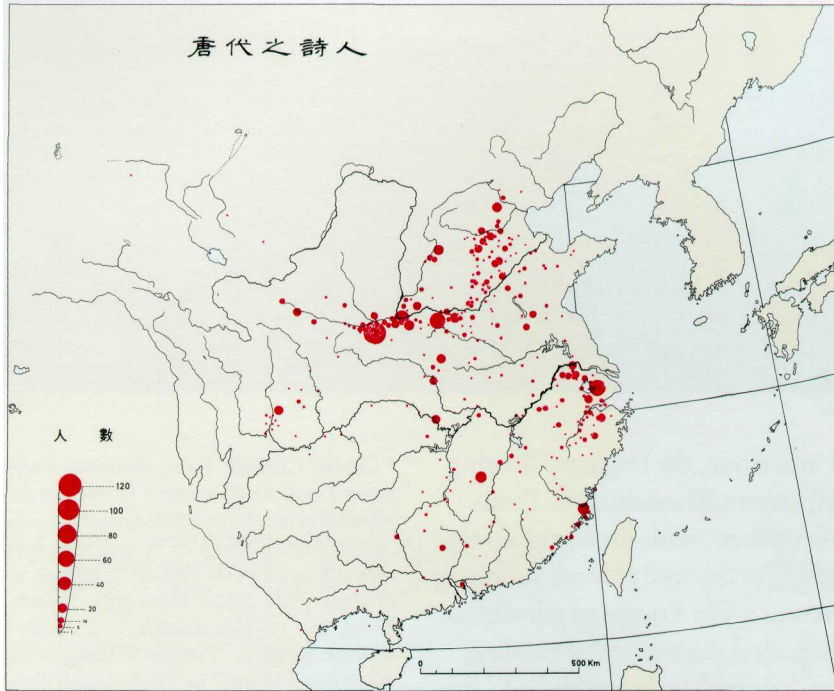
WITH figures and pictographs chipped into stone, the Dighton Writing Rock sits near the Taunton River in southeastern Massachusetts. From 1680 onwards, observers sketched the inscriptions, with divergent results. Same rock, different views, arrayed here in a comparative small multiple. Some of these uncertain drawings, when sent off to European scholars, were then converted into far-reaching historical discoveries of startling visits to the New World. One researcher "triumphantly established" the marks as Scythian; a distinguished Orientalist detected the word *melek* (king) on the rock; others thought they saw Phoenician or Runic script. A Scandinavian antiquary translated the drawings into an account of a pre-Columbian sojourn to America by a party of Thorfinn the Hopeful. Since the writing resembles that on the Indian God Rock hundreds of miles southwest, such logic places the Vikings far inland, deep into what is now West Virginia and Ohio. All this scholarship of wishful thinking denies priority to the original Native-American residents; local experts conclude that the marks are Algonquin.¹

A focused small multiple, below, shows the history of variations in the ghost-like figure, enforcing comparisons over time (the ghosts even could be spaced in proportion to the date they were drawn):

DURING the last 1,260 years in China, where did poets flourish? How many poets? And have their birthplaces changed over the years? Four maps, based on an inherently imperfect historical record, address these prominent questions.

Birthplaces of the 2,625 Tang poets, 618-907

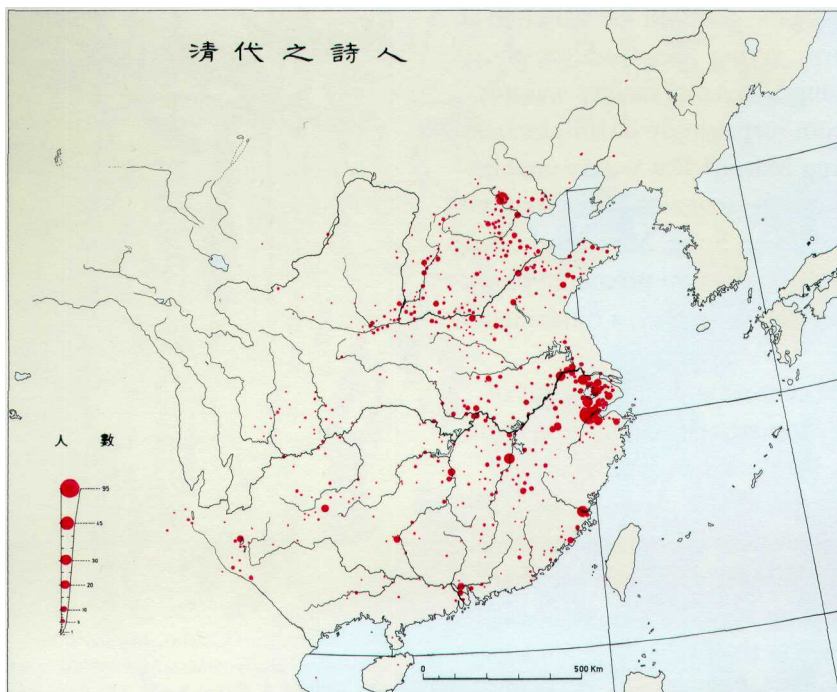


Birthplaces of the 2,377 Sung poets, 969-1279

Shown is the geographic distribution of poets (grand total 10,086) during four dynasties, with their birthplaces shifting through centuries toward southeast China and concentrating—in the case for so much human activity—in a relatively few areas.

And, finally, a map of distribution of temples of Matsu (T'ien Hou), the most famous sea goddess of China. With a sterling reputation for miracles, she receives prayers of fishermen and sailors during stormy weather; and when the sea is as dark as ink, she provides a torch on the top of the mast to guide small boats to safety. In recent times, the story goes, one mother (an alleged descendant of the goddess) left her child at a temple while going to work on the farm, saying "Sea Goddess, please take heed." Matsu's reaction to supervising a day-care facility was not recorded. Our display here, growing from surpassingly incomplete data, marks prefectures with a temple honoring Matsu.² But we are unable to make the long-awaited comparisons among geographic distributions of sea-goddess temples and birthplaces of Tang, Sung, Ming, and Ching poets—because the poets are stranded over on the two preceding pages. *Comparisons must be enforced within the scope of the eyespan*, a fundamental point occasionally forgotten in practice.

The struggle between maintenance of context and enforcement of comparison is reflected in a 19th-century topographic diagram at right. Surveying lengths of the world's rivers, the chart hangs them out, in parallel more or less, while still retaining specifics of place-names, lakes, and river branches. Note the various sequences of lakes, here linearly arranged. Without such detail, this is just another decorated bar chart. Some ardent typography sets oceans rippling at top. The juxtaposed mountains are less successful, too arbitrary in their relocation, and too stylized and lacking the nice local particulars of the rivers.

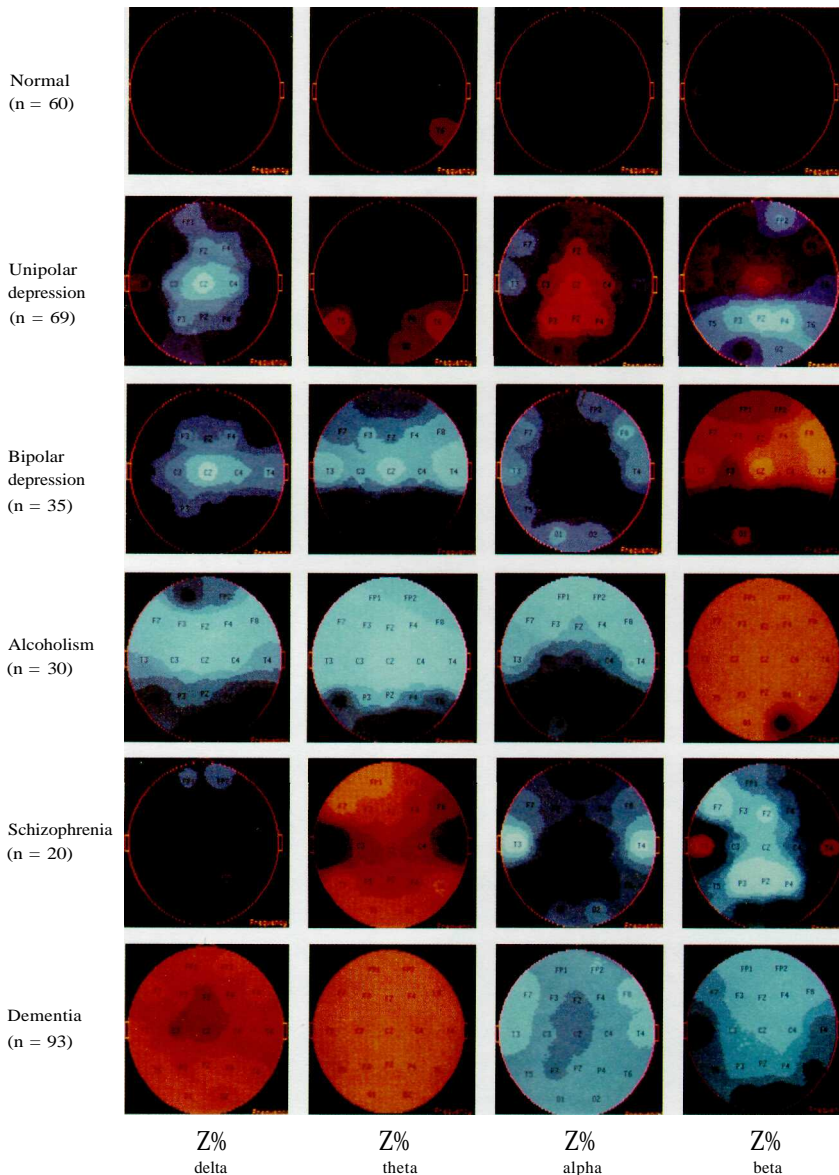
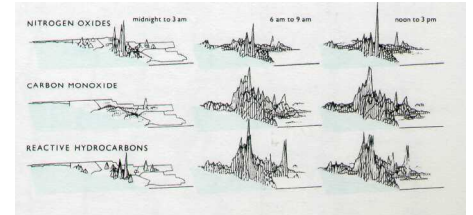

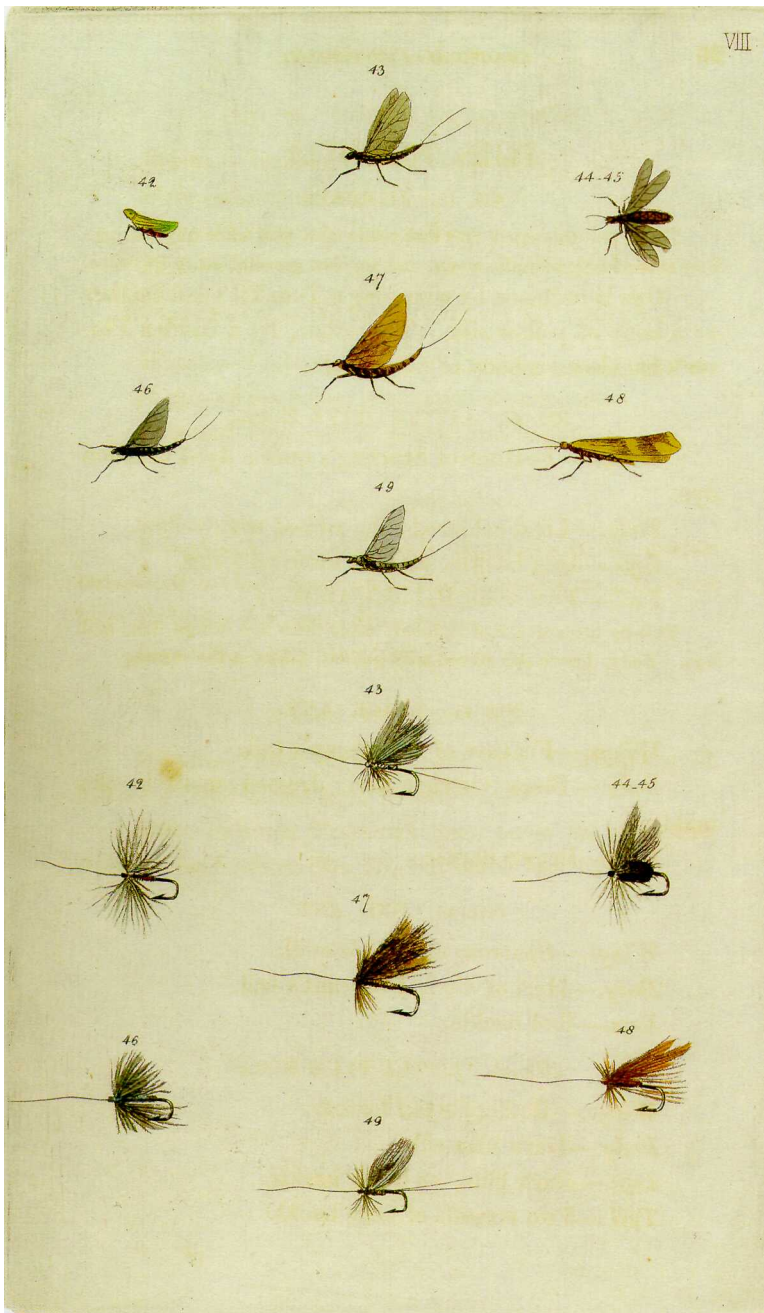

Simultaneous two-dimensional indexing of the multiplied image, flatland within flatland, significantly deepens displays, with little added complication in reading. These neurometric maps record distributions of brain electrical activity, arraying data over a matrix of color images — with frequency bands (delta, theta, alpha, and beta) sorting the columns, and individual diagnosis forming the rows. The contour lines depict only the average differences (normalized z-scores) of the *row group* compared to a healthy reference *group*, and thus do not show overlaps or extreme outlying values of all the *individual* members of each group.³ Graphically, this recursive design resembles the Los Angeles smog chart that we saw in Chapter 1, where maps were themselves spread on two dimensions, type of pollution and time of day.

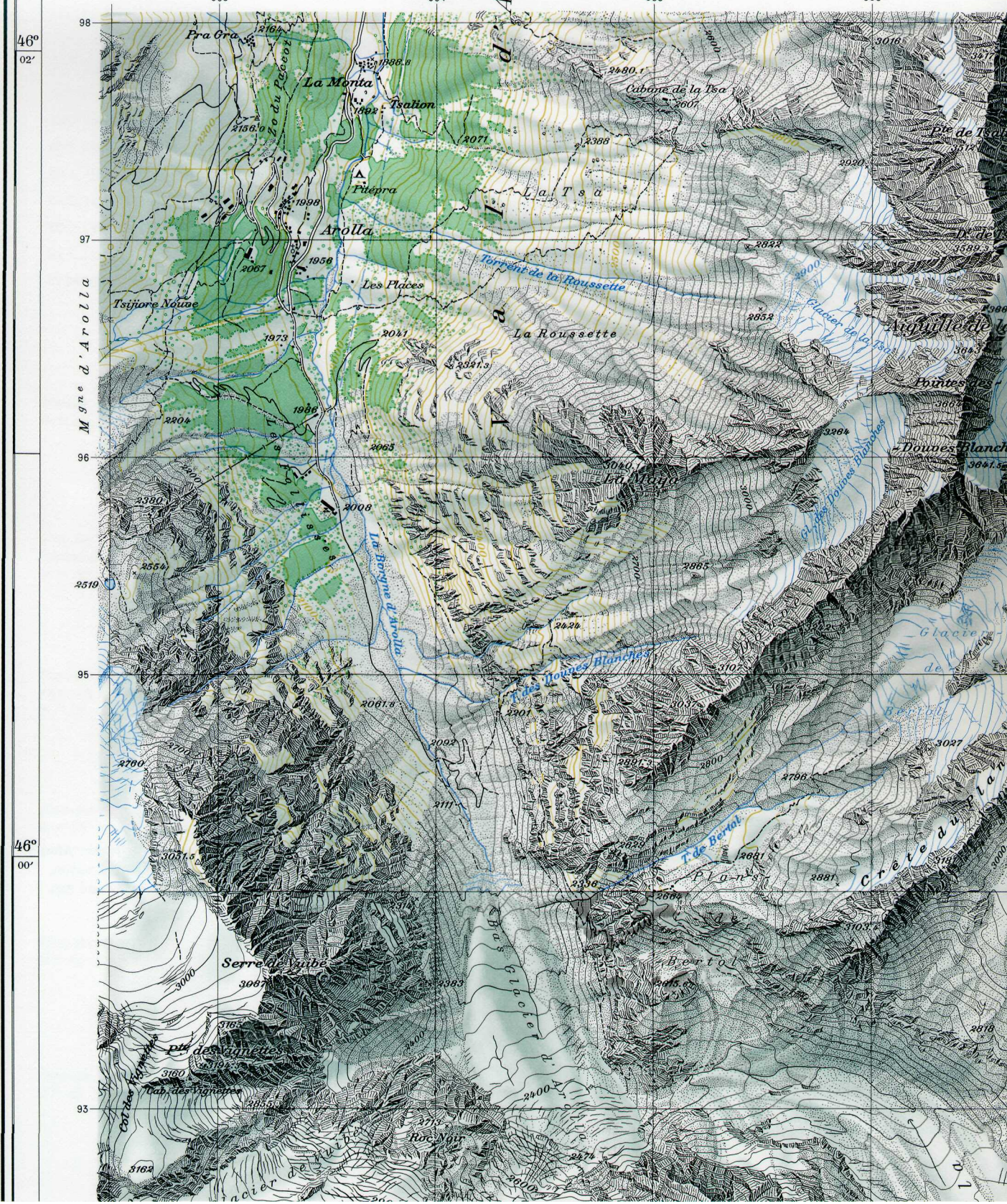

In our neurometric example at left, the dark colors surrounding each image generate disruptive white stripes. Locations can be signaled by nearly silent methods, as above, where an implicit grid pairs each insect with its fly-fishing simulation. And the limited but focused color here is more effective than strong rainbow colors, for reasons now to be revealed.



5 *Color and Information*

IN representing and communicating information, how are we to benefit from color's great dominion? Human eyes are exquisitely sensitive to color variations: a trained colorist can distinguish among 1,000,000 colors at least when tested under contrived conditions of pairwise comparison. Some 20,000 colors are accessible to many viewers, with the constraints for practical applications set by the early limits of human visual memory rather than the capacity to discriminate locally between adjacent tints. For encoding abstract information, however, more than 20 or 30 colors frequently produce not diminishing but negative returns.

Tying color to information is as elementary and straightforward as color technique in art, "To paint well is simply this: to put the right color in the right place," in Paul Klee's ironic prescription.¹ The often scant benefits derived from coloring data indicate that even putting a good color in a good place is a complex matter. Indeed, so difficult and subtle that avoiding catastrophe becomes the first principle in bringing color to information: *Above all, do no harm.*

AT work in this fine Swiss mountain map are the fundamental uses of color in information design: *to label* (color as noun), *to measure* (color as quantity), *to represent or imitate reality* (color as representation), and *to enliven or decorate* (color as beauty). Here color *labels* by distinguishing water from stone and glacier from field, *measures* by indicating altitude with contour and rate of change by darkening, *imitates reality* with river blues and shadow hachures, and visually *enlivens* the topography quite beyond what could be done in black and white alone.

Note the many finely crafted details: changes in the color of contour lines as the background shifts, interplay of light and shadow in areas of glacial activity, and color typography. The black-ink-only area at the bottom, though not an optimized monochrome design, gives a sense of the overwhelming informational benefits of color, when it is at its best.

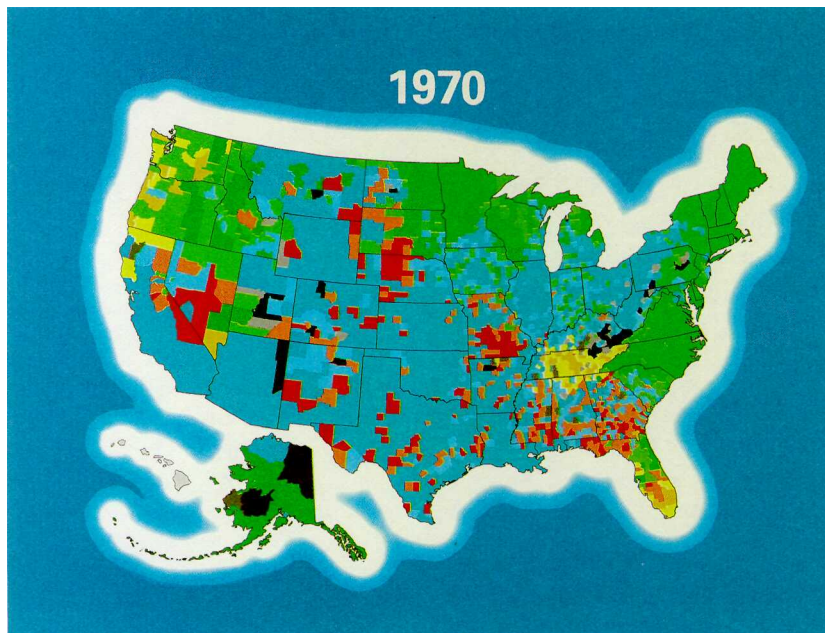

The Swiss maps are excellent because they are *governed by good ideas and executed with superb craft*. Ideas not only guide work, but also help defend our designs (by providing *reasons* for choices) against arbitrary taste preferences. Strategies for how color can serve information are set out in Eduard Imhof's classic *Cartographic Relief Presentation*, which describes the design practices for the Swiss maps. The first two principles seek to minimize color damage:

First rule: Pure, bright or very strong colors have loud, unbearable effects when they stand unrelieved over large areas adjacent to each other, but extraordinary effects can be achieved when they are used sparingly on or between dull background tones. "Noise is not music. Only a piano allows a crescendo and then a forte, and only on a quiet background can a colorful theme be constructed." The organization of the earth's surface facilitates graphic solutions of this type in maps. Extremes of any type - such as highest land zones and deepest sea troughs, temperature maxima and minima - generally enclose small areas only. If one limits strong, heavy, rich, and solid colors to the small areas of extremes, then expressive and beautiful patterns occur. If one gives all, especially large areas, glaring, rich colors, the pictures have brilliant, disordered, confusing and unpleasant effects.

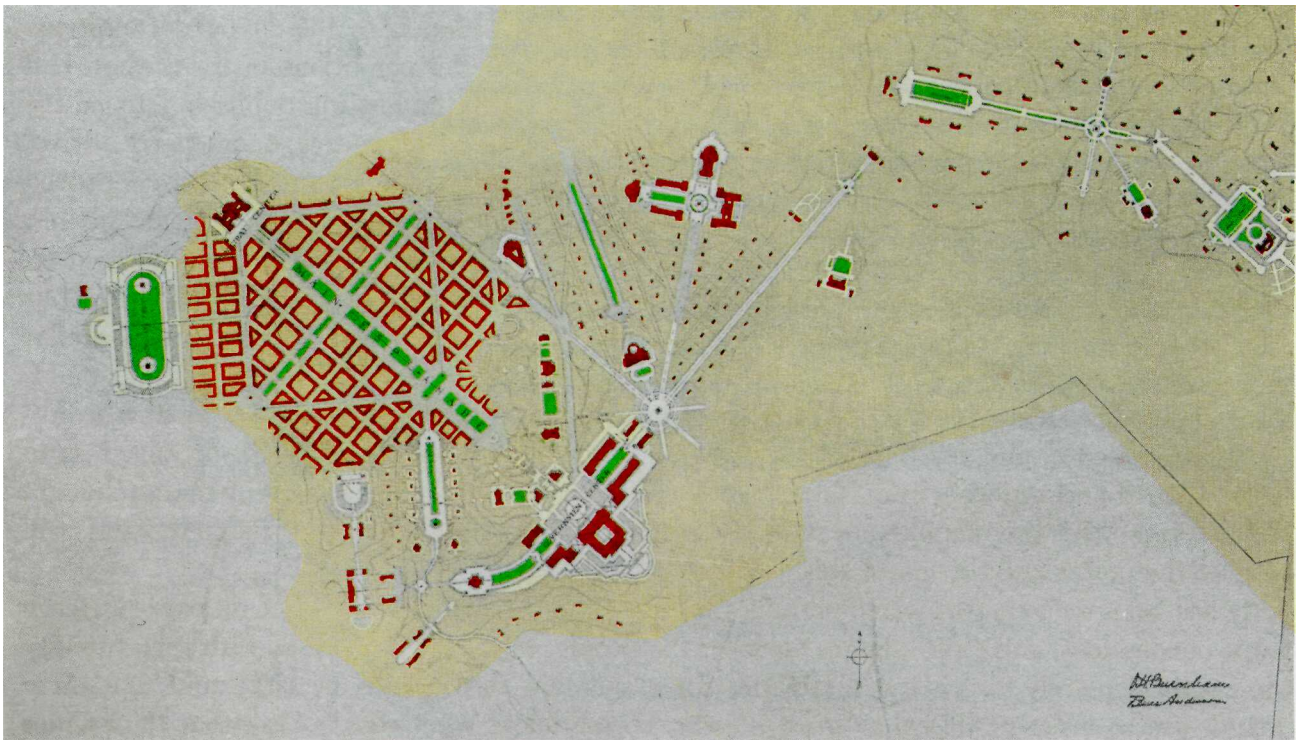
Second rule: The placing of light, bright colors mixed with white next to each other usually produces unpleasant results, especially if the colors are used for large areas.²

Violation of this counsel yields the exuberantly bad example below. All this strong color, especially the surrounding blue, generates a strange puffy white band, making it the map's dominant visual statement, with some alarming shapes at lower left. These colors are dark in value, and inevitably we have significant $1 + 1 = 3$ effects again, at visual war with the heavily encoded information.

Along with its critique of color-clutter, Imhof's first rule contains an important constructive idea: *color spots against a light gray or muted field highlight and italicize data, and also help to weave an overall harmony.* Daniel Burnham's architectural drawing shows the vitality of small color spots on large muted backgrounds: coherent, vivid and textured but without clutter, the right color in the right place. The 1909 *Plan of Chicago* contains several other drawings the equal of that shown here—with skillful color illuminating architectural drawings and maps.

Applying a single mark, a strong but transparent spot, Jan Tschichold labels his rejection of the classical central axis typography and design, in favor of the asymmetric layout at right.

COLOR serves as a label most nobly of all in Oliver Byrne's 1847 edition of Euclid's *Geometry*. This truly visual Euclid discards the letter-coding native to geometry texts. In a proof, each element names itself by consistent shape, color, and orientation; instead of talking about angle DEF, the angle is *shown* — appropriately enough for geometry. Below, we see an orthodox march through the Pythagorean theorem; too much time must be spent puzzling over an alphabetic macaroni of 63 encoded links between diagram and proof. At far right, the visual Pythagoras. Ruari McLean described Byrne's book as "one of the oddest and most beautiful books of the whole [19th] century ... a decided complication of Euclid, but a triumph for Charles Whittingham [the printer]."³ A close look, however, indicates that Byrne's design clarifies the overly indirect and complicated Euclid, at least for certain readers.⁴

THEOREM 27. (Pythagoras' Theorem.)

In any right-angled triangle, the square on the hypotenuse is equal to the sum of the squares on the sides containing the right angle.

Below, instructions for circumscribing a square on a circle, with a typically roundabout Euclidean proof verifying that  really is square. Byrne's colors keep in mind the knowledge to be communicated, color for information. Use of the primary colors and black provides maximum differentiation (no four colors differ more). This yellow, broken with orange, is darkened in value, sharpening the definition of its edge against white paper; and the blue is relatively light (on a value scale of blues), reinforcing its distance from black. In the diagrams, the least-used color is black, and it is carefully avoided for large, solid elements—adding to the overall coherence of the proofs by muting unnecessary contrasts. Spacious leading of type assists integration of text and figure, and also unifies the page by creating *lines* of type (instead of the solid masses usually formed by bodies of straight text) similar in visual presence to the geometric lines and shapes.

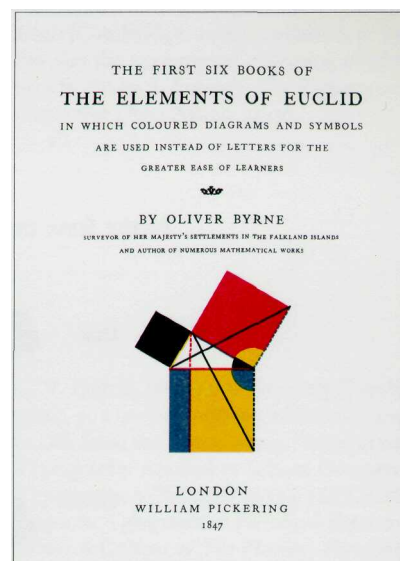

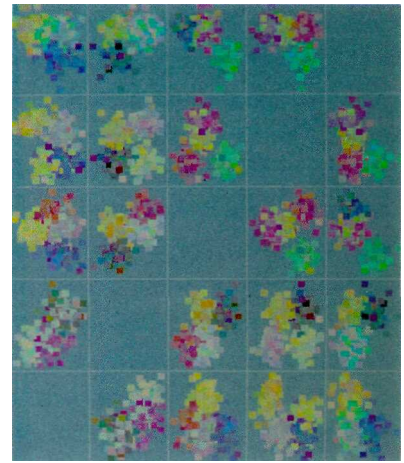

IN all 50 or so systems of color organization, every color is located in three space: described by *hue, saturation, and value* in Munsell and other spatial-perceptual classifications; by *red, green, and blue* components in various additive methods for video displays; and by *cyan, magenta, and yellow* components in subtractive methods for printing inks. A variety of color systems, but always three dimensions.

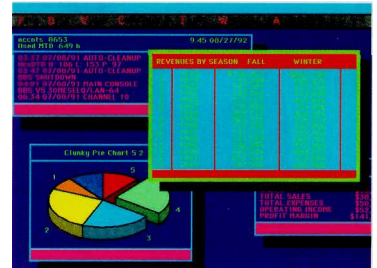
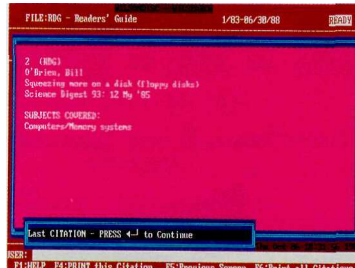
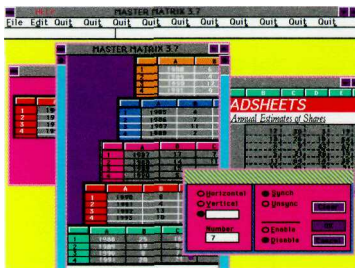
Can color's inherently multidimensional quality be used to express multidimensional information? And can viewers understand, or learn to understand, such displays? A good place to start on a video display terminal is to spread data-points over flatland for two dimensions and then light up each point by red, green, and blue (RGB) components,

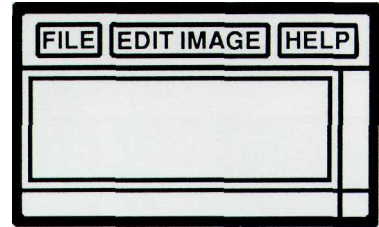
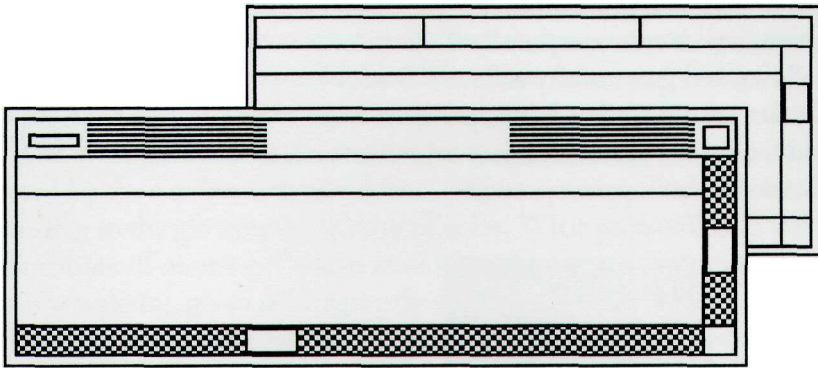

in proportion to values taken by three additional variables. At right, a five-by-five scatterplot matrix shows all X-Y pairs. Note color clusters of data, assemblies of three-dimensional similarity (on RGB variables) spread on the X-Y plane, an obvious improvement over black-only dots.

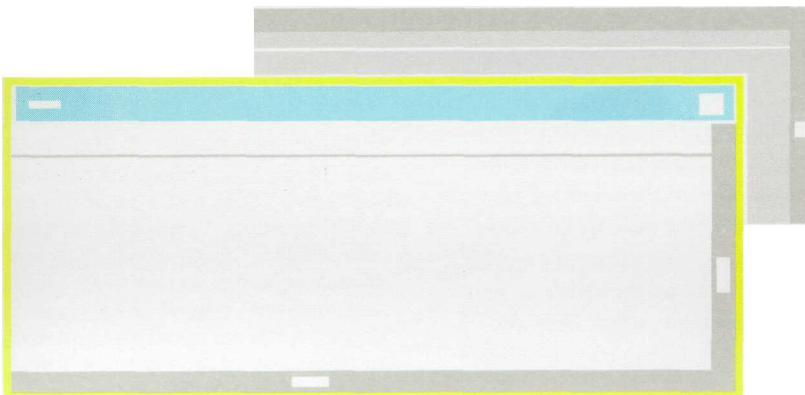
Color's multidimensionality can also enliven and inform what users must face at computer terminals, although some color applied to display screens has made what should be a straight-forward tool into something that looks like a grim parody of a video game:





Shown above are conventional graphical interfaces, with scroll bars, multiple windows, and computer administrative debris. Closely-spaced, dark grid lines generate $1 + 1 = 3$ clutter, with noise growing from the overscan borders (the surrounding dead area of a video tube). Noise is costly, since computer displays are low-resolution devices, working at extremely thin data densities, $1/10$ to $1/1000$ of a map or book page. This reflects the essential dilemma of a computer display: at every screen are two powerful information-processing capabilities, human and computer. Yet all communication between the two must pass through the low-resolution, narrow-band video display terminal, which chokes off fast, precise, and complex communication.

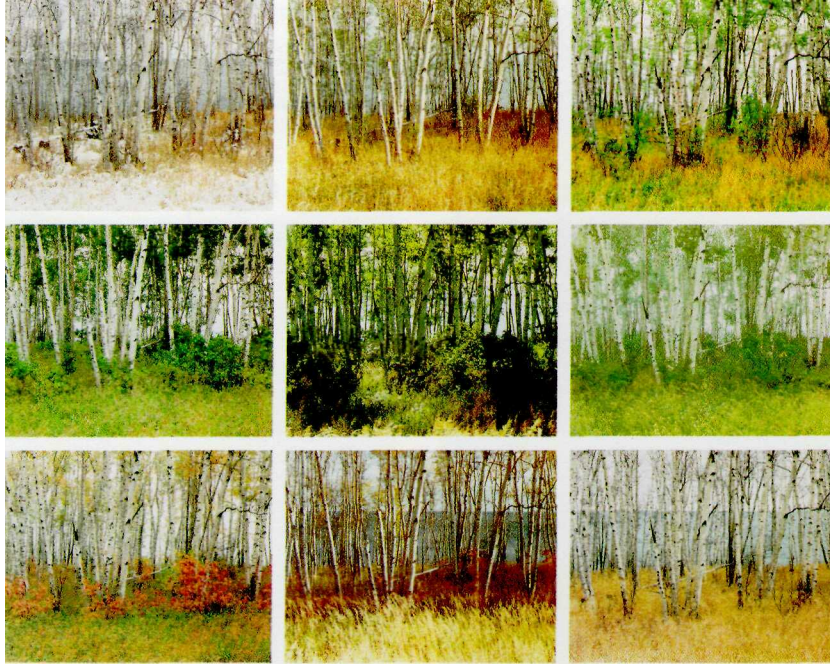
Color can improve the information resolution of a computer screen.⁶ First, by softening the bright-white background, color calms video glare, the effect of staring at a light bulb. Below, color defines edges and allows a simple and elegant *de-gridded* design. For framing fields, the appropriate color should be *light in value* (muting $1 + 1 = 3$ effects), and, at the same time, relatively *intense and saturated* (to give a strong visual signal for an active window). Yellow is the only color that satisfies this joint requirement. Thus a two-dimensional display task is handled by two visual dimensions of a single color:

WHAT palette of colors should we choose to represent and illuminate information? A grand strategy is to *use colors found in nature*, especially those on the lighter side, such as blues, yellows, and grays of sky and shadow. Nature's colors are familiar and coherent, possessing a widely accepted harmony to the human eye — and their source has a certain definitive authority. A palette of nature's colors helps suppress produc-

tion of garish and content-empty colorjunk. Local emphasis for data is then given by means of spot highlights of strong color woven through the serene background. Eduard Imhof develops this theme, with his characteristic mix of cartographic science and art:

Third rule: Large area background or base-colors should do their work most quietly, allowing the smaller, bright areas to stand out most vividly, if the former are muted, grayish or neutral. For this very good reason, *gray* is regarded in painting to be one of the prettiest, most important and most versatile of colors. Strongly muted colors, mixed with gray, provide the best background for the colored theme. This philosophy applies equally to map design.

Fourth rule: If a picture is composed of two or more large, enclosed areas in different colors, then the picture falls apart. Unity will be maintained, however, if the colors of one area are repeatedly intermingled in the other, if the colors are interwoven carpet-fashion throughout the other. All colors of the main theme should be scattered like islands in the background color. The complex nature of the earth's surface leads to enclosed colored areas, all over maps. They are the islands in the sea, the lakes on continents, they are lowlands, highlands, etc., which often also appear in thematic maps, and provide a desirable amount of disaggregation, interpretation and reiteration within the image.⁷

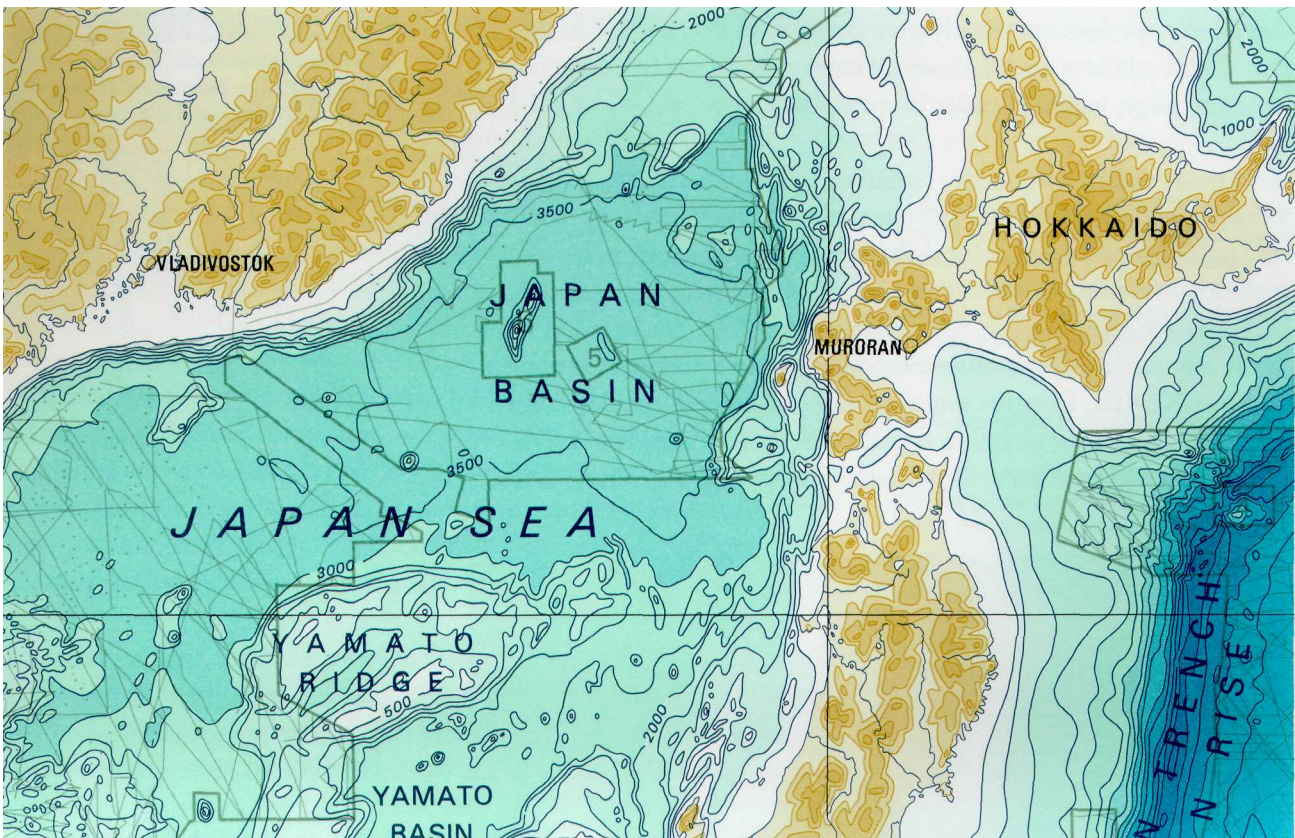
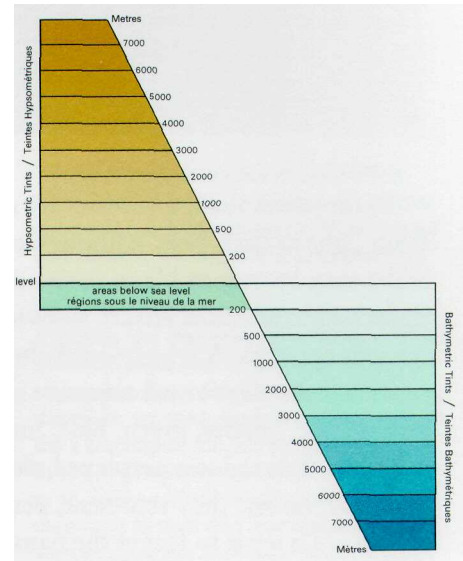

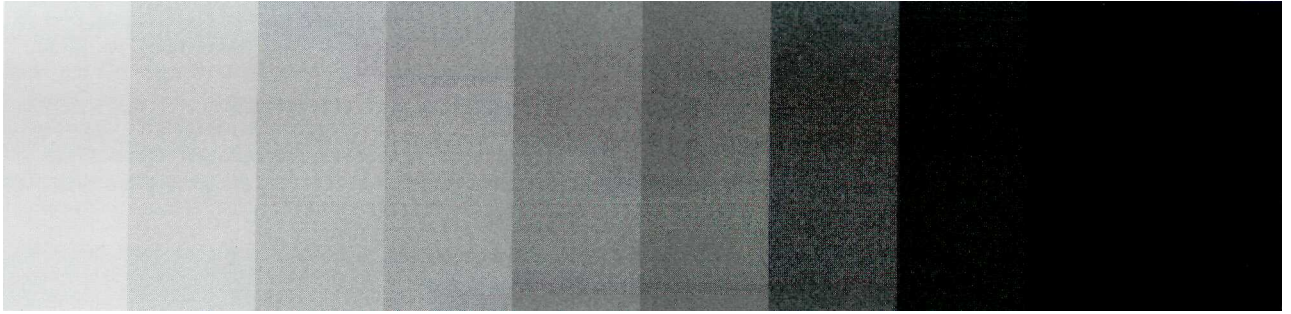
Of course color brings to information more than just codes naming visual nouns—color is a natural quantifier, with a perceptually continuous (in value and saturation) span of incredible fineness of distinction, at a precision comparable to most measurement. For data then as for art: "And what tremendous possibilities for the variation of meaning are offered by the combination of colors... What variations from the smallest shading to the glowing symphony of color. What perspectives in the dimension of meaning!" wrote Paul Klee.⁸ In practice everything is not this wonderful, given the frequently uneasy translations from number to corresponding color and thence to human readings and interpretations.

Shown are the great ocean trenches of the western Pacific and Japan Sea. Numbered contours outline color fields, improving accuracy of reading. Nearly transparent gray tracks, on a visual plane apart from the bathymetric tints, trace paths of sounding lines (outside those areas of extremely detailed surveys, such as ports and along coast lines). Every color mark on this map signals four variables: latitude, longitude, sea or land, and depth or altitude measured in meters.

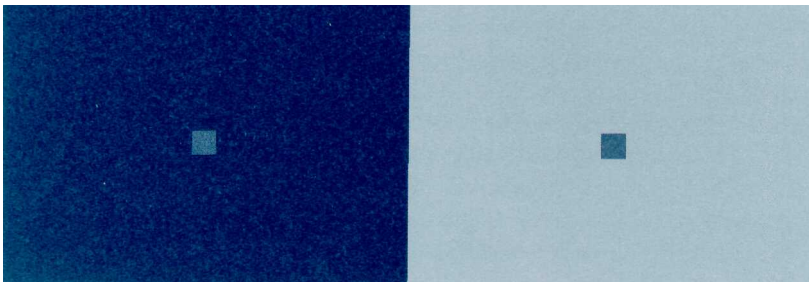


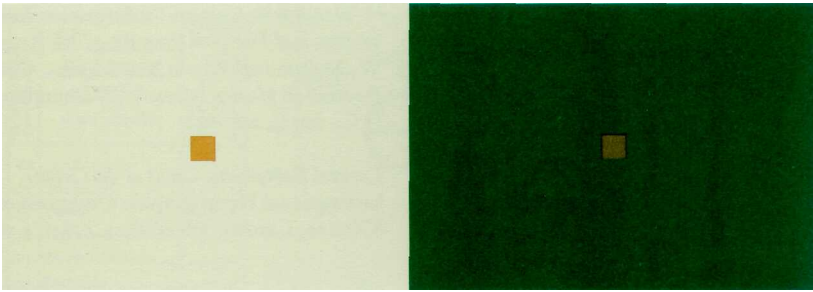


In the ocean map, quantities are shown by a *value* scale, progressing from light to dark blue. Although easy to learn and remember, value scales may be vulnerable to the inaccuracies of reading provoked by disturbing contextual effects, shown above, of edge fluting and simultaneous contrast. A widely-used alternative is a scale of rainbow colors, replacing the clear visual sequence of light to dark with the disorderly red, orange, yellow, green, blue, indigo, and violet — an encoding that now and then reduces perplexed viewers to mumbling color names and the numbers they represent, perversely contrary to Paul Valery's axiom, "To see is to forget the name of the thing one sees." Despite our experiences with the spectrum in science textbooks and rainbows, the mind's eye does not readily give an order to ROYGBIV.⁹ In the face of this rainbow encipherment, viewers must turn to other cues (contour, edge, labels) in order to see and interpret data.

ANY color coding of quantity (whether based on variations in hue, value, or saturation) is potentially sensitive to interactive contextual effects. These perceived color shifts, while an infrequent threat to accuracy of reading in day-to-day information design, are surprising and vivid—suggesting that color differences should not be relied upon as the sole method for sending a message amidst a mosaic of complex and variable data. Here the same color (in the central squares) looks quite different when placed in slightly different circumstances. The small squares are shifted so as to match the opposite surround — a fine

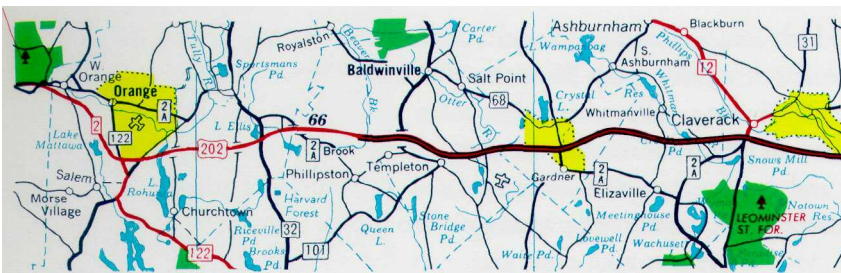




visual touch. Perhaps even more stunning are arrangements of color fields that make two different colors look alike. Albers describes this as a *subtraction* of color: "Repeated ... experiments with adjacent colors will show that any ground subtracts its own hue from colors which it carries and therefore influences."¹⁰ How different the colors of the small squares above look against a uniform white field:



Can these interactions of color *benefit* information displays? Not often, but, in this conventional road map, the perceived visual palette used for labels is extended, without the expense of printing an additional flat color. The thin red line (smaller roads) changes to a deeper red when flanked by parallel blue stripes in the code for larger roads.



Color itself is subtle and exacting. And, furthermore, the process of translating perceived color marks on paper into quantitative data residing in the viewer's mind is beset by uncertainties and complexities.¹¹ These translations are nonlinear (thus gamma curves), often noisy and idiosyncratic, with plenty of differences in perception found among viewers (including several percent who are color-deficient).^{12,13}

MULTIPLE signals will help escape from the swamp of perceptual shifts and other ambiguities in reading. Redundant and partially overlapping methods of data representation can yield a sturdy design, responding in one way or another to potential visual complications—with, however, a resulting danger of fussy, cluttered, insecure, committee-style design. A crystalline, lucid redundancy will do.

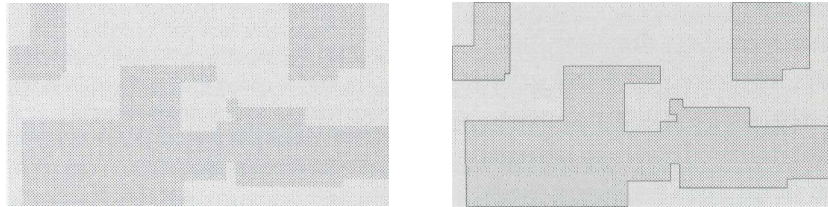

Transparent and effective deployment of redundant signals requires, first, the *need*—an ambiguity or confusion in seeing a data display that can in fact be diminished by multiplicity—and, second, the *appropriate choice of design technique* (from among all the various methods of signal reinforcement) that will work to minimize the ambiguity of reading.¹⁴ Disregard of these conspicuous distinctions will propagate a gratuitous multiplicity. Several examples, illustrating mutual interplay of color and contour, give our verbal pronouncements a visual reality.

The ocean map exemplifies a sensitive multiplicity: the color fields which encode depth are in turn delineated by contours labeled with depth measurements. These lines eliminate edge fluting and make each field a more coherent whole, minimizing within-field visual variation and maximizing between-field differences. Edge lines allow very fine value distinctions, increasing scale precision. Between fields, only the *presence* of an edge is needed, a *thin* line of a color not too distant in



value from the scale itself (at left, 3% and 7% screen tints for ground and for building; at right, exactly the same tints with edges). Note the dramatic effect of the contour here, visually shifting color within the outlined form, sharply distinguishing the building from the surrounding ground. This technique of cartography and graphic design is confirmed by theories of vision, which point out that human cognitive processing

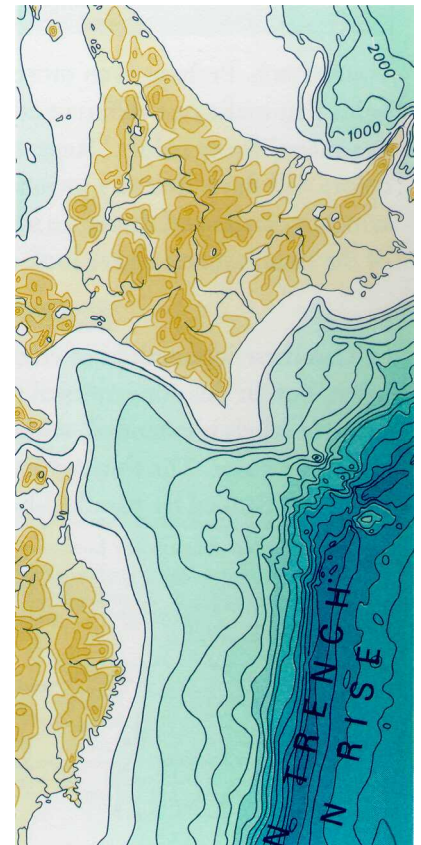
gives considerable and often decisive weight to contour information.¹⁵

In this map, the color merely delineates what is already obvious. Laid down in broad unrefined bands, the strong colors induce a loss of focus of detail on the entire map, making it something to be read only at poster distance. So much visual excitement, so little data, merely to outline a shape

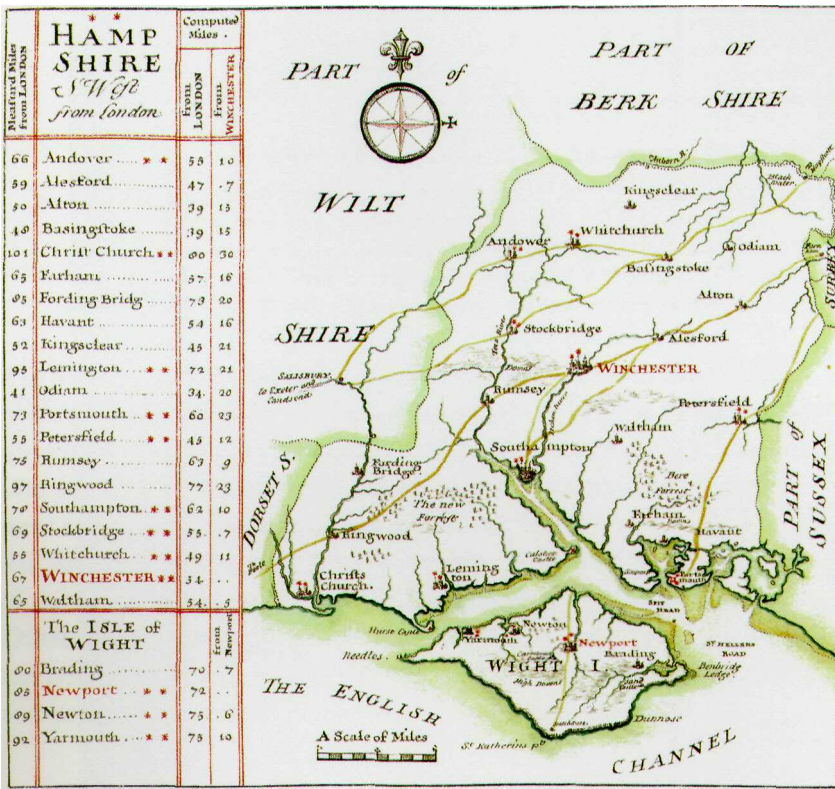

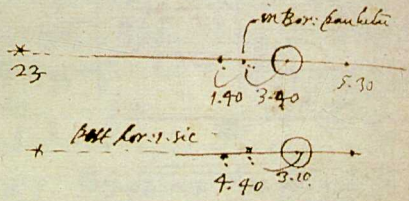
already familiar to most viewers of the map. Boundary lines should be drawn so as to show clearly what falls on which side, essential details lost here in color cross-hatching. The color misses the point.

The map at left is an unsuccessful imitation of the beautiful original above, translucently aglow with delicate light. Outer areas are given less emphasis, with color gently defining roads, boundaries, and cities. City symbols are marked by red stars indicating how many members each place sent to Parliament in 1724. At any rate, a clear statement about geography, rather than a statement about color.

"ALL things are always on the move simultaneously," as Winston Churchill once described military strategy. So it is also for design and color; even simple visual effects can involve a simultaneous complexity of design issues. For this Japanese textile pattern, white dots produce a slight *contextual color shift* nearby, as in the Albers examples of color interactions. Surrounding the dots and the narrow band of shifted color are *cognitive contours*. And these contours in turn produce a *homogeneous edged field*, a result we have seen both in the ocean map and in the gray tints of the building planviews.

6 Narratives of Space and Time

MANY information displays report on the world's workaday reality of three-space and time. Painting four-variable narrations of space-time onto flatland combines two familiar designs, the map and the time-series. Our strategy for understanding these narrative graphics is to hold constant the underlying information and then to watch how various designs and designers cope with the common data. Examined first are accounts of the motion of Jupiter's satellites, beginning with Galileo's notebooks. Other case studies in our space-time tour are itinerary design (schedules and route maps) and, finally, various notational systems for describing and preserving dance movements.

The Galilean Satellites of Jupiter

On the evening of January 7, 1610, Galileo first turned his new telescope toward Jupiter and saw three small, bright starlets near the planetary disk. His book, *The Starry Messenger*, records the series of observations.¹

Though I believed them to belong to the host of fixed stars, they somewhat aroused my curiosity by their appearing to lie in an exact straight line parallel to the ecliptic, and by their being more splendid than other stars their size. Their arrangement with respect to Jupiter and to each other was as follows:



That is, there were two stars on the easterly side and one to the west; the more easterly star and the western one looked larger than the other. I paid no attention to the separations between them from Jupiter, since at the outset I thought them to be fixed stars, as said before.

But either Jupiter or the starlets or both were moving, for next evening a different arrangement appeared. The three starlets were now all west of Jupiter, closer together than before, about equally spaced:

At this time I did not yet turn my attention to the manner in which the starlets had gathered together, but I did begin to concern myself with the question how Jupiter could be east of all these stars when on the previous night it had been west of two of them. I commenced to wonder whether Jupiter might not be moving eastward at this time, contrary to the computations of astronomers, and had gone in front of them by that motion.

Galileo awaited the next night with great interest, but clouds blocked his view. Then on January 10, 1610 he did see Jupiter and was able to separate out motion of planet from that of the starlets, a sequence of observation and logic adding up to one of the most important scientific discoveries ever made:

On the tenth of January, however, the stars appeared in this position with respect to Jupiter:



That is, there were but two of them, both easterly, the third (as I supposed) being hidden behind Jupiter. As at the beginning, they were in the same straight line with Jupiter and arranged exactly in the line of the zodiac. Noticing this, and knowing that there was no way in which such alterations could be attributed to Jupiter's motion [alone], yet being certain that these were still the same stars I had observed [before] — in fact, no other star was to be found along the line of the zodiac for a long distance on either side of Jupiter — my perplexity was now turned into amazement. Certain that the apparent changes belonged not to Jupiter but to the observed stars, I resolved to pursue this investigation with greater care . . .

I decided beyond all doubt that there existed in the heavens three stars wandering about Jupiter as do Venus and Mercury about the sun, and this became plainer than daylight from observations on occasions that followed. Nor were there just three such stars [as I was soon to learn]; four planets do complete their revolutions around Jupiter, and I shall give a description of their alterations as observed more precisely



later on. Also I measured the distances between them by means of the telescope, using the method explained earlier. Moreover, I recorded times of observations, especially when more than one was made on the same night; for the revolutions of these planets are so swiftly completed that it is usually possible to note even their hourly changes.²

Continued observation soon established that four satellites revolved around Jupiter. Longer time-series, flickering with discontinuities, were plotted by Galileo in 1613 and Cassini in 1668. Satellite motion could be forecast precisely enough to serve as a worldwide signaling clock for determining longitude (since 24 hours corresponds to 360°). Data were entabled — even gridlocked—in ephemerides such as this 1766 *Connaissance des Temps* issued by the Bureau des Longitudes in Paris.

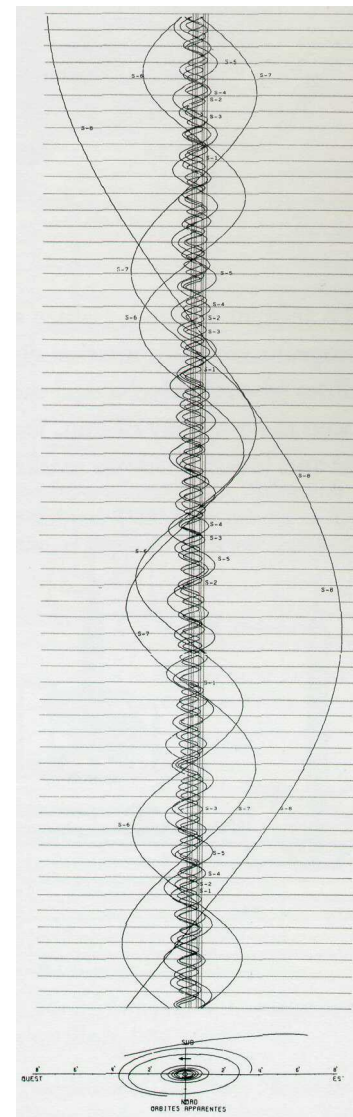
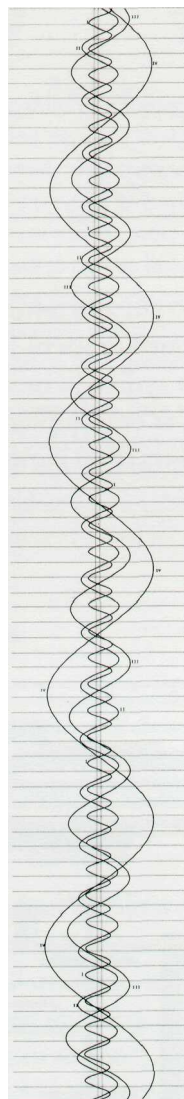
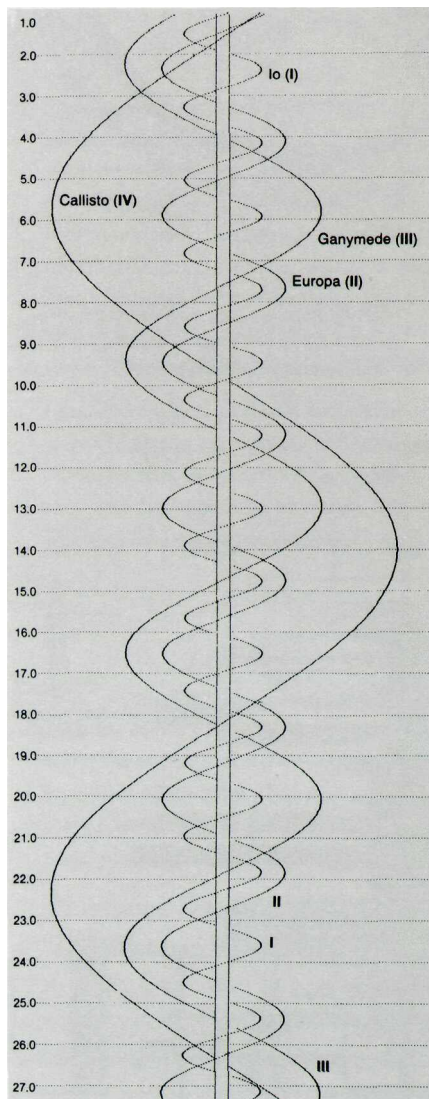
To animate flatland, Galileo and then others constructed Jovilabes, nomogram-like computation devices that recounted orbits of Jupiter's satellites (above). Mechanical models of the solar system in motion showed the interplay of Sun, Earth, and Jupiter, as our shifting vantage point and Jovian shadows masked Galilean satellites from Earth view.

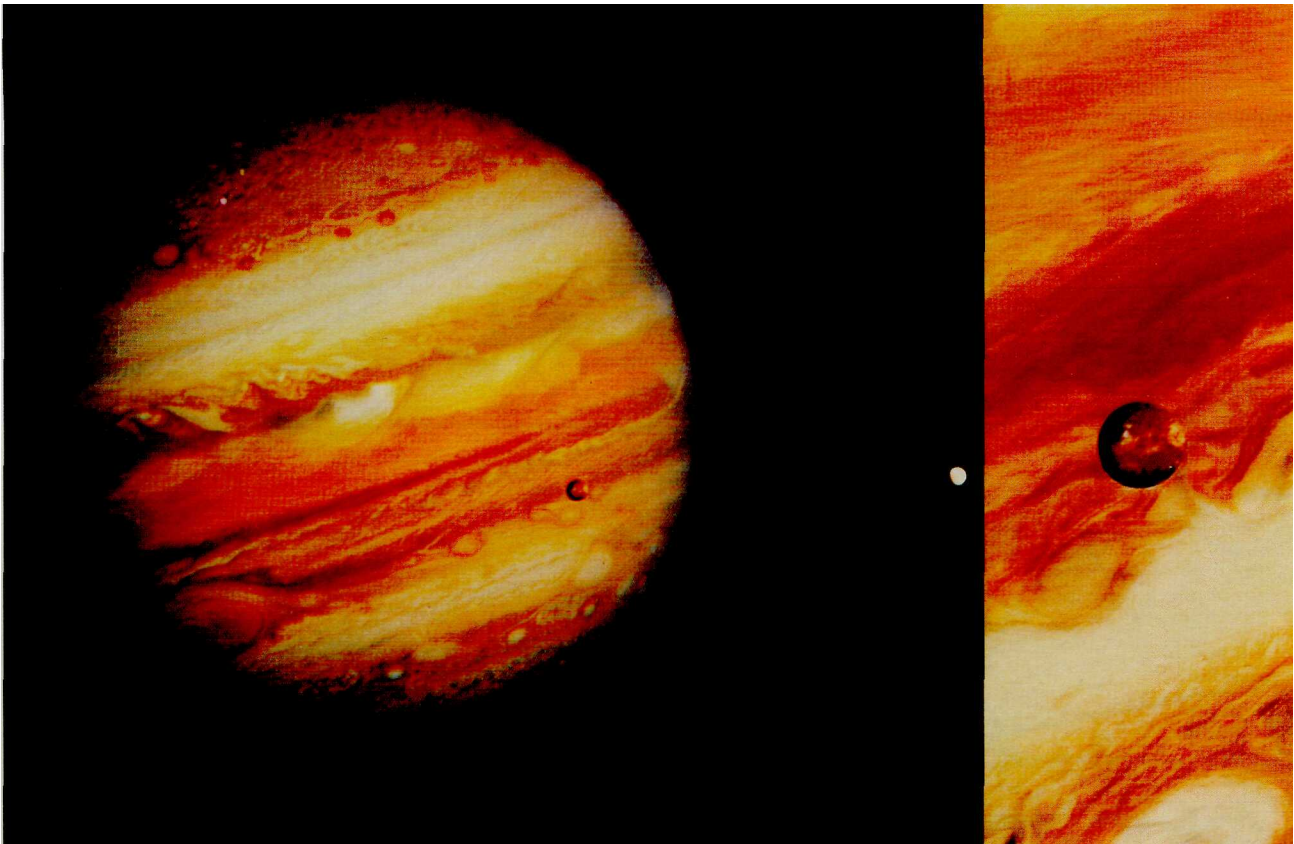

Now, in modern portrayals of Jupiter's satellites, all the individual observations are connected in the corkscrew diagram, with continuous spirals traced out by Io, Europa, Ganymede, and Callisto. These micro/macro diagrams work on a grid of one spatial dimension stretched by time, just like graphical timetables. In our redrawings, the flickering prison bars of the horizontal slices are muted, thus avoiding the clutter of $1 + 1 = 3$ effects. It was not until the 20th-century, 300 years after Galileo's discovery, that the dots were linked into continuous curves—an advance in design that came slowly despite the intellectual skills of the astronomers involved. The smooth trajectories of the modern diagram report *every* position of the moons - fitting data for even a few hours of viewing, because of the rapid journeys of the inner satellites. At right is a similar chart for Saturn, including an orbital planview.

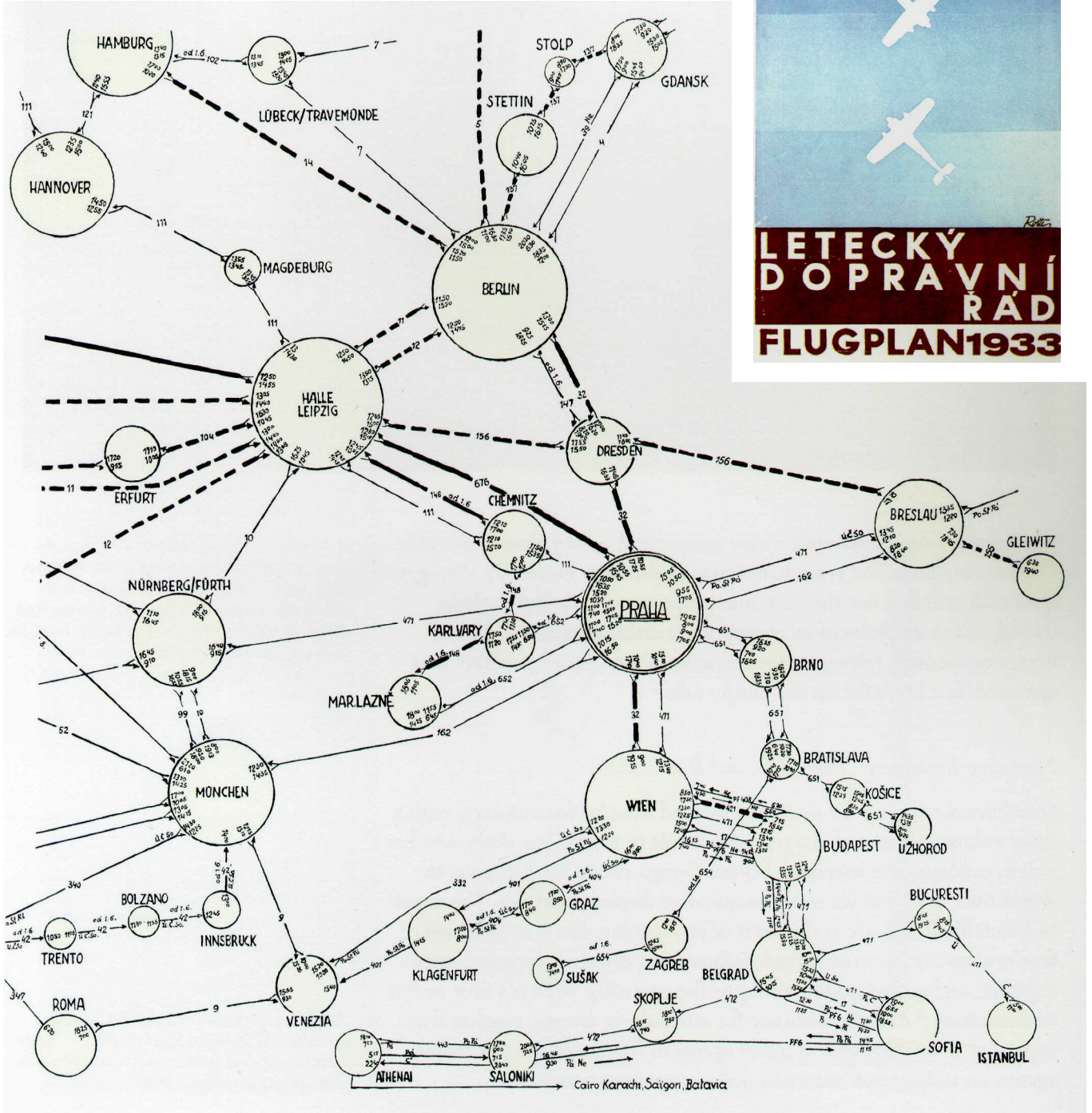
Our story concludes with a new perspective, a very close look at the Galilean satellites. The remarkable 1979 flights near Jupiter by Voyager spacecraft revealed not the luminous pinpoints of reflected sunlight tracing out swift cycles of an elegant and reliable geometry—ashad been seen through telescopes for centuries—but, instead, satellites that appeared, frankly, a bit on the lumpy side.³

Narrative Itineraries: Timetables and Route Maps

Schedules are among the most widely used information displays, with a sheer volume of printed images comparable to road maps, daily weather charts, catalogs, and telephone books. Design efforts for 150 years the world over have yielded some imaginative display strategies. The issues of timetable design are at the heart of envisioning data—large arrays of fussily annotated numbers, thick information densities, type and image together, and multivariate techniques for narrating what is a four or five variable story.⁴ And the audience for schedules is diverse, ranging from experts at timetables such as travel agents to those who are not travel agents, an audience of uncertain skills, eyepower, patience.

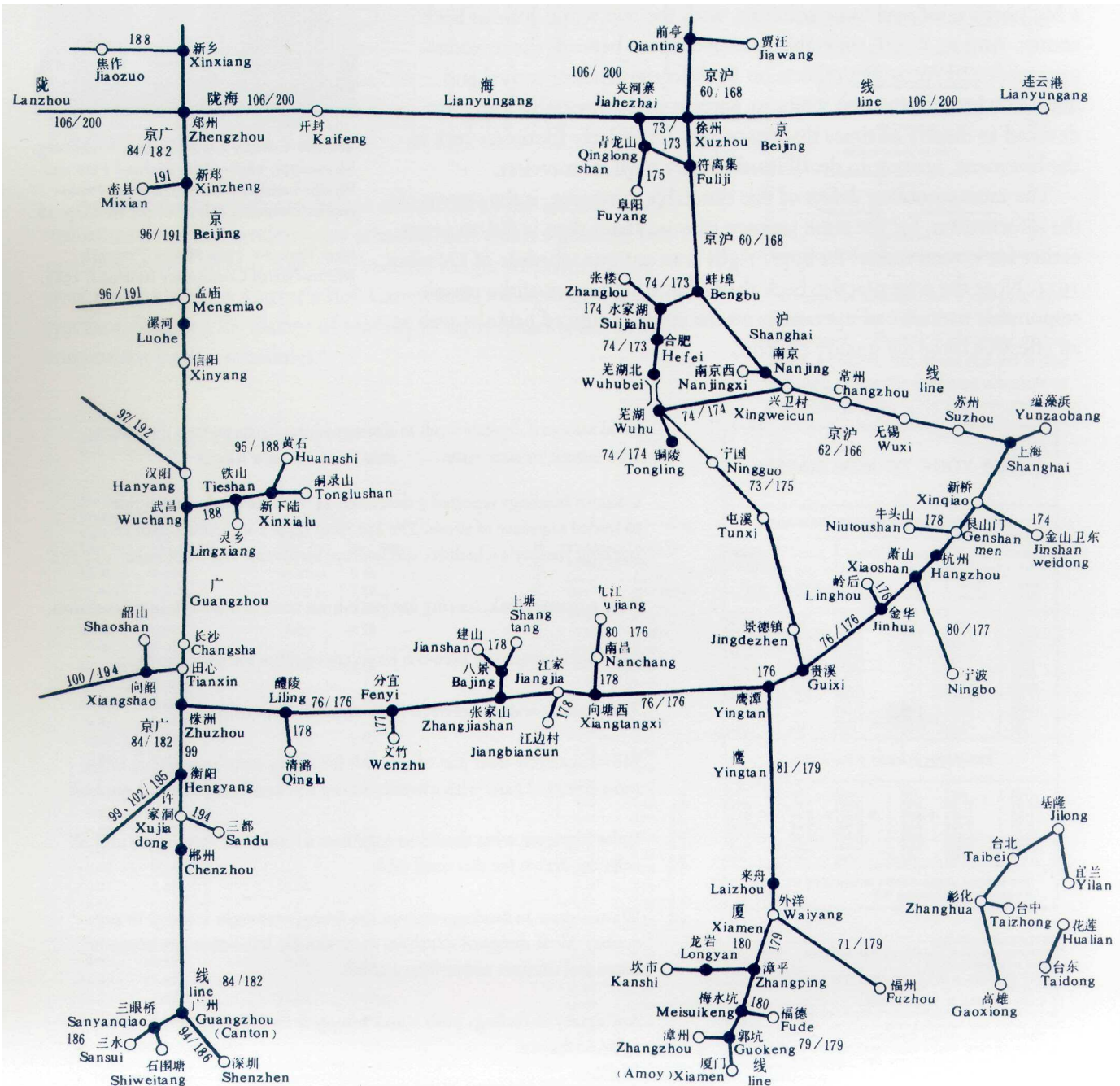

A comprehensive narrative description of a transport system requires a record of both time and spatial experiences. Here a complex network of routes is brought together with flight times and identification numbers in a brilliant map/schedule for the Czechoslovakia Air Transport Company in 1933. A playful and polished cover makes the brochure an exceptional union of graphic and information design.

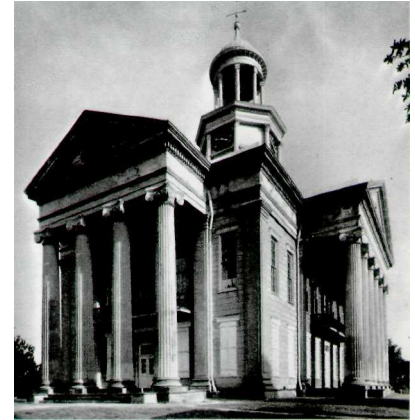


A similar multifunctioning pattern presides over this diagram, a fine combination of flatland and data table. Route map and index, an unusual pairing, are merged in this 200-page timetable for the railroads of China. Although the linework and typography are faltering, the overall layout has a directness and clarity of organization — maintaining the full spatial relationships of towns, patterns usually reduced to a witless alphabetical ordering in a conventional typographical index.

SOME tables are better than others; an example reveals the difference design makes. Millions of copies of this standard typographical table (shown below) have been distributed by the railroad for years. Space is poorly allocated; much of the paper is given over to categories at top that labor incessantly to make only three binary distinctions (between New York/New Haven, leaving/arriving, and weekdays/weekends). All the little boxes create an elaborate but false appearance of systematic order. It resembles the county court house in Vicksburg, Mississippi — a big portico, inflated Ionic columns, with the real work done in back rooms. And so, in this timetable, left-over space beneath the introductory grids and rectangles reports on 80 different times of arrival and departure (410 characters). Only 21 percent of the timetable's area is devoted to display of times that trains run. Disorderly footnotes lurk in the basement, waiting to derail insufficiently vigilant travelers.

The most troubling defect of this timetable, however, is the *content* of the information, for the same journey runs no faster than it did 70 years earlier for several trains! At upper right is an antique schedule of October, 1913. Note the wise practice back then of putting names of the people responsible for railroad operations on the cover, a sign of pride as well as an effective force for quality control.

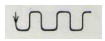

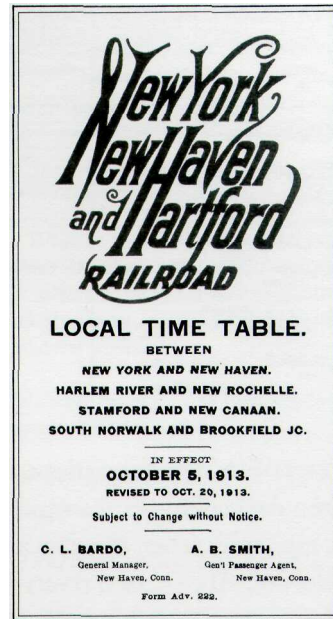

At any rate, the redesign below eliminates all the assorted convolutions from the modern-day schedule and yields a graceful but unceremonious layout. The numbers, no longer serpentine, are now set in Matthew Carter's Bell Centennial, a telephone-book typeface designed for clarity of reading in tight spaces (such as the convenient pocket schedule).⁵



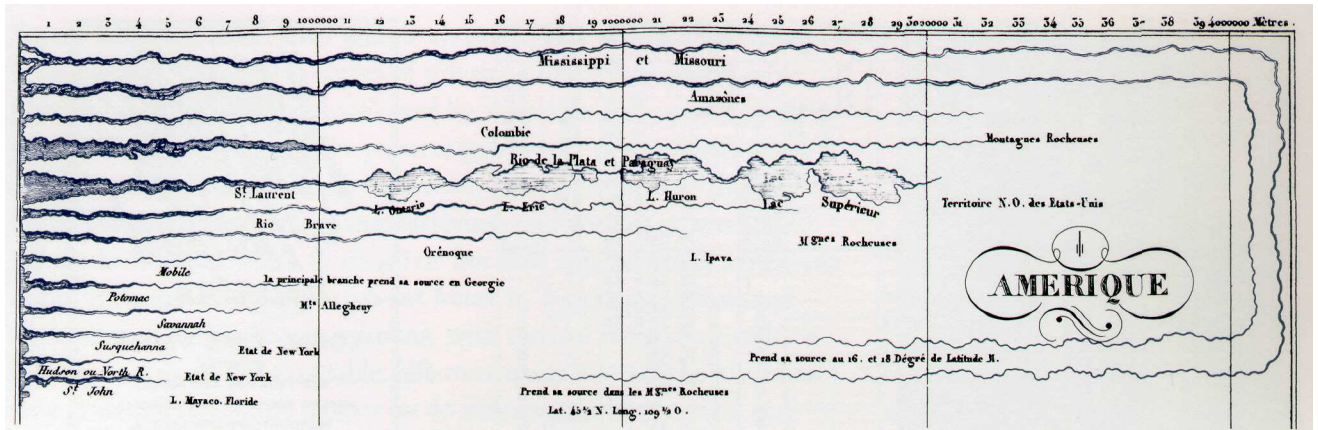

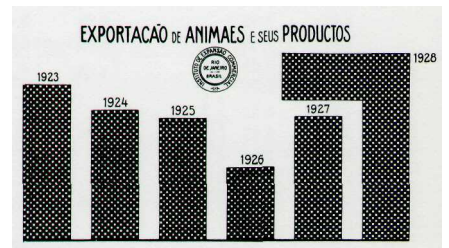
SERPENTINED data formations, like the New Haven timetable, spring up when data collide into a rigid grid. Authentic graphical treasures can result, especially when the data are lognormally distributed as so many variables are. Above, two rivers meander boustrophedonically around a tight frame, weakening comparison of their lengths. And a delight from the 1935 *Graphic Illustration of Tokyo City* (a book too often forgotten), analyzing the water supply system with a very bent bar chart:

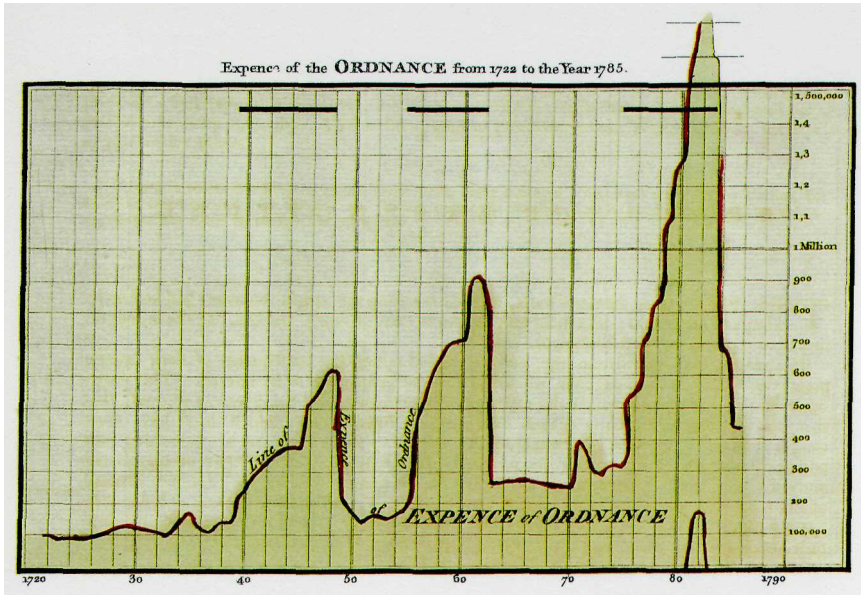

In this time-series, William Playfair ingeniously spilled outlying data over, first by temporarily extending the grid at top (like ledger lines in musical notation) and then by topologically gluing the data surface from top around to bottom (like octave displacement in music). The result is a torus-graphic. Thick horizontals identify periods of war, when British government spending for weapons multiplied. A ratchet effect appears, as post-war expense fails to shrink back to its pre-war level:

This, like the three former Charts, is made out from the yearly Accounts laid before the House of Commons; like those, too, it rises in time of war; and has, like them, not returned to its former low establishment. The people, in every different line, are interested in raising the consequence of their department; and example is contagious, when seconded by inclination or by interest.⁶

Playfair's enfolding resembles the gluing of music repeats as well as the visual-musical round at right, a becoming curiosity. Moreover, the 24-hour graphical timetable can likewise be glued end-to-end onto a cylinder, to show a fully connected cycle and to prevent running off the right side of a schedule at midnight. Simply prolonging the grid a few more hours will also show a complete cycle—as in the airplane schedule below, which itemizes a day's visit to Chicago after flying from Atlanta. Globes may likewise be recycled, avoiding ethnocentrism and showing, somewhere in the picture, every country and ocean together in full.



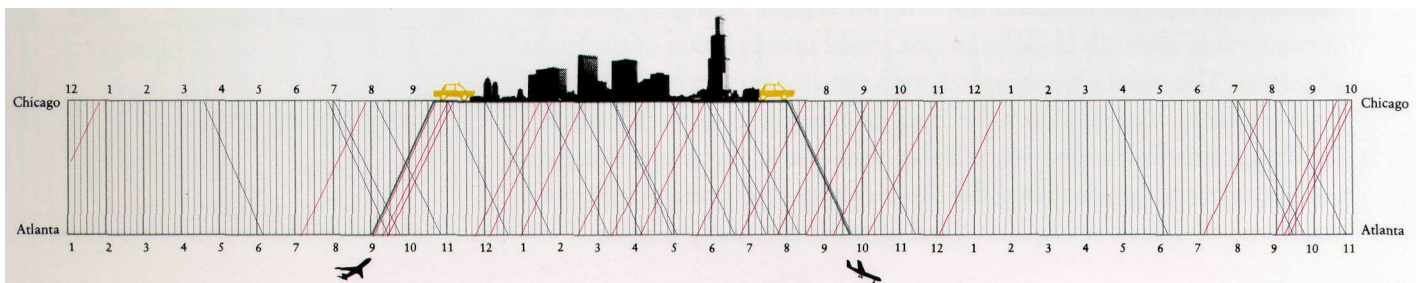
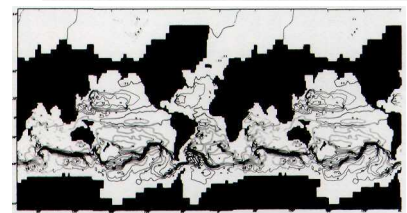
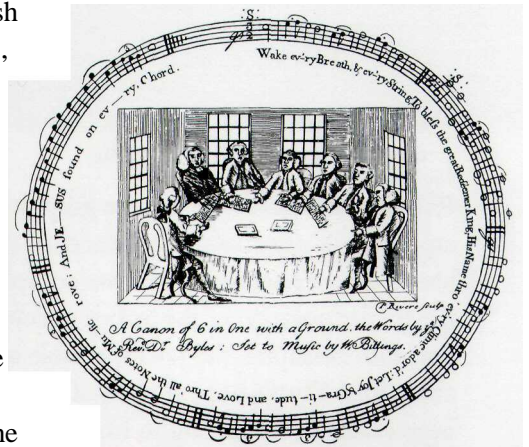

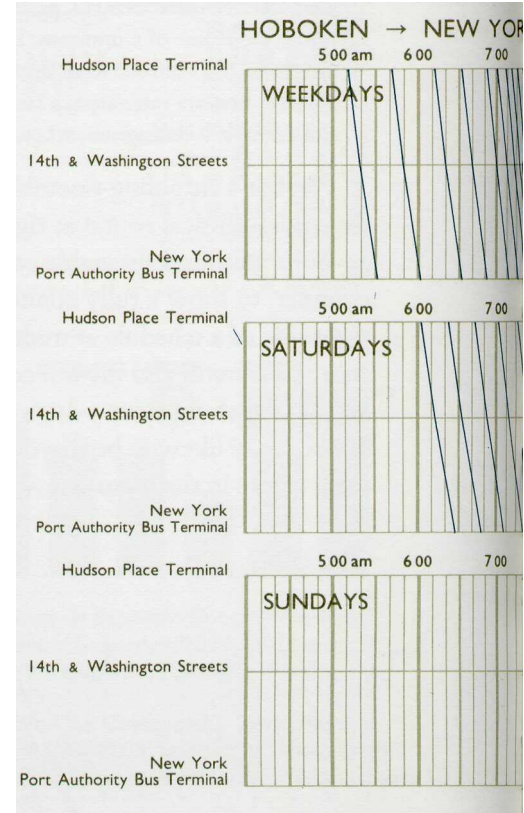
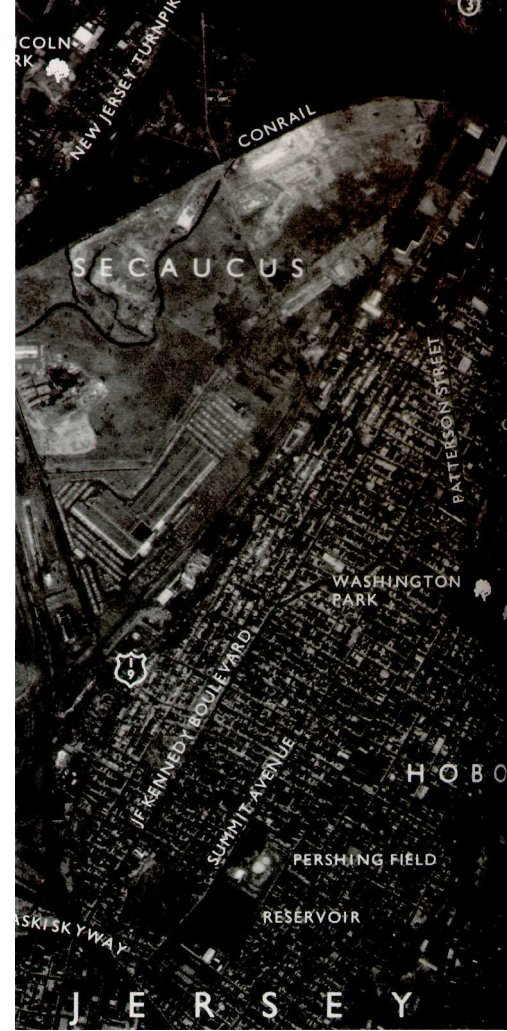


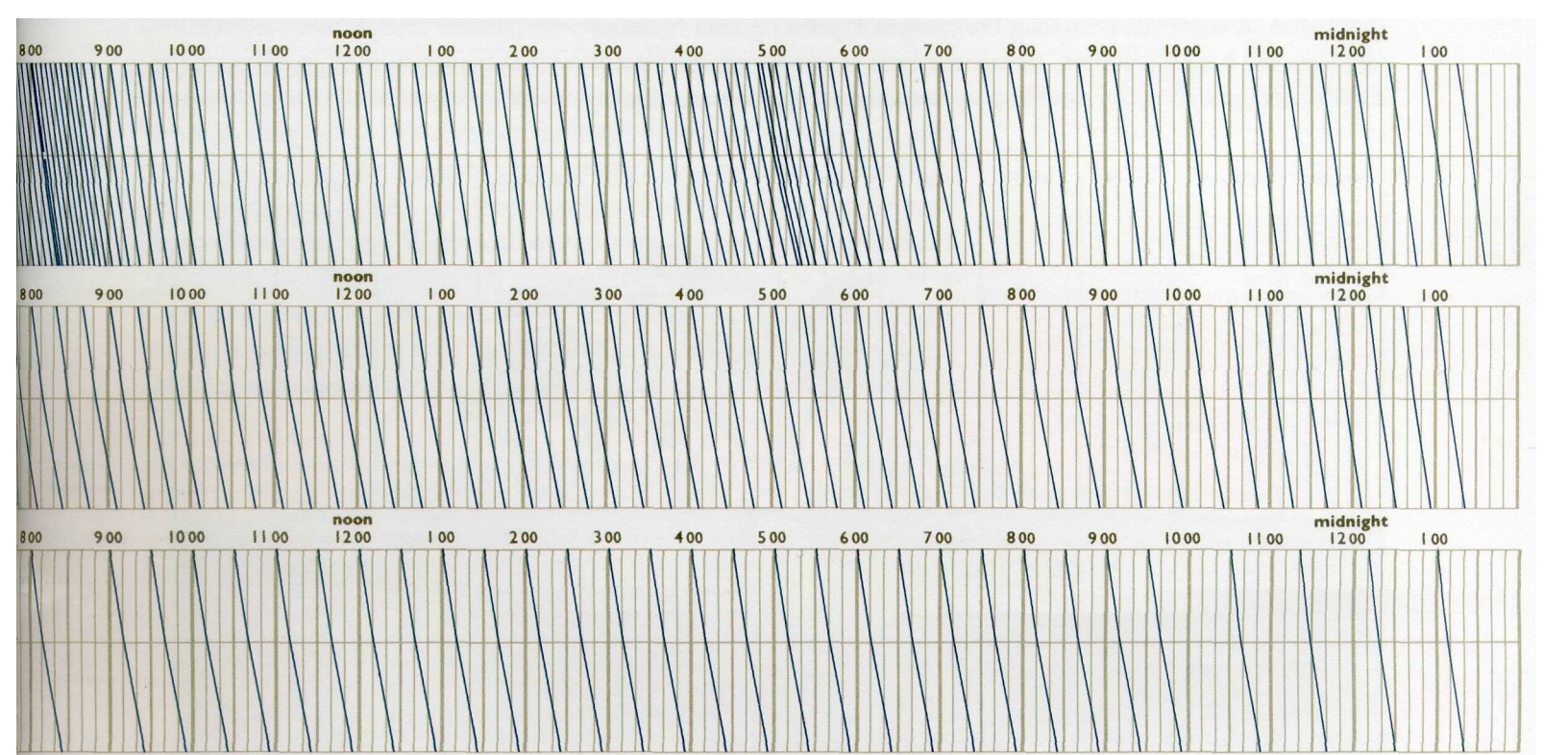
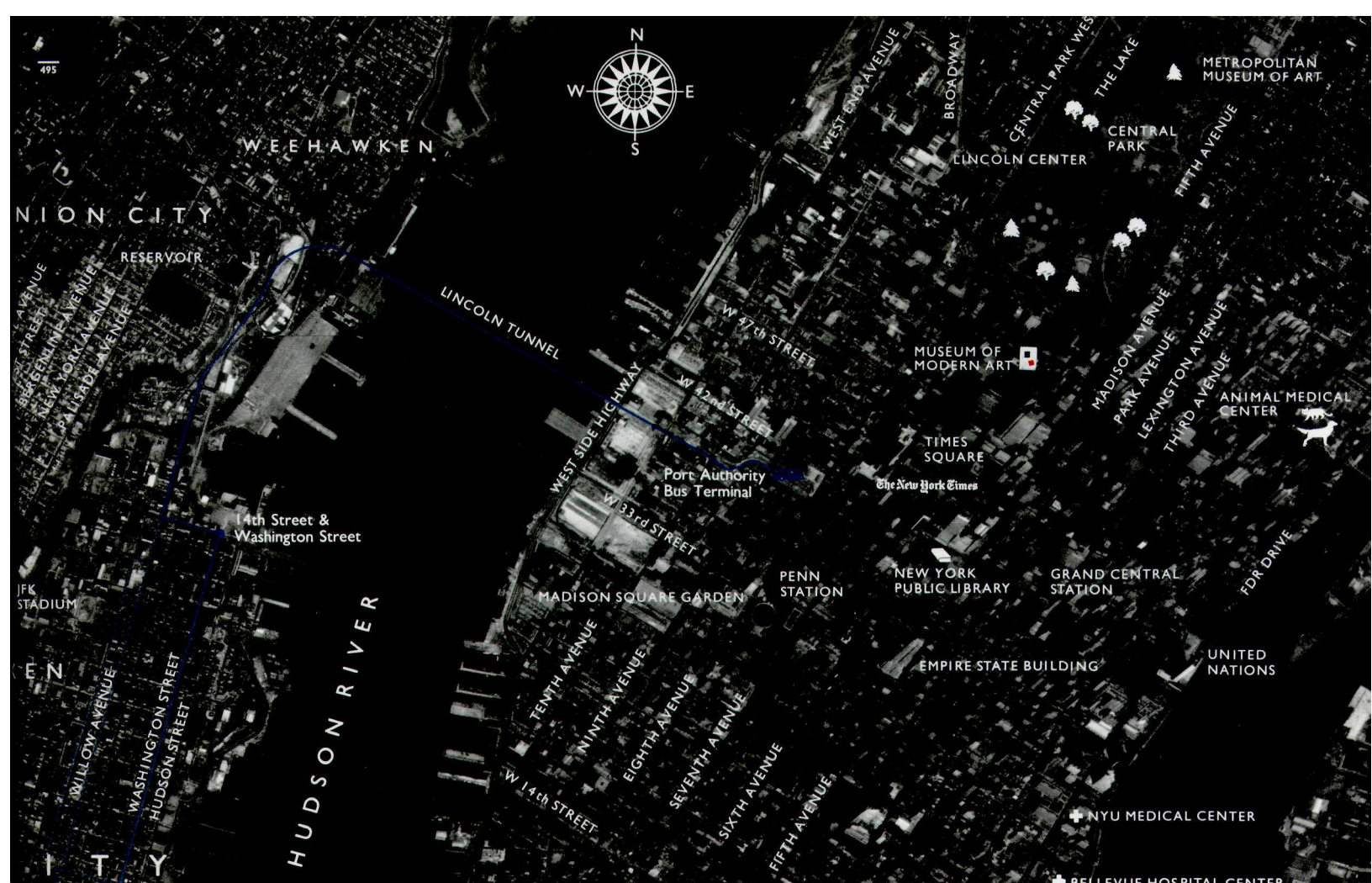
A good alternative to the traditional typographical timetable is the now-familiar graphical schedule. Developed by Charles Ybry, a Paris engineer, the visual timetable provides a detailed reading of times of a particular train along with an overview of the daily structure of times, stations, and routes—separating and combining micro/macro data. Ybry wrote in his 1846 British patent statement:

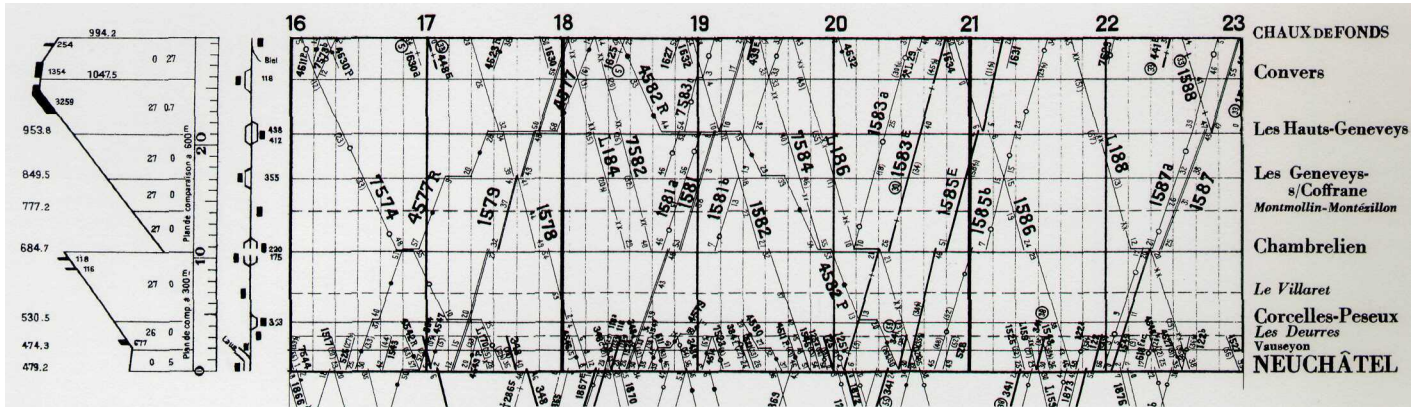
Invention will be such for each line of railway as to indicate the point of departure and arrival of the up and down trains, and also the bridges or any irregularities on the line or tunnels. It will be evident that the engine driver and guards having such time table with them will be enabled to regulate the speeds of the different trains with great exactness, and in cases where special trains are required the diagonal lines of their speed can at once be determined and ruled on the table, so as to enable the engine drivers to avoid all preceding trains which they may have to pass; for by the table the engineers will not only know the speed at which they are to move, but they will ascertain at sight positions where all preceding trains ought to be at any moment of time. From the time table shown, a person will readily construct a time table for any particular line of railway, and the same may be engraved and printed, not only for the use of the persons belonging to the railway, but also for the public.



Railways soon came to use the graphical method for planning schedules, especially in negotiating sequences of several trains running on the same line. Today systems of immense complexity are governed by graphical timetables portraying thousands of station stops. We have already seen two fine examples, the Java spy table and the *Shinkansen* master control chart. But Ybry's hope for use of visual timetables by the public has not been realized. On the right, however, is our design of a bus schedule that combines a graphical timetable with a route map overlaid on a precisely detailed aerial photograph, so much richer than the typical schematic diagram of bus routes. Hourly, daily, and weekly rhythms of the buses are clearly revealed, as well as details of each journey. During rush hours, lines densely crowd into spaghetti—but then service is so frequent that the jumble of lines informs the rider simply to show up, for there will be virtually no wait for whatever bus it is that arrives. The gray grid is set at ten-minute intervals in order to ease visual interpolation of the times of arrival. The aerial photograph unveils the area mostly at the level of *house resolution*, that is, with sufficiently fine details to show individual buildings. Indeed, the reaction of those who live in the area is to explore the photograph, personalizing the data, seeking to discover their own residence, school, or workplace. Same picture, but many stories.







In contrast to the data-rich bus schedule, a Swiss Federal Railroad chart chronicles just a few local trains proceeding daily from Chaux de Fonds in 1932. Note the distinctive pattern here — rhythmic diagonals cross only at stations, indicating that a single track serves the line and, consequently, trains are able to pass one another only at sidings within stations. Visual timetables help plan such passings; it would be clumsy and awkward to design such a pattern nonvisually.

The space-time grid has a natural universality, with nearly boundless subtleties and extensions.⁷ Organized like the graphical timetable, this unusual arrangement below simultaneously describes two dimensions, space *and* time, on the horizontal while maintaining a vertical spatial dimension. A complete year-long life cycle of *Popillia japonica Newman* (the Japanese beetle) is shown, transparently, in a smooth escape from flatland brought about by doubling up variables along the horizontal.

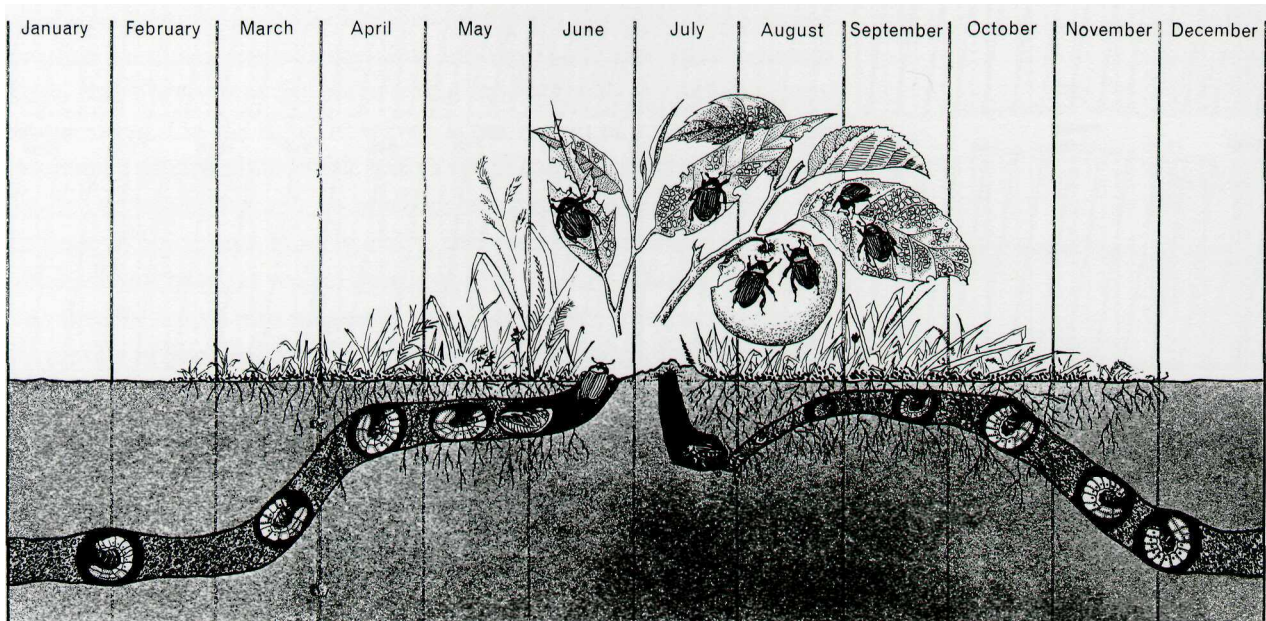

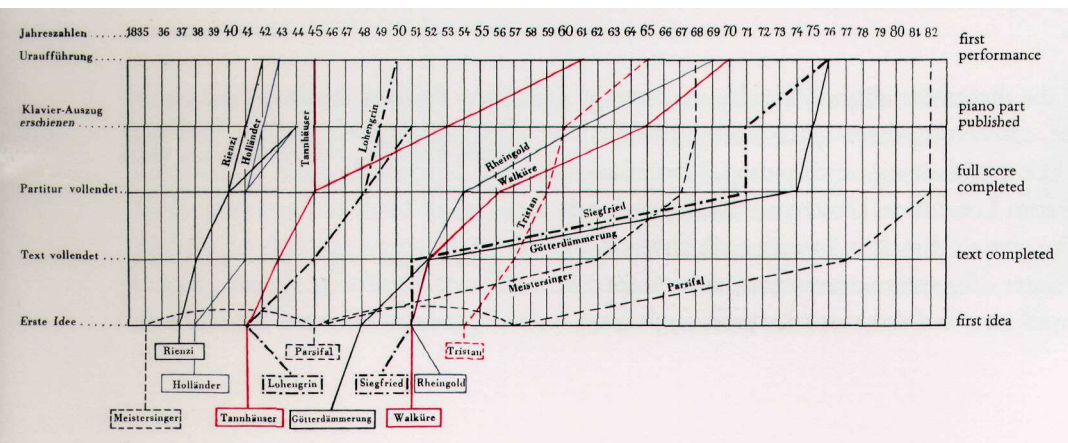
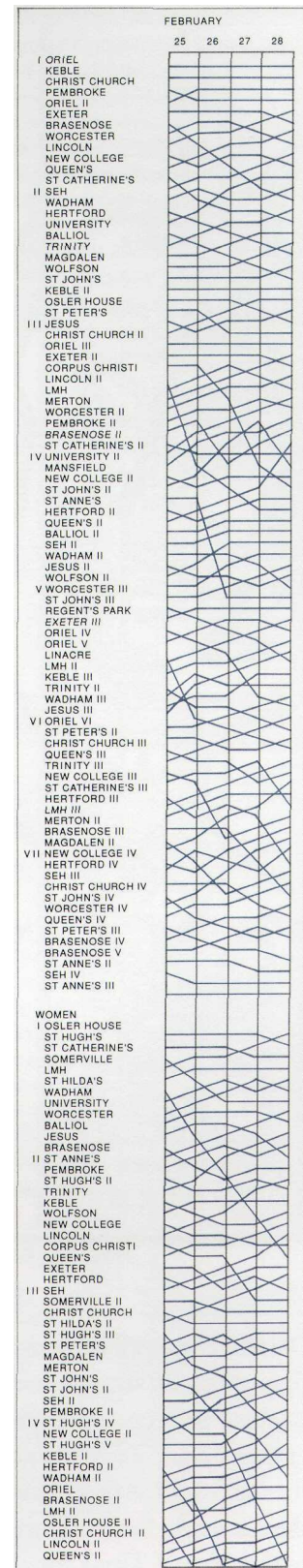


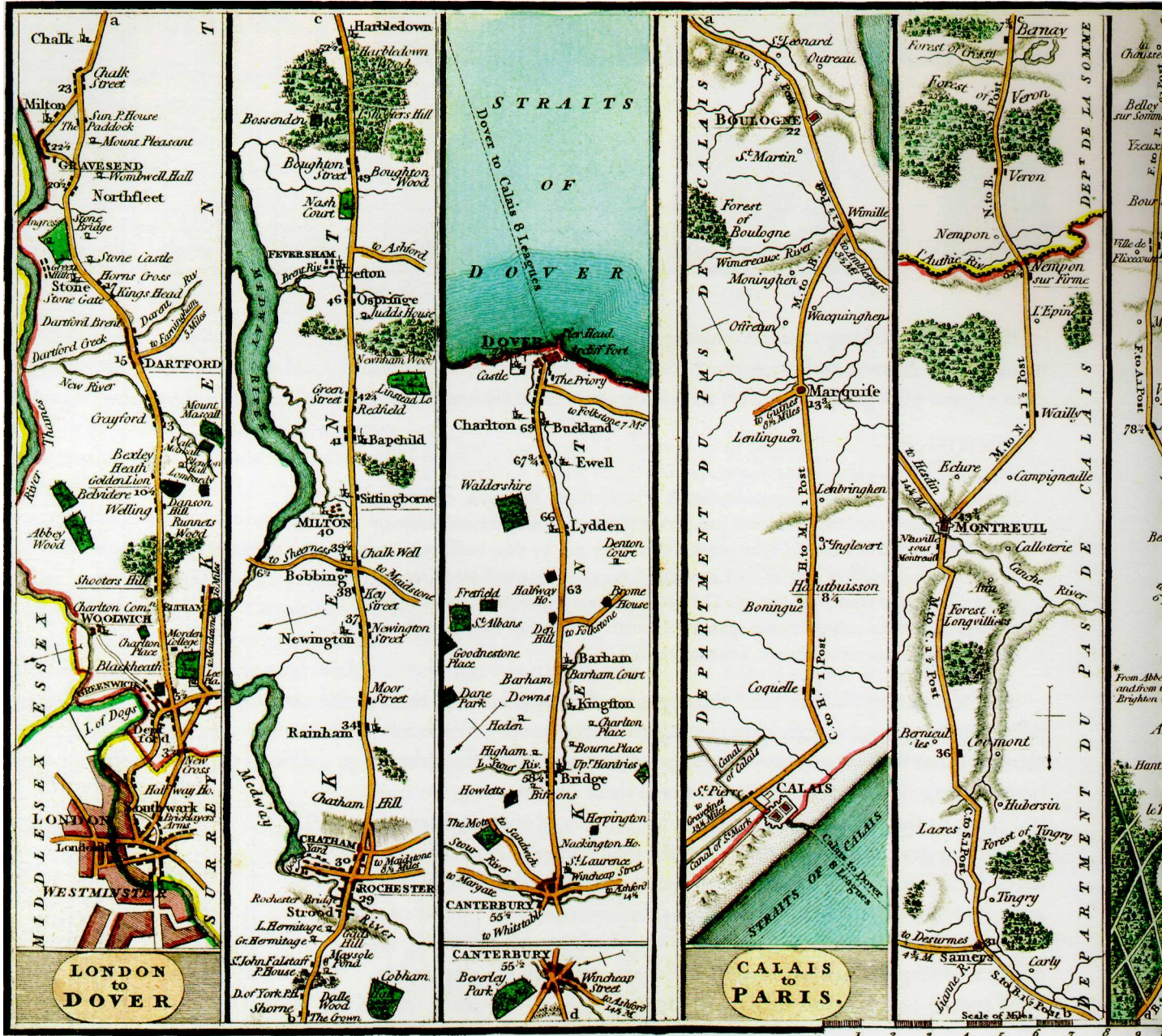


And here is the long-awaited esophageal timetable, narrating movement of food from mouth to stomach. Sequenced images are condensed onto a space-time grid, along with a measure of radioactive intensity:

Eight of the consecutive 0.2 second 64 by 64 standard image frames (top) show radioactive liquid descending to the stomach. The transit process involves only one dimension of the esophagus; lateral motion is of no concern. Therefore, each image frame was compressed into a column one pixel wide by summing the counts along horizontal rows. The columns were assembled in order side by side, including the eight above but totalling sixty in the entire study, to create the condensed dynamic image of an entire swallow (bottom). The horizontal axis encompasses 12 seconds of time, the vertical axis the spatial span from mouth to stomach. The bolus shows uncomplicated downward transit, a normal result.⁸

Also recounting place in time, the engaging "bumps chart" at right tallies results of English collegiate rowing contests. Bumps races come about because the narrowness of rivers precludes more than two crews from rowing side-by-side; in fact on bends there may be room for only one boat. At the beginning of a race, crews are spaced apart at intervals, the starting gun is fired, and they row like mad trying to catch the boat immediately in front. When a boat overtakes another, the crew in front pulls over and the one formerly behind goes on by, now in pursuit of the boat next ahead. In times past, the boats may have actually bumped, signaling a passing and crossed lines on the chart. And, below, a timetable of Wagner's operas, from writing of text and music to first performance.

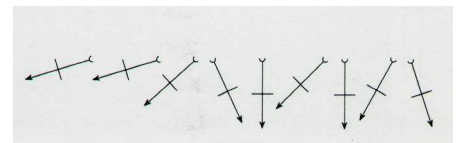


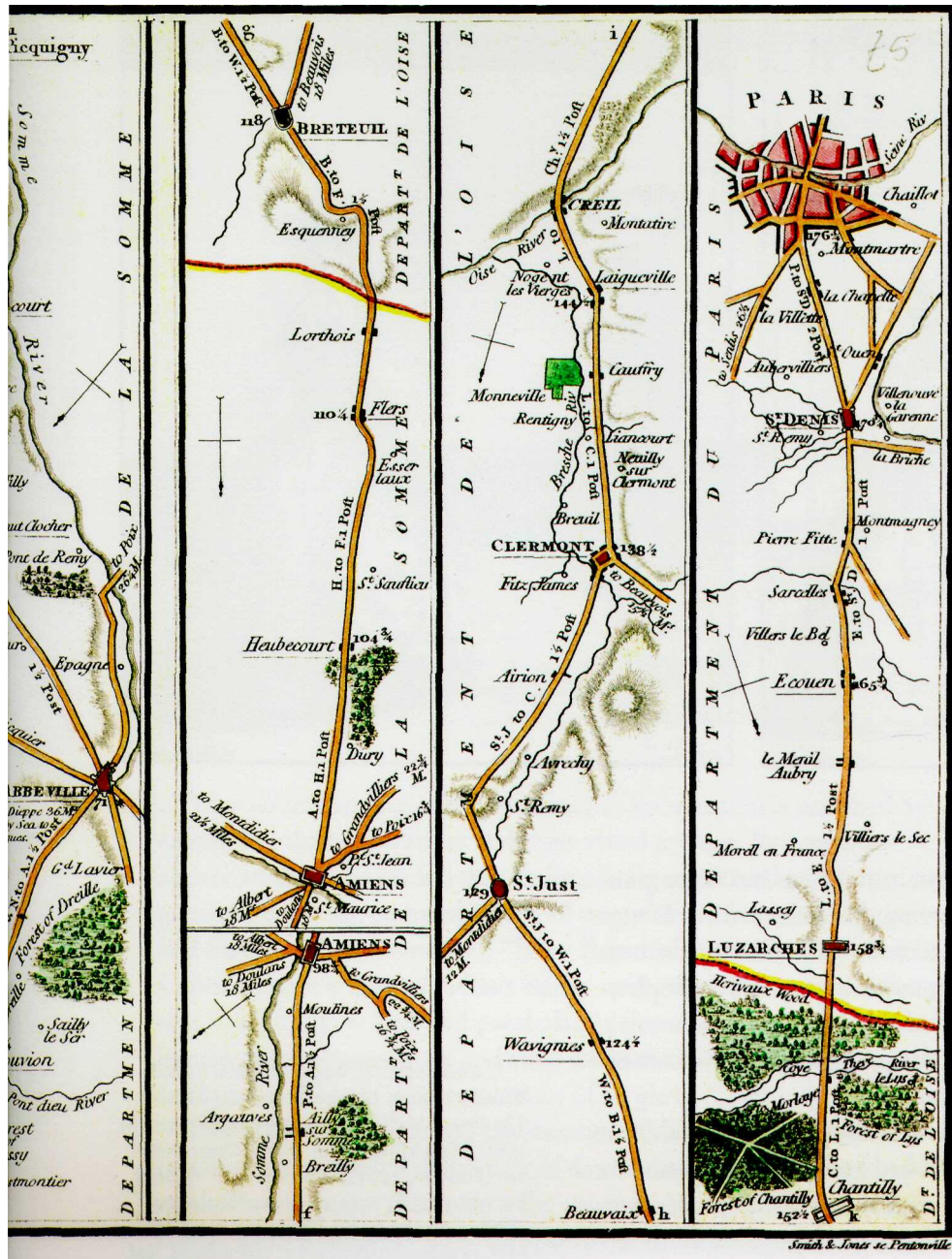

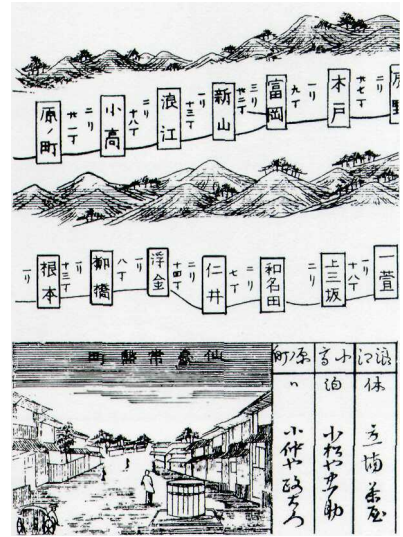
Graphical timetables compress the dimensionality of data by measuring distance along the rail line itself, converting three-space reality into a lineland path on paper, much like the itinerary or strip map. Here is an extraordinary guide, running from London to Dover, across the sea, and thence from Calais to Paris. The route's direction orients each strip, as the normally fixed compass pointer diligently rotates from slice to slice in this *Tale of Two Cities*. Various inns and rest stops are indicated along

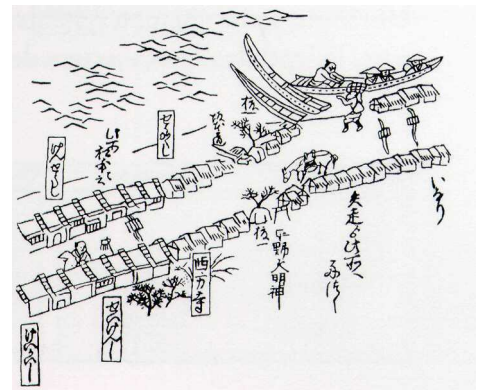

the muddy journey, which was taken by horses and coach in 1801. Note the two-sided accents on the edges of gridded city streets (as we saw in Chapter 4). Such strip maps, something of a wrong-way departure from flatland toward lineland (it depends on what is done with the second dimension that has opened up), do allow viewers to edit and to focus directly on the relevant—compensating somewhat for loss of context. But what if we were to change our minds in midcourse?⁹

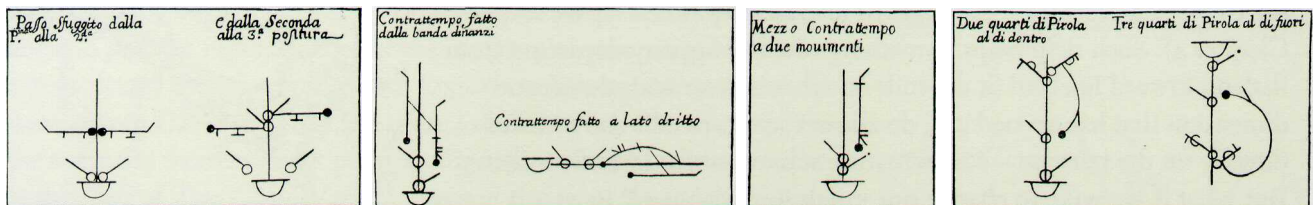


Dance Notation: Commotion and Order

Systems of dance notation translate human movements into signs transcribed onto flatland, permanently preserving the visual instant. Design strategies for recording dance movements encompass many of the usual (nearly universal, nearly invisible) display techniques: small multiples, close text-figure integration, parallel sequences, details and panorama, a polyphony of layering and separation, data compression into content-focused dimensions, and avoidance of redundancy.

Now and again, the paper encoding reflects the refinement of dance itself—a flowing and graceful line embellished by disciplined gesture, a dynamic symmetry inherent to both individual and group proceedings. Moreover, some notation systems engender a visual elegance all their own, independently of motions described.¹⁰

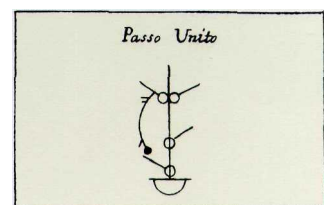
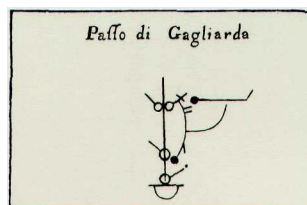
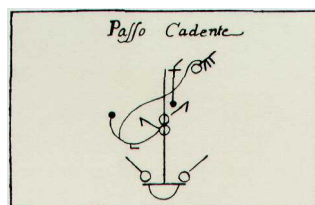
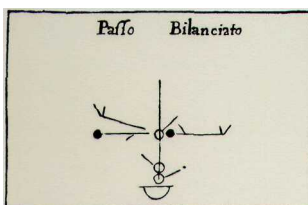
Our understanding of the aesthetics of information is enriched by examining dance narratives and their visual texture. We come to appreciate how the underlying designs bring about and enable the joy growing from the comprehension of complexity, from finding pattern and form amidst commotion. "How beautiful it was then," writes Italo Calvino about a time of radiant clarity in cosmic prehistory, "through that void, to draw lines and parabolas, pick out the precise point, the intersection between space and time when the event would spring forth, undeniable in the prominence of its glow . . ." ¹¹

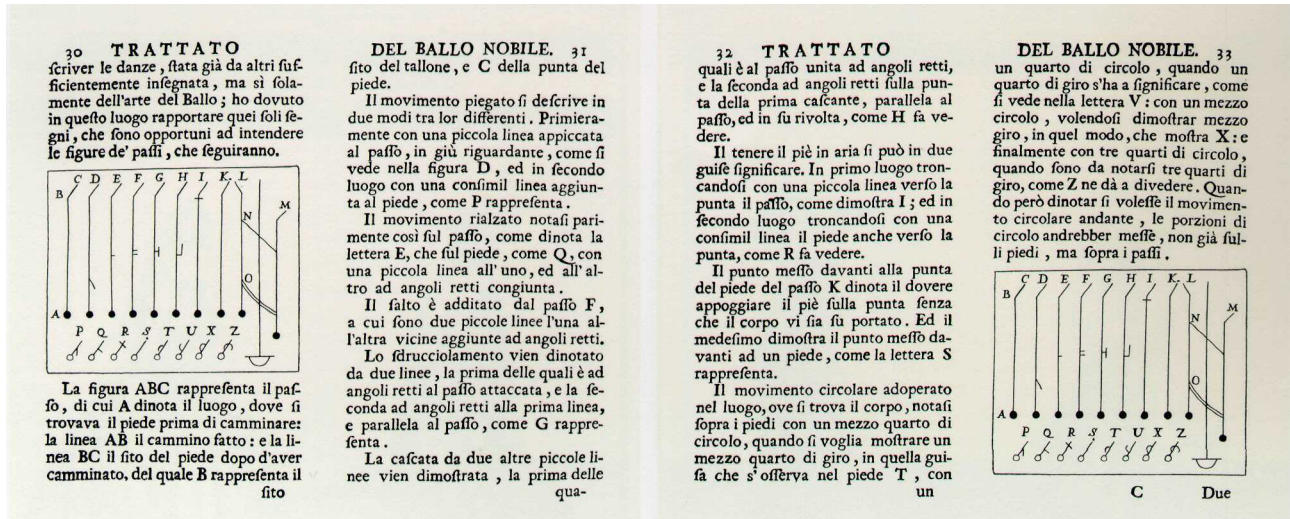
Inevitably the texts begin taxonomically, laying out fundamental movements in a visual dictionary of dance elements. For most notation methods, the design of choice is the small multiple — since the analytical task at hand is unswervingly comparative. Variations, sequences, and combinations naturally follow.

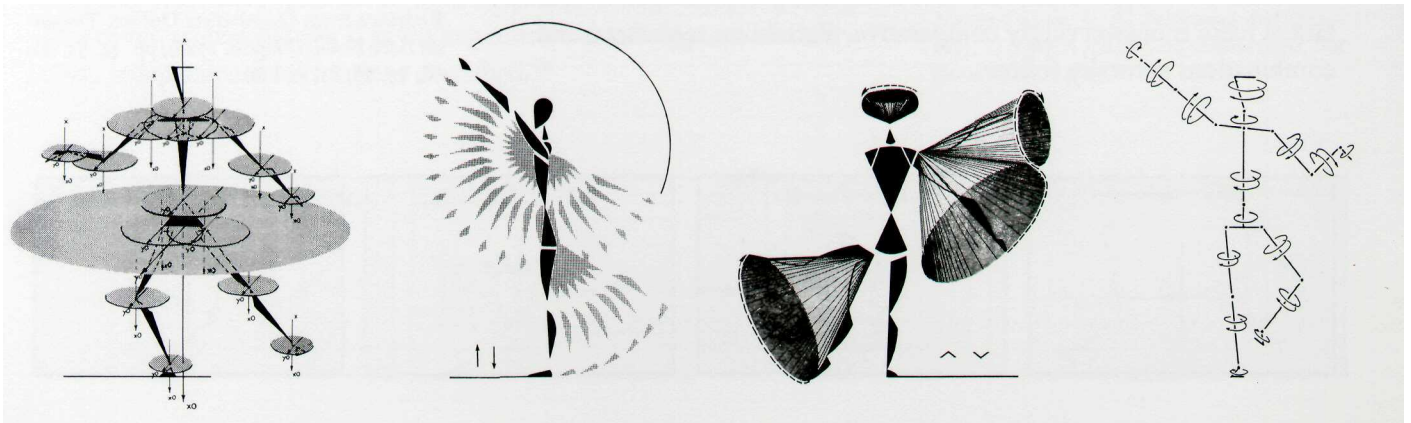
On each double-page spread here, identical small-multiple diagrams are repeated, facilitating comparisons among dance steps. Descartes did the same thing in his *Principia*, repeating one particular diagram 11 times. Such a layout makes it unnecessary to flip from page to page in order to coordinate text with graphic. Words and pictures belong together, genuinely together.¹² Separating text and graphic, even on the same page, usually requires encoding to link the separate elements. Within each spread above, for example, attentive readers must repeatedly jump back and forth between text and graphic, which are connected up by 22 letters. Alphabetical labels bestow a sequence on the illustrations, but otherwise are just arbitrary codes, unrelated to the dance movements depicted.

Multiplied consecutive images, below, eerily trace out motion, in these original diagrams from an earnestly scientific system of movement notation. The proliferating cones and plates perhaps help to envision the range of three-space action, although the substance might be forgotten amid witticisms provoked by the eccentric drawings.

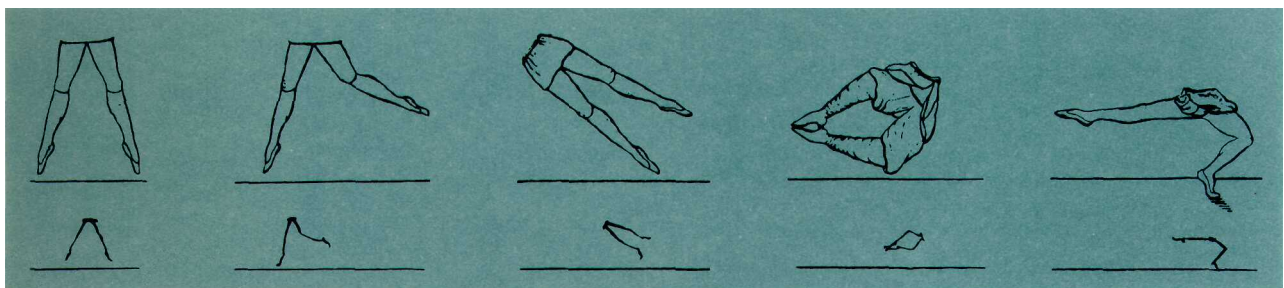

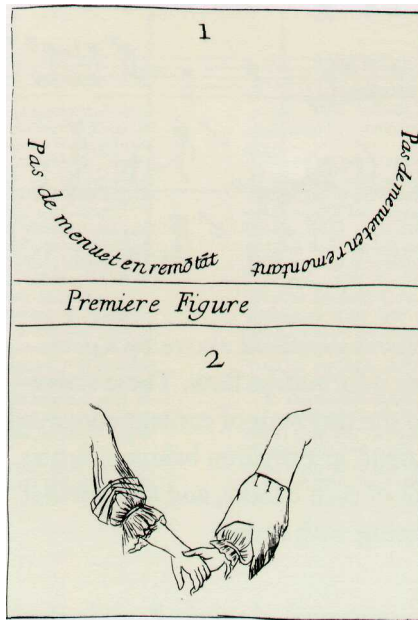
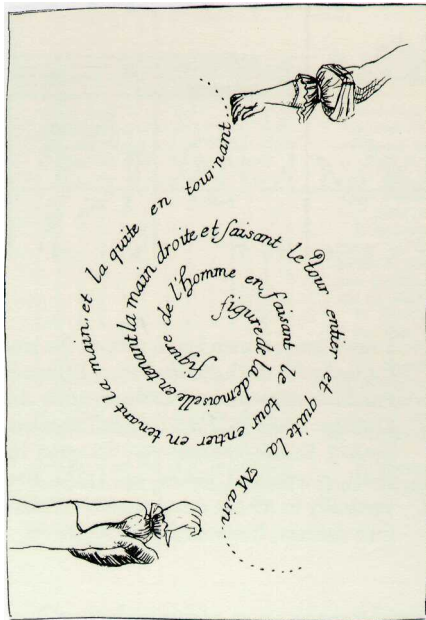

De-gridding the procession above enhances the depiction of continuous

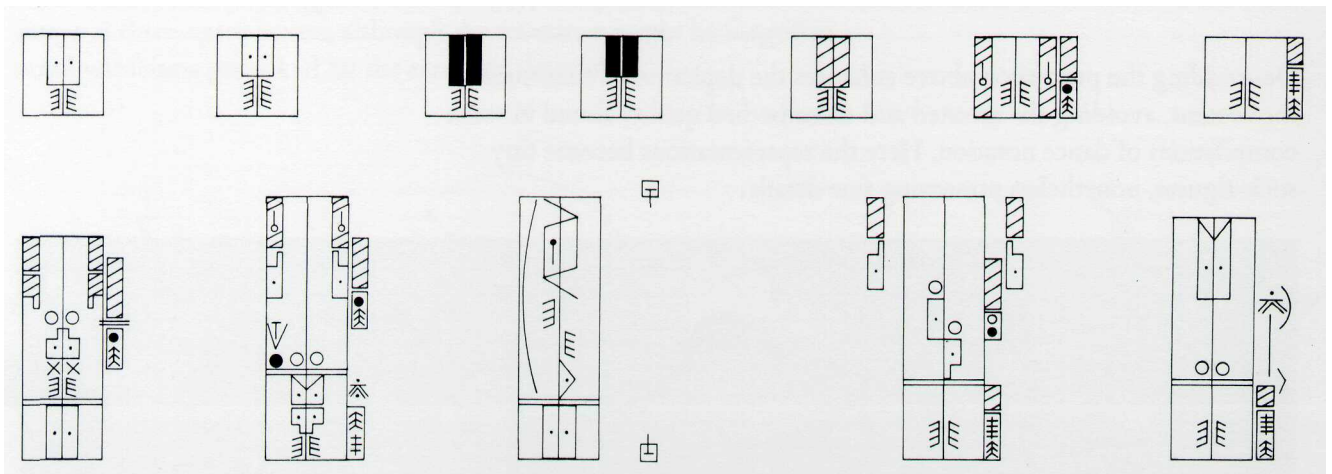


New meaning to the idea of integration of word-and-image is given by these quick-witted drawings from Rameau's 1725 *Dancing Master*. Such innovations, restricted by the exacting horizontality of traditional typographic grids, are now easily—sometimes too easily—accomplished in computerized typesetting and display programs. Rameau furnishes an uncommon demonstration of the *informational*, rather than exclusively ornamental, use of swirling words.

The microscopic and abstracted encodings of contemporary dance notation—sofussy and clumsy and contrary to the wholeness of the substance—provoked the choreographic eye of Lincoln Kirstein of the New York City Ballet:

A desire to avoid oblivion is the natural possession of any artist. It is intensified in the dancer, who is far more under the threat of time than others. The invention of systems to preserve dance-steps have, since the early eighteenth century, shared a startling similarity. All these books contain interesting prefatory remarks on the structure of dancing. The graphs presented vary in fullness from the mere bird's-eye scratch-track of Feuillet, to the more musical and inclusive stenochoreography of Saint-Léon and Stepanov, but all are logically conceived and invitingly rendered, each equipped with provocative diagrams calculated to fascinate the speculative processes of a chess champion. And from a practical point of view, for work in determining the essential nature of old dances with any objective authority, they are all equally worthless. The systems, each of which may hold some slight improvement over its predecessor, are so difficult to decipher, even to initial mastery of their alphabet, that when students approach the problem of putting the letters together, or finally fitting the phrases to music, they feel triumphant if they can decipher even a single short solo *enchaînement*. An analysis of style is not attempted, and the problem of combining solo variations with a *corps de ballet* to provide a chart of an *entire* ballet movement reduces the complexity of the problem to the apoplectic.¹³

This profound and informed frustration reflects the essential dilemma of narrative designs—how to reduce the magnificent four-dimensional reality of time and three-space into little marks on paper flatlands. Perhaps one day high-resolution computer visualizations, which combine slightly abstracted representations along with a dynamic and animated flatland, will lighten the laborious complexity of encodings—and yet still capture some worthwhile part of the subtlety of the human itinerary.
